Responses to this sources sought will be used by the Government to make appropriate acquisition decisions. Responses to this sources sought synopsis are not considered adequate responses for a solicitation announcement.

The Department of Veterans Affairs (VA), VISN 22 Network Contracting Office, is seeking sources that can provide a ***Robotic Prescription Dispensing System*** that at a minimum meets the following salient characteristics with a brand name or equal product for the VA Loma Linda Healthcare System:

- 1) Prescription Filling Robot and workstations must work with ScriptPro's SP Central software**
- 2) Prescription Filling Robot and workstations must work with the VA OPAI Class 1 Interface**
- 3) Prescription dispensing robot must support the ability to bulk load prescription vials**
- 4) Prescription dispensing robot medication dispensing cells must be configurable on-site to be able to dispense different sizes and shapes of oral solid medications**
- 5) Prescription Filling Robot and workstations shall use barcode verification during the prescription filling process**
