1. Organization/Line Office:

Network contracting office VISN 22/VA Long Beach Healthcare System (VALBHS)

2. Description of Action being approved:

This solicitation is requesting a firm fixed price purchase for Zeiss Eye Care Data Management System for the VALBHS via the open market.

3. Description of Product, Supplies or Services:

The VA Long Beach Eye Clinic has a requirement to acquire Zeiss Eye Care Data Management System. It interfaces with existing ophthalmology and optometry Zeiss equipment to capture information for viewing and archiving through Picture Archiving and communication system (PACS).

The VALBHS currently has Zeiss equipment in multiple areas of the hospital. The archival and viewer system serves to connect those systems to the VA PACS infrastructure. The required system must be compatible with the existing Zeiss equipment or it will not function to connect to the existing systems. No other brand name has a system that is compatible with the Zeiss system VALBHS currently has. This Zeiss system is the only one that works with our VISTA imaging system to intergrade all different imaging modalities that VALBHS has in the eye clinic.


C. URGENT AND COMPELLING


