All Amendments to the solicitation must be acknowledged with the bid. All questions should be submitted by close of business on Friday, February 17, 2012.

There is a base bid item #1 and five bid deduct items, which are numbered items #2 thru #6. The base bid price includes everything in the statement of work and if that price is within our budget, an award will be made based on that amount. However, if the price is over the base bid budget, one of the bid deduct items will be chosen. The TOTAL AMOUNT for each bid deduct item is the figure that goes in the spaces provided on the second page of the SF 1442.

The solicitation was issued as an IFB, meaning there will be a public bid opening; there will be no discussions held; only price will be considered; and award will be made to the responsive/responsible low bidder. The solicitation is also a 100% SDVOSB set-aside. All firms must be registered in CCR; DUN/BRADSTREET; ORCA; and VETBIZ in order to be considered for an award.
