Questions and Answers

1. Are the Install Lead and Installers required to have an OSHA 10 card or OSHA 30 card?

2. What's the conduit distance (linear feet) between equipment closet 3E145 and the rooms being serviced from this closet?

We are unable to determine exact distances, but there is an approximate distance for the OR that is furthest away. The furthest OR (3D172) from the room is approximately 132 linear feet from the closet 3E145.

3. What's the conduit distance (linear feet) between equipment closet 3F128B and the rooms being serviced from this closet?

The closet is actually 3F182B. We are unable to determine exact distances, but there are approximate distances in linear feet (distances through the hallways):

- a. 3F182B to hybrid room: 203.5'
- b. 3F182B to Cath Labs: 176', 148.5'
- c. 3F182B to IR procedures: 38.5', 71.5'
- d. 3F182B to EP Room: 38.5'
- e. 3F182B to GI rooms: 170.5', 192.5', 214.5', 154'
- f. 3F182B to Branch: 225.5'
- g. 3F182B to ERCP: 132'

4. Can we view the Electrical drawings (power, low voltage and data), Mechanical drawings and boom drawings?

5. Can we view the boom drawings that show the number of low voltage plate locations?

6. In the General ORs, are the display boom arms single or dual arms? Can the arm hold 1 monitor or 2?

Dual arms. The arm can hold one monitor.

7. Can you confirm that the 6 other conference rooms are the same size as conference room 3D170? Where are the other conference rooms located (linear feet) in relation to 3D170 (the only conference room we were able to view)?

The other conference rooms (besides 3D170) are still to be determined. They will be in Inpatient, Outpatient, and Diagnostic and Treatment. The approximate distance between 3E145 and the Inpatient building is 440 linear feet. The

approximate distance between 3F182B and the Outpatient building is 475 linear feet. The furthest possible conference room in D&T is approximately 280 linear feet from the closest closet (3F182B). Entire site plan can be seen in attachment (ATTACHMENT 1 – SITE PLAN).

8. What is the distance from the video integration rack room to each of the 8 general ORs?

We are unable to determine exact distances, but there is an approximate distance for the OR that is furthest away. The furthest OR (3D172) from the room is approximately 132 linear feet from the closet 3E145

9. What is the distance from the video integration rack room for each of the non-OR rooms, ERCP (1), Bronch (1), GI (6)?
