- Offeror shall present documentation to substantiate that their firm, or a proposed subcontractor, has performed at least one (1) project similar in size and scope to this project, within the past 5 years. **A similar project is one involving, demolition, renovation and general construction in a hospital or institutional building setting.** The project information should include:
 - Project name and number
 - Customer and location where work was performed
 - Customer name and contact information, telephone and email
 - Total project value
 - Note : Information provided MUST be verifiable by the contact information provided It is the offeror's responsibility to ensure the Government will be able to contact the POCs using the contact information provided
