B.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes . Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. Furthermore, if VA determines any services the support contractor(s) will perform in assessing compliance are advisory and assistance services as defined in FAR 2.101, Definitions, the support contractor(s) must also enter into an agreement with the contractor to protect proprietary information as required by FAR 9.505-4, obtaining access to proprietary information, paragraph (b). - PACS System must be listed in the VistA Approved DICOM Modality Interfaces, 15 June 2014, or later page 17. A DICOM modality is considered “Supported” if it passes the VA’s internet validation test suite listed in the Joint VA/DoD DICOM Modality Conformance Requirements (Rev 3.0) document (see <http://www.va.gov/imaging>).
- PACS System must be FDA 510k approved and listed as a Medical Device.
- PACS System must be in eMass with official contact within the Dept. of Defense to verify. Must be able to reference site and Military Personnel.
- PACS System must be compatible and seamlessly fully integrate with the PACS system at Walter Reed National Medical Center. Must be able to provide contact name for verification.
- PACS System must provide “Post Processing Analysis, Dynamic Review/Manipulation of RAW data” functionality for ZEISS Cirrus HD-OCT. If Glaucoma Workplace is procured you can do with the ZEISS HFA Instruments as well.
- PACS system must be able to store and access raw instrument data from ZEISS Field Analyzer, ZEISS Cirrus HD-OCT, ZEISS Visucam Fundus Camera and ZEISS FF450/Visupac Fundus Camera systems.
- PACS System must have functionality to enable real-time and dynamic editing/manipulation of all prior Visual Field Test data for all Glaucoma patients and allow for Baseline changes, real-time report generation for any VFI date, display RealEye images and data from the new ZEISS HFA 3 instruments.
- PACS System must support DICOM standards and Work-List functionality in order to create and send patient demographics to a specific or all instrument’s via a DICOM work-list within the eye clinic’s network.
- PACS system must be able to integrate with the VA VistA system and accept New/Updated Consults/Orders created from CPRS/VistA that contains Patient demographic data, and send these as a DICOM Modality Work-lists to a single/multi DICOM compliant instruments within the eye-clinics network.
- Combined Report: HFA-Cirrus reports for Structure Function analyses in Single Display with OD-OS on 1 page. If Combined Report is procured as option of FORUM
- PACS system must be able to integrate with the VA VistA system and Store-forward diagnostic test results back to the VA VistA system for access via the VA VistA imaging system.
- PACS system must have Bi-directional DICOM capabilities to send both DICOM Modality Work-lists containing Consult/Order details to instrument’s within the eye-clinics network and receive back the diagnostic test results and RAW data for storage within the PACS system for access.
- PACS system must connect to any brand of non-DICOM diagnostic instrument with export capabilities, and convert the diagnostic test results into a DICOM compatible file containing all patient demographical information, UID’s, Accession number, Device name and type, laterality and other key pieces of data with the least amount of user interaction. This must be then stored within the PACS system and also forwarded to the VA VistA system for viewing within the VA VistA imaging system.

- The PACS system must not require the use of an external PC or import computer for a DICOM compatible modality.
- PACS System must be able to access all ZEISS instrument data that would be on the VA's or Govt Military server. (Instruments would include ZEISS HFA, ZEISS Cirrus, ZEISS Fundus Camera.)
- PACS system must be able to download all past RAW data from one or more ZEISS Field Analyzers, ZEISS Cirrus HD-OCT's, ZEISS Visucam Fundus Camera and ZEISS FF450/Visupac Fundus Cameras acquired within the main clinic and all satellite clinics upon installation of the PACS system.
- PACS system must provide access through its viewer to all past visual field test reports in color from one or more ZEISS Field Analyzers located in the main clinic and all satellite clinics at the time of installation
- PACS system must be able to display ZEISS Field Analyzer Glaucoma Progression Analysis (GPA) and enable the clinician to manipulate data and store baseline changes at the workstation within the PACS System if Glaucoma Workplace is procured as a part of FORUM
- PACS system must be able to present VFI Index, Mean Deviation, Pattern Standard Deviation and Global Indices at a glance summary of all past and present tests.
- PACS system must be able to display all Cirrus HD-OCT past and present test data from one or more ZEISS Cirrus instruments located in one or more VA clinics. This data must be accessible to enable viewing and manipulation at the workstation.
- PACS system must be able to display and allow the clinician to scroll through the various ZEISS Cirrus Macula Cube B-scan slices, within in the PACS System viewer.
- The PACS system must be able to import at time of installation all past ZEISS Visucam Fundus Camera and Visupac Fundus Camera photographic images.
- PACS system must be able to automatically label images and reports coming from the instruments to enable the clinician to sort test data by visit date/s, modality type/s, right eye, left eye or both eyes.
- PACS system must be able to display images in pre-formatted clinical display groupings for Glaucoma, Retina and Cataract cases.
- PACS system viewer must be able to display images in a right eye / left eye display format
- PACS system must be able to tag individual test reports/images as Favorites to enable easy access on future patient visits.
- PACS system must be able to allow notes to be entered by clinician and append to diagnostic images/reports at the time of review through the PACS viewer.

SECTION E - SOLICITATION PROVISIONS

Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

“Inverted domestic corporation” means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as

those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

(2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;

(3) Consist of providing goods or services to marginalized populations of Sudan;

(4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;

(5) Consist of providing goods or services that are used only to promote health or education; or

(6) Have been voluntarily suspended.

“Sensitive technology”—

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

“Small business concern” means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

“Small disadvantaged business concern”, consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that—

(1) Is at least 51 percent unconditionally and directly owned (as defined at 13 CFR 124.105) by—

(i) One or more socially disadvantaged (as defined at 13 CFR 124.103) and economically disadvantaged (as defined at 13 CFR 124.104) individuals who are citizens of the United States; and

“Subsidiary” means an entity in which more than 50 percent of the entity is owned—

(1) Directly by a parent corporation; or

(2) Through another subsidiary of a parent corporation.

“Successor” means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

“Veteran-owned small business concern” means a small business concern—

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and
