- Upgrade Touch Screen Capability:
 - Allow for speaker sound selections during activation of Command Center
 - Allow for audio content from the current touchscreen to be streamed to the HCC speakers
 - Include recording capabilities for audio conferencing, exercise event, minutes form meetings.
 - Broadcast through the speakers opposed to a phone system
- This upgrade includes design, manufacturing and integration to integrate upgrades with existing System: Current A/V System and furniture, 5x2 Planar Rear Project DLP Video Wall, Crestron Control System, QSC Audio Speakers, Jupiter Video Wall Processor.

B.5 STATEMENT OF WORK

Statement of Work

Background

Upgrade video display units from LCD rear projection to LED ultra thin video display is required as part of the ongoing hospital command center upgrade project.

Requirement

- Provide design and space planning upgrade services, specialized furniture, and video wall technology that meet the agency’s product and performance requirement with “existing” system.
- Consultation and space planning specific to emergency management concept of operations and latest industry methods and practices. Design for the most efficient use of space for when the Emergency Operation Center is activated. Lengthening the width of the existing furniture to accommodate the new display and meet all safety codes for access and egress.
- Replace DLP Rear Projection Displays with LED backlit LCD displays. Upgrade existing LCD TVs to compatible LED Backlit LCD displays. Upgrade control systems to allow for more functionality and compatibility with new displays. Upgrade videoconferencing room by adding compatible LCD displays.

- Increase capabilities to view multiple Satellite News Stations during a disaster of existing System presently installed: It will expand the capability of the current HDMI matrix switch and allow more content to be displayed in more area within the Hospital Command Center's (HCC) Executive Staff Conference room and supports Staff's Stations. This also allows for simultaneous viewing of these areas.
- Programming existing Hospital Command Center upgrades and screen selections to computers and lighting controls with previously purchased items. The base programming has already been completed with prior installations but requires additional upgrades in order for it to be compatible with the new hardware being installed.
- Installation of Hiperwall system to manage daily video dashboard for maintaining a current operation system that includes cameras, PCs, local media/TV, web content, presentations, and alerts to be integrated with future technology as it comes available. Eliminates hardware control of video and audio inputs to web based server applications. Therefore reduces possibility of equipment failures, maintenance costs and down times.
- Upgrades include integration capabilities for facilities drawings viewing of Network facilities for Continuity of Operations if relocations are required.
- Delivery, installation and training.
- Warranties and service.
- Project management.

SECTION C - CONTRACT CLAUSES

C.1 VAAR 852.232-72 ELECTRONIC SUBMISSION OF PAYMENT REQUESTS (NOV 2012)

(a) *Definitions.* As used in this clause—

(5) *Payment request* means any request for contract financing payment or invoice payment submitted by the contractor under this contract.

(b) *Electronic payment requests.* Except as provided in paragraph (e) of this clause, the contractor shall submit payment requests in electronic form. Purchases paid with a Government-wide commercial purchase card are considered to be an electronic transaction for purposes of this rule, and therefore no additional electronic invoice submission is required.

(c) *Data transmission.* A contractor must ensure that the data transmission method and format are through one of the following:

(d) *Invoice requirements.* Invoices shall comply with FAR 32.905.

(e) *Exceptions.* If, based on one of the circumstances below, the contracting officer directs that payment requests be made by mail, the contractor shall submit payment requests by mail through the United States Postal Service to the designated agency office. Submission of payment requests by mail may be required for:

SECTION E - SOLICITATION PROVISIONS

Accordingly, to insure that sufficient information is available, the bidder must furnish as a part of his/her bid all descriptive material (such as cuts, illustrations, drawings or other information) necessary for the purchasing activity to:

(i) Determine whether the product offered meets the salient characteristics requirement of the Invitation for Bids, and

(ii) Establish exactly what the bidder proposes to furnish and what the Government would be binding itself to purchase by making an award. The information furnished may include specific references to information previously furnished or to information otherwise available to the purchasing activity.

E.5 52.212-2 EVALUATION—COMMERCIAL ITEMS (OCT 2014)

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

Lowest Price Technically Acceptable

Technical acceptability shall be reviewed by our technical expert/evaluator.

(b) *Options.* The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an

offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

“Highest-level owner” means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

“Immediate owner” means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

“Inverted domestic corporation” means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;

- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;

“Sensitive technology”—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—
 - (i) To restrict the free flow of unbiased information in Iran; or
 - (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”—
