Description

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in FAR Subpart 12.6 in conjunction with Part 13, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation for this action. Quotes are being requested, and a written solicitation will not be issued.

This solicitation is issued as a Request for Quote (RFQ). Submit written quotes on VA248-16-Q-1677. The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2005-89-1 effective August 15, 2016. This request for quote is issued September 6, 2016 and will end on September 19, 2016 at 10:00 AM EST and is set aside for 100% SDVOSB.

The Network Contracting Office 8-SAO East intends to award a firm fixed priced contract providing all labor, personnel, equipment, tools, materials, supervision and other items and services necessary to change the oil and filter, tune up, and to maintain a total of sixteen (16) emergency power generators with the following identification and locations of #6, #7, #8, #9, #10, #11, #12, #13, South Bed Tower, Main Building, CLC, OPA, Administration Building, Arecibo CBOC, POPC, and St. Croix CBOC operational and in reliable conditions are defined in this Statement of Work (SOW), for the VA Caribbean Healthcare System. All the work will be in accordance with the Scope of Work below.

This procurement is being conducted under Subpart 13.5 Simplified Procedures for Certain Commercial items. The intent is to award a firm fixed price contract.

The North American Industrial Classification System (NAICS) code for this procurement is 238210, with a small business size standard of \$14M in Annual Receipts. This procurement is a SDVOSB and all eligible offerors are encouraged to submit quotes. All offerors must be registered in System for Award Management (SAM) at <http://www.sam.gov> to be considered for an award of a federal contract registered in the record must be complete and not missing elements such as representations and certifications.

C. SCOPE OF WORK

Scope of Work: The Contractor shall provide all labor, personnel, equipment, tools, materials, supervision and other items and services necessary to change the oil and filter, tune up, and to maintain a total of sixteen (16) emergency power generators with the following identification and locations of #6, #7, #8, #9, #10, #11, #12, #13, South Bed Tower, Main Building, CLC, OPA, Administration Building, Arecibo CBOC, POPC, and St. Croix CBOC operational and in reliable conditions are defined in this Statement of Work (SOW), for the VA Caribbean Healthcare System.

1. Equipment:

The contractor shall provide, after award of contract, a list of tools and equipment to be used during the course of the contract. Prior to the beginning of the contract, the Contracting Officer's Technical Representative (COR) shall inspect the contractor's equipment to ensure it is of commercial grade and is in safe operating condition.

The Contractor is responsible for performing maintenance on all emergency generators listed in the Scope of Work. All maintenance and repairs shall use supplies, materials, and parts of the highest quality available appropriate for the repair of the given equipment or system. Any replacement part used during the course of this contract must be Caterpillar authorized parts or higher quality.

2. Maintenance. All preventive and corrective maintenance shall be documented in VACHS by the personnel who initiate the service or repair. For continuity and familiarity with the EPG system, the same annual preventive maintenance contractor should be used to perform corrective maintenance.

3.1. Emergency Power Generators.

3.1.1. Monthly Inspections. Monthly inspections of all VACHS Emergency Power Generator (EPG) systems are required. A Monthly Inspection Checklist shall be filled. A copy of each checklist shall be sent to the Facility Electrical Engineer (FEE) upon completion.

3.1.2. Annual Preventive Maintenance and Inspection. Annual PM and inspection shall be accomplished each year (or every 250 operating hours) by a certified Caterpillar technical maintenance contractor. The FEE will initiate a Maintenance Record for each in their area of responsibility.

3.1.3. Corrective Maintenance. All corrective maintenance shall be recorded in VACHS. Maintenance Record shall be completed by the personnel initiating the corrective maintenance action.

3.1.4. Resistive Load Run. As required, the FEE will contract to connect a resistive load bank and run the EPG under 100% load for no less than two hours. This action is required to prevent “wet stacking” typically caused by engines operating under 30% capacity.

3.2.1. Periodic Inspections. Periodic inspections of all VACHS Emergency Power Generators (EPG) are required. A Monthly Inspection Checklist shall be filled out during each visit (not to exceed one per month or a minimum of one per quarter) to the VACHS facility and kept on file at the VACHS Facilities Maintenance Service. A copy of each checklist shall be kept on file at the responsible FEE.

3. MAINTENANCE SERVICES TO BE PROVIDED:

The preventive maintenance and tune up services for emergency generators shall include, but not be limited to the following:

1. Diesel Engine.
2. Lubrication Oil System.
3. Fuel Oil System.
4. Cooling System.
5. Intake and Exhaust Air Systems.
6. Starting System.
7. Generator.
8. Controls, Supervision and Distribution
9. Provides applicable travel, labor, parts, fluids and tooling to perform preventive maintenance.
10. Performs walk-around-visual inspection of the complete machine. Inspections are intended to identify and report readily observable equipment condition and/or deficiencies, which could adversely affect safety, machine life, operation and/or performance.
11. Provides fluid analysis for engine compartment and cooling system at selected intervals.

12. Provides written preventive maintenance and fluids analysis reports and estimate for any corrective action.
13. Provides computerized maintenance scheduling system and a contact person to coordinate the efficient scheduling of work.
14. Maintain service records of all preventive maintenance including fluid analysis.
15. Battery Banks.

4. Acceptance of Repairs/Report: The repairs and tests shall be accomplished without any abnormalities as a minimum to ensure the systems will function satisfactorily as designed. The Government shall witness this testing and provide acceptance of the results. The Contractor shall submit the detailed written result of the operational testing, and shall certify the overall result, pass or fail. With Contracting Officer's Technical Representative (COR) approval, the contractor shall correct any problem discovered during the above tests. Re-testing of the system shall be coordinated with the COR until a passing (satisfactory) result is obtained. Report shall document each phase of the installation, drawings, testing and list of equipment including product data specifications.

5. Emergency Calls. The contractor shall respond accordingly for emergency and urgent calls. A log shall be maintained of all service calls received; a description of the problem or requested work, date and time received location name and number. The contractor shall plan and schedule work to assure material, labor, and equipment are available to complete work requirements with regard to established time limits and quality standards. Verbal scheduling and status reports shall be provided when requested by the COR.

6. Emergency service calls will be classified as emergency at the discretion of the CO and COR. Generally, emergency calls consist of correcting failures that constitute an immediate danger to personnel; threaten to damage property, or threaten to disrupt activity operations. Urgent service calls will be classified as urgent at the discretion of the CO and COR. Generally, urgent calls consist of providing services or correcting failures which do not immediately threaten personnel, property, or activity missions, but will soon inconvenience and/or affect the health or well-being of personnel, and lead to property damage. Routine service calls will be classified as routine when the work does not qualify as an emergency or urgent call.

7. Green Purchasing. The Contractor must implement a comprehensive Affirmative Procurement Program for the purchasing of bio based, products and products made with recovered materials to the maximum extent possible. The Contractor shall detail how it intends to keep abreast of the development and increasing availability of bio based products and how any new or improved products will be incorporated on an ongoing basis into contract performance. The Contract will also indicate how, at a minimum, it will conform to the Comprehensive Procurement Guidelines (CPG) published by EPA with respect to recovered material products. The Contractor must update its Program to accommodate all revisions.

8. The contractor shall provide data on the quantity and dollar values of bio based products and recycled content products used in this contract. The data will be submitted to the COR monthly.

9. The contractor shall ensure that its employees have received proper personnel protective equipment and required training.

10. A copy of each service report shall be furnished to the COR and/or assigned designee at the conclusion of each service call. The service report must have a VA employee name and signature of certifying personnel.

11. DISPOSAL:

Store removed engine oil, and other components into U.S. Department of Veterans Affairs (49 CFR 178) approved 55-gallon drums. Properly label each drum to identify the type of waste (49 CFR 172) and the date the drum was filled. Obtain and complete the Uniform Hazardous Waste Manifest forms from VA Caribbean Healthcare System. Comply with land disposal restriction notification requirements as required by 40 CFR 268:

- a. At least 14 days prior to delivery, notify the COR who will arrange for job site inspection of the drums and manifests by VA Caribbean Healthcare System personnel.
- b. As necessary, make lot deliveries of hazardous wastes to the VA Caribbean Healthcare System to ensure that drums do not remain on the jobsite longer than 2 calendar days from the date affixed to each drum.

13. SPECIAL WORK REQUIREMENTS:

Contractor is to respond within 2-hours of the government request for emergency services to any complaint or call by VACHS and authorized personnel.

All personnel employed by contractor shall wear either a company shirt, or hat bearing the company logo. The contractor vehicles shall bear the company logo. Proper safety equipment is to be worn at all times. The contractor shall have competent, documented experience in the power generator business.

14. QUALIFICATIONS AND CERTIFIED TECHNICIANS

Contractor shall provide trained and qualified technician to operate the equipment and perform EPG maintenance and repair to the extent necessary to fulfill the requirements contained in this statement of work. Technician shall be experienced Preventive Maintenance, Repairs and troubleshooting on Caterpillar Emergency Generators. In addition, technician shall be able to conduct diagnostics protocols and in consultation with the VACHS conduct major, minor repairs as needed to the system. Provide all qualifications and copies of Caterpillar Trained certifications. The service provider shall ensure that technicians have all technical and knowledge competencies to conduct the necessary services. Technicians shall be experienced Preventive Maintenance, Repairs and troubleshooting on Caterpillar Emergency Generators.

The Contractor personnel should be trained, physically capable, and qualified to perform required services, and should receive periodic training to maintain proficiency and to keep current with required certifications. Technician personnel shall be responsible for conducting the required services with all health and safety precautions in accordance with OSHA requirements, National Fire Protection Authority (NFPA) and Contractor's work health and safety occupational plans.

15. PROPERTY DAMAGE:

The contractor shall take all necessary precautions to prevent damage to any government property. The contractor shall report any damages immediately and shall be assessed current replacement costs for property damaged by the contractor, unless corrective action is taken. Any damaged material (i.e., trees, shrubs, lawn/turf, curbs, gutters, sidewalks, etc.) will be replaced in a timely manner or corrected by the contractor with like materials, at no extra cost to the government, upon approval of the Contracting Officer.

16. IDENTIFICATION, PARKING, SMOKING, CELLULAR PHONE USE AND VA REGULATIONS:

The contractor's employees shall wear visible identification at all times while on the premises of the VA property. It is the responsibility of the contractor to park in the appropriate designated parking areas. Information on parking is available from the VA Police-Security Service. The VA will not invalidate or make reimbursement for parking violations of the contractor under any conditions. Smoking is prohibited inside any buildings at the VA. Cellular phones and two way radios are not to be used within six feet of any medical equipment. Possession of weapons is prohibited. Enclosed containers, including tool kits, shall be subject to search. Violations of VA regulations may result in a citation answerable in the United States (Federal) District Court, not a local district state, or municipal court.

17.0 PERIOD OF PERFORMANCE: This is a service contract with the performance period starting October 1, 2016 to September 30, 2017.

18.0 HOURS OF OPERATIONS. The contractor shall perform the services required under this contract during the following hours: Mondays through Fridays, 0700 to 1600 hours.

D. Contract Administration

The Contracting Officer is the only person authorized to approve changes or modify any of the requirements under this contract. The Contractor shall communicate with the Contracting Officer on all matters pertaining to contract administration. Only the Contracting Officer is authorized to make commitment or issue changes that will affect price, quantity or quality of performance of this contract. In the event the Contractor effects any such change at the direction of any person other than the Contracting Officer, the change shall be considered to have been made without authority and no adjustment will be made in the contract price to cover any increase in cost incurred thereof.

LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes FAR 52.219-14 Limitations on Subcontracting. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. Furthermore, if VA determines any services the support contractor(s) will perform in assessing compliance are advisory and assistance services as defined in FAR 2.101, Definitions, the support contractor(s) must also enter into an agreement with the contractor to protect proprietary information as required by FAR 9.505-4, obtaining access to proprietary information, paragraph (b). The contractor is required to cooperate fully and make available any records as may be required to enable the CO to assess the contractor's compliance with the limitations on subcontracting or percentage of work performance requirement.

(End of Clause)

SUBCONTRACTING COMMITMENTS--MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes VAAR 852.215-70, Service-Disabled Veteran-Owned and Veteran-Owned Small Business Evaluation Factors, and VAAR 852.215-71, Evaluation Factor Commitments. Accordingly, any contract resulting from this solicitation will include these clauses. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) to assist in assessing contractor compliance with the subcontracting commitments incorporated into the contract. To that end, the support contractor(s) may require access to the contractor's business records or other proprietary data to review such business records regarding contract compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of

assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. Furthermore, if VA determines any services the support contractor(s) will perform in assessing compliance are advisory and assistance services as defined in FAR 2.101, Definitions, the support contractor(s) must also enter into an agreement with the contractor to protect proprietary information as required by FAR 9.505-4, obtaining access to proprietary information, paragraph (b). The contractor is required to cooperate fully and make available any records as may be required to enable the CO to assess the contractor compliance with the subcontracting commitments.

CONTRACT CLAUSES

52.212-4 CONTRACT TERMS AND CONDITIONS—COMMERCIAL ITEMS (MAY 2015)

(a) *Inspection/Acceptance.* The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

- (1) Within a reasonable time after the defect was discovered or should have been discovered; and
- (2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) *Assignment.* The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) *Changes.* Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) *Disputes.* This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) *Definitions.* The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity,

fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) Invoice.

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include—

- (i) Name and address of the Contractor;
- (ii) Invoice date and number;
- (iii) Contract number, contract line item number and, if applicable, the order number;
- (iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;
- (v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;
- (vi) Terms of any discount for prompt payment offered;
- (vii) Name and address of official to whom payment is to be sent;
- (viii) Name, title, and phone number of person to notify in event of defective invoice; and
- (ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.
- (x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer—Other Than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) *Patent indemnity.* The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) *Payment.*—

(1) *Items accepted.* Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) *Prompt payment.* The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

(3) *Electronic Funds Transfer (EFT).* If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) *Discount.* In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) *Overpayments.* If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall—

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the—

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

(C) Affected contract line item or subline item, if applicable; and

(D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) *Interest.*

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) *Final decisions.* The Contracting Officer will issue a final decision as required by 33.211 if—

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on—

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) *Risk of loss.* Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) *Taxes.* The contract price includes all applicable Federal, State, and local taxes and duties.

(l) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. (m) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

“Highest-level owner” means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

“Immediate owner” means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

“Inverted domestic corporation” means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). - (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).
