A.1 SOLICITATION QUESTIONS AND ANSWERS

A. The following section provides questions submitted in response to the solicitation and the Government's responses.

1. What were the company's name, DUNS number, contract value, and year of the last awarded contract?

RESPONSE: There is no incumbent or previous contract.

2. The statement states 1920 hours. Is this per driver or annual total to include all three drivers?

RESPONSE: Each CLIN in the Price Schedule is for one driver per period of performance.

3. Where is the actual place of performance?

RESPONSE: These services shall be performed within the National Capital Region and other geographical locations in Maryland, Virginia, and West Virginia, and other neighboring states. The VA's Central Office (VACO), Transportation Office is located at 810 Vermont Avenue, Washington, DC 20005.

4. What are the standard daily hours of operations?

RESPONSE: 7:00 am - 5:30 pm

5. Is the contractor required to purchase fuel for the vehicle(s)?

RESPONSE: No.

6. Is there a maximum number of hours per driver that the contractor is allowed to bill for on a daily basis?

RESPONSE: No, but see the service hours in Question 4. In addition, no overtime is authorized and offerors are required to comply with the Service Contract Act and applicable Wage Determination.
