B.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes VAAR 852.219-10 VA Notice of Total Service- Disabled Veteran-Owned Small Business Set-Aside. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. Statement of Work

Contractor shall provide labor and materials necessary for replacing two Air Curtains located near the loading dock of building 2. The first Air Curtain provides service for the double doors leading from the loading dock into building 2. The second Air Curtain provides service for the set of double doors leading from the loading dock into the kitchen area inside building 2. All service will be completed at the Philadelphia VAMC, 3900 Woodland Ave, Philadelphia Pa. 19104 as follow:

Contractor shall coordinate all work with the A/C foreman to lock out /tag out all energy supply, hot water heating and electrical outlets connected to the air curtains. Contractor shall provide protection for the work area inside the kitchen with removable plastic tents to contain dust and debris inside the work site. All work shall be scheduled in advance with A/C foreman. Contractor shall demolish and properly dispose of the two existing air curtains, disconnect electric power wiring and heating hot water supply and the return piping. Contractor shall remove ceiling tile and grid as required to perform demolition activities.

Contractor shall provide and install two new Applied Air/King Air Curtains model KIC-06-300 or equal complete with 2 row hot water coils (6FPI), 3 HP TEFC Fan Motor (460 volt, 3 phase, 1800 rpm), and new door switch. Contractor shall provide and install new supply and return piping complete with new isolation valves as required. Contractor shall reconnect the power wiring with a new door switch to provide operation of the air curtains only when the doors are open. Contractor shall re-install ceiling grid and tiles to complete installation.

Contractor shall test and start up the new air curtains and provide training to staff on the proper operation of the air curtains. The job duration is 90 calendar days from award which includes equipment delivery and installation.

Contractors shall be qualified for HVAC and Electrical work in Health Care Facilities and provide supporting documentation of past performance on similar projects.

The contractor shall obtain and maintain access to building 2 during the installation period only after completing TMS security training. Work will be performed between the hours of 7:00 a.m. and 5:00 p.m. Monday through Friday with the exception of holidays.

Contractor shall provide one year full warranty on labor and material from acceptance.

(a) Definition. For the Department of Veterans Affairs, "Service-disabled veteran-owned small business concern":

(1) Means a small business concern:

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans (or eligible surviving spouses);

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans (or eligible surviving spouses) or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran;

(iii) The business meets Federal small business size standards for the applicable North American Industry Classification System (NAICS) code identified in the solicitation document; and

(iv) The business has been verified for ownership and control and is so listed in the Vendor Information Pages database, (<http://www.VetBiz.gov>).

(2) "Service-disabled veteran" means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

(b) *General.* (1) Offers are solicited only from service-disabled veteran-owned small business concerns. Offers received from concerns that are not service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a service-disabled veteran-owned small business concern.

(c) Agreement. A service-disabled veteran-owned small business concern agrees that in the performance of the contract, in the case of a contract for:

(1) Services (except construction), at least 50 percent of the cost of personnel for contract performance will be spent for employees of the concern or employees of other eligible service-disabled veteran-owned small business concerns;

(2) Supplies (other than acquisition from a nonmanufacturer of the supplies), at least 50 percent of the cost of manufacturing, excluding the cost of materials, will be performed by the concern or other eligible service-disabled veteran-owned small business concerns;

(3) General construction, at least 15 percent of the cost of the contract performance incurred for personnel will be spent on the concern's employees or the employees of other eligible service-disabled veteran-owned small business concerns; or

(4) Construction by special trade contractors, at least 25 percent of the cost of the contract performance incurred for personnel will be spent on the concern's employees or the employees of other eligible service-disabled veteran-owned small business concerns.

(d) A joint venture may be considered a service-disabled veteran owned small business concern if--

(1) At least one member of the joint venture is a service-disabled veteran-owned small business concern, and makes the following representations: That it is a service-disabled veteran-owned small business concern, and that it is a small business concern under the North American Industry Classification Systems (NAICS) code assigned to the procurement;

(2) Each other concern is small under the size standard corresponding to the NAICS code assigned to the procurement; and

(3) The joint venture meets the requirements of paragraph 7 of the explanation of Affiliates in 19.101 of the Federal Acquisition Regulation.

(4) The joint venture meets the requirements of 13 CFR 125.15(b).

(e) Any service-disabled veteran-owned small business concern (non-manufacturer) must meet the requirements in 19.102(f) of the Federal Acquisition Regulation to receive a benefit under this program.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.
