

**JUSTIFICATION FOR SINGLE SOURCE AWARDS IAW [FAR 13.106-1](#)**  
 (OVER MICRO-PURCHASE THRESHOLD(\$3.5K) BUT NOT EXCEEDING THE SAT (\$150K))

IAW [FAR13.104](#), COs must promote competition to the maximum extent practicable to obtain supplies and services from the source whose offer is the most advantageous to the Government, considering the administrative cost of the purchase. When competition is not practicable, IAW [FAR13.106-1\(b\)](#), COs solicit from a single source for purchases not exceeding the simplified acquisition threshold. COs may solicit from one source if the CO determines that the circumstances of the contract action deem only one source reasonably available (e.g., urgency, exclusive licensing agreements, brand-name or industrial mobilization). IAW [FAR13.106-3\(b\)\(3\)](#), COs are required to include additional statements ***explaining the absence of competition*** (see [13.106-1](#) for brand name purchases) if only one source is solicited and the acquisition does not exceed the simplified acquisition threshold (does not apply to an acquisition of utility services available from only one source) or supporting the award decision if other than price-related factors were considered in selecting the supplier. UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED:</b>  Lebanon VAMC requests Haag-Streit brand equipment for use with equipment currently used in the eye clinic. All of the facility’s other Slit Lamps are Haag-Streit, and the purchase of additional brand name equipment is needed to ensure interface ability with the lamp accessories in the clinic (lightbulbs are specific to the Haag-Streit Slit lamp). Additionally, the purchase of brand name equipment is necessary to ensure continuity for staff members who have been trained in the existing equipment.

DESCRIPTION OF MARKET RESEARCH CONDUCTED AND RESULTS OR STATEMENT WHY IT WAS NOT CONDUCTED:</b>  Requesting service conducted research in GSA Advantage and found three businesses that can provide the requested equipment – two small businesses and one large business. In compliance with the Kingdomware decision, the CO conducted research in the VIP database and found two SDVOSB that can provide the necessary equipment.
