### **1.0 DESCRIPTION OF SERVICES**

The VA Office of Security and Preparedness has a requirement for a Protective Service Course that will be attended by 6 new officers. This course is necessary to ensure that the Office of Security and Preparedness maintains a sufficient quantity of trained special agents

5.4.3 Provide the student with a study of vehicle dynamics and study on historical and analytical evaluation of previous attack situations.

5.4.4 Provide the student with practical exercises in vehicle dynamics including braking techniques, precision driving and motorcade operations, single and motorcade tactical evasive operations and mock attack scenario.

## 7.0 Contractor Qualifications

7.1 Contractor shall provide past performance information for work of a similar size and scope to that indicated in this Product Description to include customer point of contact, synopsis of performed training, and training plan.

7.2 Contractor shall provide training site information (pictures preferable) to ensure the contractor's site has capacity to perform live firing exercises and driving instruction.

7.3 Contractor shall provide credentials/resumes along with the number of instructors performing the training.

## **8.0 Quality Assurance Surveillance Plan (QASP)**

Performance Standards define required performance for specific tasks. The Government performs surveillance to determine if the contractor exceeds, meets or does not meet these standards. The Government may utilize the table below or another method to compare contractor performance to the Acceptable Levels of Performance (ALPs).

### **8.1 Acceptable Performance**

- 8.1.1 The Government shall document acceptable performance accordingly. Any report may become a part of the supporting documentation for any contractual action.

- 8.2.2 When the CO determines formal written communication is required, the COR shall prepare a Contract Discrepancy Report (CDR), and present it to the Contractor's program manager.
- 8.2.3 The Contractor shall acknowledge receipt of the CDR in writing to the CO. The CDR will state how long after receipt the Contractor has to take corrective action. The CDR will also specify if the Contractor is required to prepare a corrective action plan to document how the Contractor shall correct the unacceptable performance and avoid a recurrence. The CO shall review the Contractor's corrective action plan to determine acceptability.

### 8.3 Frequency of Measurement

- 8.3.1 During contract/order performance, the COR will periodically analyze whether the negotiated frequency of surveillance is appropriate for the work being performed, and at a minimum shall be performed twice within the Period of Performance.

- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). “Sensitive technology”—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—
  - (i) To restrict the free flow of unbiased information in Iran; or
  - (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and
- (2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”—

- (1) Means a small business concern—
  - (i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and
  - (ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.
