2. Nature and/or Description of the Action Being Processed: Contract for custom Perfusion kits. Items being ordered are Custom Packs made specifically for Cardiac Surgery to insure the Perfusion team at the West Roxbury MA campus can provide to the Dr.'s, to place a patient on lung and heart bypass during Cardiac surgery. Perfusion also provides blood filtration for other caseloads such as Vascular and General Surgery. This contract will be a firm fixed price, with a base year and 4 options years. The total approximate value is: This is a Brand Name Justification only. TF

3. Description of Supplies/Services Required to Meet the Agency's Needs:

Cardmedia tubing packs/heparin bonded are required when conducting cardio pulmonary bypass and provide cardiac and pulmonary support for the patient. The technique administers low doses of heparin bonded circuits to provide high quality medical care to the patient. These supplies and accessories are used in all open heart cases. Through clinical market research it was determined that Cardmedia tubing packs/heparin bonded can only be purchased from Medtronic or their distributors.

The MPS Cardioplegia Delivery Set is a brand name that we need to acquire because we currently own the Quest MPS console equipment, and these are the only supplies that will work with this equipment.

The CDI Blood Parameter Monitoring System 500 (CDI System 500) with Sensor is the only product of this type in the market. It is used as part of the Custom Packs because it continuously measures and calculates vital blood parameters during cardiopulmonary bypass. This product provides the Cardiac surgeons and Perfusionists information to improve patient care during surgery. The CDI System equipment is also currently owned by the VA.

The Haemonetics Cell Saver is the only brand that will suffice because it is the only product that is used with the Elite Autotransfusion System that we currently own. These supplies and accessories are used in all open heart cases along with some vascular and abdominal surgery cases.

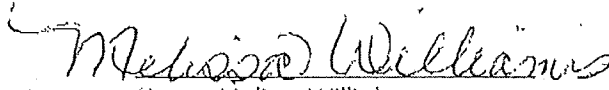

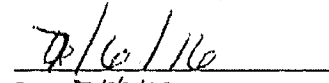
