

## Sole Source Justification

1. **Contracting Activity:** Department of Veterans Affairs

2. **Description of Action:** This sole source justification requests for the issuance of a sole source Purchase Order for VA employees to attend the Partnership for Public Service – Excellence in Government Fellows Program. This training is for 31 students, who are Federal employees, to attend the Excellence in Government Fellows Program at \$9,900.00 per student for a total cost of \$306,900.00.
  
3. **Description of Supplies or Services:** The Partnership for Public Service – Excellence in Government Fellows Program was established to help identify the best qualified employees from Veterans Affairs (VA) to attend select high-impact leadership development programs. The Corporate Employee Development Board (CEDB) process allows VA's senior leadership (GS-13 level and above, including Title 38 equivalents) to take a corporate approach toward leadership development. The CEDB aims to develop a broad cadre of leaders who can help drive change, inform, shape strategic planning, and integrate policy at VA. Employees will receive CLPs for this executive training.

5. **Statutory Authority:** The authority permitting this action is Federal Acquisition Regulation 13.501(a) Sole Source Acquisitions.
  
6. **Rationale Supporting:** Use of Authority Cited Above:

The VA Training Leadership Council (TLC) recommended the Excellence in Government Fellows Program for inclusion in the list of upper level leadership training offered under the VA Corporate Employee Development Board (CEDB) program. The CEDB equips leaders to handle the challenges and ever-changing environments that Veterans face on a daily basis. This particular course was

selected by the VA Staff Offices and Administrations, vetted by the VA Training Leaders Council (TLC), and recommended for approval and implementation by the VA Human Capital Management Board (HCMB) and approved for inclusion in the CEDB by the VA Chief of Staff. Partnership for Public Service is a private institution and is held in highest regard as being a premier institute that can provide exclusive Senior Executive Training. Partnership for Public Service is the only institution that offers the Excellence in Government Fellows Program. The Excellence in Government Fellows Program provides senior executives with new skill sets to be leaders and managers. Functional expertise is overshadowed by the need to build coalitions, drive results and performance, and guide organizational change.

The curriculum in this course encompasses all of the Office of Personnel Management (OPM) Executive Core Qualifications which are: Leading Change, Leading People, Results Driven, Business Acumen, and Building Coalitions. This program of instruction is designed for federal government employees at the high functioning GS-13 level and above to include Title 38 Equivalents.

- 7. Efforts to Obtain Competition:** There is only one responsible source for the Partnership for Public Service – Excellence in Government Fellows. There is no competition anticipated for this acquisition. Procurement data does not include any unnecessary requirements that may inhibit competition.
- 8. A listing of the sources, if any that expressed, in writing, an interest in the acquisition:** No sources have expressed any interest in this acquisition.
- 9. Fair and Reasonable Cost Determination:** The Contracting Officer has made a determination that the price is fair and reasonable. All Schools on the Corporate Employee Development Board present pricing that is the same for all attendees.
