**(2) NATURE AND/OR DESCRIPTION OF ACTION BEING APPROVED:**

This is a new action required to continue using chemistry and immunoassay analyzers in place at the VA Palo Alto Health Care System (VAPAHCS).

**(3) (a) A DESCRIPTION OF THE SUPPLIES OR SERVICES REQUIRED TO MEET THE AGENCY'S NEED:**

Chemistry and immunoassay laboratory analyzers are used to run tests on patient samples to assist in diagnosing medical issues. NCO 21 awarded an order (VA261-16-F-2145) to Beckman Coulter on August 16, 2016 in response to a competitive solicitation (VA261-16-Q-0141). The order requires Beckman Coulter to furnish and install new chemistry and immunoassay analyzers throughout all VISN 21 designated facilities. Due to the length of time required for installing new laboratory analyzers under the new VISN contract, the current analyzers provided by Beckman Coulter, Inc. are needed in order to prevent an interruption of services. The implementation of the new analyzers is estimated to take 6 months. The resulting order issued will be terminated once the new analyzers and support equipment is installed, validated, and accepted by VA under the new VISN contract.

The new analyzers and support equipment will take at least six months to install, validate, and accept under the new VISN contract. Beckman Coulter, Inc.'s analyzers are currently in place at all of the VISN facilities. No other FSS contractor is capable of providing analyzers before the current contract expires.

**(5) DESCRIBE WHY YOU BELIEVE THE ORDER REPRESENTS THE BEST VALUE CONSISTENT WITH FAR 8.4 TO AID THE CONTRACTING OFFICER IN MAKING THIS BEST VALUE DETERMINATION:**

FSS contract prices have already been determined to be fair and reasonable at the GSA contract level. Therefore, a separate price determination is not required.

Market research has been conducted among the interested FSS schedule holders for the new VISN procurement. However, since no contract holder, other than Beckman Coulter, Inc. has their analyzers in place; no further market research has been conducted nor is needed.
