The Government Technical evaluator reviewed the proposed hours and indicated that they were necessary and acceptable based on the level of effort necessary to complete the requirement. Furthermore he indicated the breakdown of hours for each team member is justifiable and will be needed. The contractor's team will work in concert with the activations of the new HCC. 


