The Contractor shall provide all equipment, supplies, management, supervision, personnel, and transportation necessary to assure that all services are in accordance with the contract and all applicable laws and regulations. The contractor shall ensure all work meets performance standards specified in this Performance Work Statement (PWS) and referenced documents.

Section 5: Specific Tasks

5.1 Preventative Maintenance Inspection and Testing

- A. Contractor shall provide all tools, equipment, labor, materials, transportation, and supervision necessary to accomplish the tasks specified in this contract. Perform five year testing and inspections in accordance with the California code regulation title 19, and the NFPA 25 most current editions to include all notes and appendixes. At all locations stated in section 1.6.
- B. Contractor shall be responsible to test and inspect all devices, systems, and perform all testing as per NFPA 25 to include all systems. Some locations have multiple building and systems.
- C. Inspection, testing, and maintenance of private fire main system:
 - a. Water spray fixed systems; Gauges tested and calibrated or replaced.
 - b. Perform reducing valve full flow test.
 - c. Standpipe and hose system; inspect interior of dry-pipe valves (that can be reset without opening). Inspect alarm valves and their associated strainers, filters, and restriction orifices, internally inspect check valves to ensure all parts operate properly, move freely and are in good condition, strainers, internally inspect filters restricted orifices and diaphragm chambers on dry-pipe valves.
 - d. Tests all gauges against a calibrated gauge or replace, test automatic standpipe systems at required flows; record static pressure, residual pressure, and flows indicate if flow and pressures are acceptable, record all hose connection and hose rack assemble pressure.
 - e. Preaction and deluge fire sprinkler inspections; internally inspect check valves to ensure all parts operate properly, move freely and are in good conditions, internally inspect filters, restricted orifices and diaphragm chambers, internally inspect preaction and deluge valves that can be externally reset.
 - f. Wet pipe fire sprinkler systems; Sprinklers rated above high temperatures shall be tested, test all gauges against a calibrated gauge or replace, perform full flow tests on all pressure reducing valves.

 - i. Fire pump testing: Complete 5 year testing per applicable codes.
 - j. Fire Department Connections; perform back flush o fall fire department connections.
 - k. Labeling of system during testing: it is the contractor's responsibility to provide a weather resistant impairment tag, tag shall be place on the valves and fire department connection to alert responding fire fighters of an abnormal condition.

- l. Certification labeling: Upon completion certification of inspections a NFPA/CCR compliant inspection label shall be placed on all system risers at the first floor location, and at all locations directed by code.
 - m. Contractor shall provide an excel spreadsheet of all devices tested with building and location.
 - D. Contractor shall request in writing 30 days prior to the COR of impairment, disarming, disabling, or shutting down of any system. Contractor shall confirm with COR at the end of a work day to reactivate all fire protection systems.
 - E. Contractor shall be responsible to conduct an Interim Life Safety Measure (i.e. fire watch) for impaired system(s), as described in the NFPA 25, greater than 10 hours.
 - F. Contractor shall submit a schedule to COR for review and approval.
 - G. Building audible alarm shall be silenced for only the device being replaced, repaired, modified, inspected, or testing. All other alarm panel functions shall operate normally. Building audible alarm and all non-work related alarm signals must be received by the monitoring company and building occupants.
 - H. Contractor shall contain all water to prevent damage to all floor coverings, ceilings, walls office furniture and equipment. Damaged items shall be replaced or cleaned to new condition at the discretion of the COR. Contractor shall be solely responsible for costs related to items damaged during repairs, replacement, modifications, inspections, or testing to the fire protection system.
 - I. Contractor shall be responsible for the safety of all employees, staff, patients, and visitors and take all necessary precautionary measures. Contractor shall for VA Palo Alto Health Care System infectious control plan and measures.

 - N. Contractor shall provide daily reports to the COR and meet every week for project meetings with COR. Contractor shall have an updated gantt chart and present issues. Project planning and scheduling shall be in Microsoft projects.
 - O. Site Investigation and Conditions Affecting the Work: The Contractor acknowledges that it has taken steps reasonably necessary to ascertain the nature and location of the work, and that it has investigated and satisfied itself as to the general and local conditions which can affect the work or its cost, including but not limited to (1) conditions bearing upon transportation, disposal, handling, and storage of materials; (2) the availability of labor, water, eclectic power, and roads; (3) uncertainties of weather, river stages, tides, or similar physical conditions at the site; (4) the conformation and condition of the ground; and (5) the character of equipment and facilities needed preliminary to and during work performance. The Contractor also acknowledges that it has satisfied itself as to the character, quality , and quantity of surface and subsurface materials or obstacles to be encountered insofar as this information is reasonably ascertainable from an inspection of the , including all exploratory work done by the Government, as well as from the drawings and specifications made a part of this contract. Any failure of the Contractor to take the actions described and acknowledged in this paragraph will not relive the Contractor from

responsibility for estimating properly the difficulty and cost of successfully performing the work, or for proceeding to successfully perform the work without additional expense to the Government.

- P. The Government assumes no responsibility for any conclusions or interpretations made by the Contractor based on the information made available by the Government. Nor does the Government assume responsibility for any understanding reached or representation made concerning conditions which can affect the work by any of its officers or agents before the execution of this contract, unless that understanding or representation is expressly stated in this contract. Contracting Officer is the only authorized person to make any modification on this contract.

The past performance evaluation assesses the level of expectation the Government has in a prospective contractor's ability to meet the requirements of the solicitation, based on a demonstrated record of performance. Past performance will be rated as "acceptable" or "unacceptable" in accordance with the following definitions:

In the case of a contractor without a record of relevant past performance or for whom information on past performance is not available or so sparse that no meaningful past performance rating can be reasonably assigned, the contractor may not be evaluated favorably or unfavorably on past performance. Therefore, the contractor shall be determined to have unknown past performance. In the context of acceptability/unacceptability, "unknown" shall be considered "acceptable."

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

“Highest-level owner” means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

“Immediate owner” means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

“Inverted domestic corporation” means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;
- (4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;
- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

“Sensitive technology”—

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

“Small business concern” means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

“Small disadvantaged business concern”, consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that—

(1) Is at least 51 percent unconditionally and directly owned (as defined at 13 CFR 124.105) by—

(i) One or more socially disadvantaged (as defined at 13 CFR 124.103) and economically disadvantaged (as defined at 13 CFR 124.104) individuals who are citizens of the United States; and

(2) The management and daily business operations of which are controlled (as defined at 13.CFR 124.106) by individuals, who meet the criteria in paragraphs (1)(i) and (ii) of this definition.

“Subsidiary” means an entity in which more than 50 percent of the entity is owned—

(1) Directly by a parent corporation; or

(2) Through another subsidiary of a parent corporation.
