1. Contracting Activity: Department of Veterans Affairs, Network 16 Contracting Activity, Michael E. DeBakey VA Medical Center VA Medical Center 2002 Holcombe Boulevard Houston, TX 77030

2. Nature and/or Description of the Action Being Processed: Pursuant to Citations 41 U.S.C. 304(a)(2) the VA has a need for the supplies of such a compelling urgency that the Government would be seriously injured unless the agency is permitted to limit the number of sources from which it solicits bids or proposals, full and open competition need not be provided for. Supplies at this time may be deemed to be available only from the original source. Award to another source would result in unacceptable delays in fulfilling the agency's requirement and substantial duplication of cost to the Government that is not expected to be recovered through competition.

The Government anticipates entering into sole source acquisition to Abiomed, Inc. for Catheters based on the quantities listed below.

The Impella CP is percutaneously inserted circulatory support device that can provide, active unloading of the left ventricle without the need for atrial (transeptal) puncture. The unique, minimally-invasive technology employs a microaxial pump which is placed into the aorta by means of a catheter that is inserted into the femoral artery. The Impella support device minimizes the need for access to multiple vessels in order to provide direct circulatory support of up to 4.2 liters/minute. The Impella CO also provides pressure measurements which are helpful in determining intravascular pressure.

Only Abiomed is capable of providing the supplies or services required at the level of quality required because the supplies or services ordered are unique or highly specialized.

6. Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable: This procurement action is deemed an emergency, and the research conducted was in VIP portal but limited due to time constraints. The search conducted found 73 SDVOSB that could potentially fulfill the requirement but due to the urgency of this order the contracting officer found the price as fair and reasonable when compared to the submitted quote and the IGCE.

7. Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable: Because of time constraints the contracting officer found the price as fair and reasonable when compared to the submitted quote and the IGCE.

8. Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted: VIP portal was searched and yielded 73 SDVOSB that could potentially fulfill the requirement but due to time constraints the contracting officer feels that the price is fair and reasonable when compared to the submitted quote and the IGCE.
