

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in [Subpart 12.6](#), as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; proposals are being requested and a written solicitation will not be issued.

The solicitation number VA249-17-Q-0091 is issued as a request for quotation (RFQ).

The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular 2005-83.

The requirement is a Service Disabled Veteran-Owned Small Business (SDVOSB) set-aside. The associated NAICS code is 238210 and small business size standard \$15 Million.

The government anticipates awarding a Firm Fixed Price award. Award will be made to lowest price quote which conforms to the requirements within this solicitation.

James H. Quillen VA Medical Center, Engineering Department (138), located at the Juncture of Lamont & Veterans Way, Mountain Home, TN 37684 needs a contract to inspect elevators.

Also, review the attached statement of work (SOW), Price/Cost Schedule, FAR clauses & provisions, and Wage Determination 08-0003 (Rev.-7) for complete details.

The contract period of performance: December 1, 2016 – November 30, 2017.

SUBMISSION REQUIREMENTS:

1. The Contractor shall submit a quote on company letterhead and include the following information: name, address, and telephone number and DUNS#. The quote shall have the following information included: quantity, unit frequency, unit price, total cost, applicable shipping charges, offered discounts or proposed delivery listed in the item description as specified above.
2. The Contractor shall complete the annual representations and certifications electronically via the SAM Web site accessed through <https://www.SAM.gov>.
3. The Contractor shall provide sufficient evidence that they possess adequate resources, capability, experience, responsibility and integrity to meet the technical capabilities to comply with the requirements of the solicitation.
4. The Contractor shall provide past performance evidence. This assessment is based on the Contractor's record of relevant and recent past performance information that pertains to services outlined in the solicitation requirements.

8. There will be no automated email notification of receipt of quotes. All quotes received without requested documentation will not be considered. The Government will not provide paper copies of the solicitation. Telephone, written, or facsimile, requests, for the solicitation package will not be honored.

DISCLAIMER AND IMPORTANT NOTES: The government is in no way obligated to do business with or enter into the award a contract to any firm or its affiliates or otherwise pay for the information provided in this synopsis.

Statement of Work

Requirements: These specifications cover the semi-annual maintenance inspections of the elevators and dumbwaiters, the annual tests of governor and safety devices and the test for car and counter weights, governors and oil buffers on said elevators and dumbwaiters during the period of this contract. The American Standard Practice for the Inspection of Elevators, inspectors' Manual A17.2-1979 (or latest edition), and the American National Standard Safety Code for elevators, dumbwaiters, escalators, and moving walks - ANSI, A17.11978 (or latest edition) or ASME A17.2.1B-1995 (or latest edition), will be used by the inspector as a guide in making inspections and recommendations.

Inspections: The inspections shall be thorough and cover all items as specified in "Report of Inspection of Elevators", VA Form 10-6166, as well as any other parts and assemblies not listed thereunder in order to make a proper inspection. A minimum of one and one-half (1-1/2) hours shall be spent on each elevator and one (1) hour for each dumbwaiter per inspection. Parts shall be removed where necessary to determine the exact condition of parts which could not otherwise be determined, and the equipment shall be cleaned where necessary to make the proper inspection. The following provisions apply:

- a. Cables: The inspector shall inspect the entire length of each cable and use mirrors to inspect concealed portions of cable. Each view point on concealed side of cables shall be identified (i.e., chalk marks) before moving to a new view point. Inspector shall use a micrometer to check cable for stretch. The entire length of each cable shall be inspected in three-foot sections. The inspector shall use a tension gauge to insure proper adjustment of hoisting cables.
- b. Rails: Rails marked (i.e., damaged) by inspectors' forces shall be refinished to match original condition.
- c. Doors: The inspector shall test (with scales) and/or adjust hoistway doors in compliance with ANSI A17.1A - latest edition. Hoistway doors shall not exceed

a closing pressure of thirty (30) pounds. The force shall be measured at 1/3 closed and 2/3 closed positions.

Annual Test:

- a. Safeties shall be subjected to an annual running test as indicated in the Safety Test instructions on VA Form 10-6167, "Report of Test of Elevator Governor and Safety Devices".
- b. The slowest operating speed, at no load test required for annual test, shall be made as indicated in the Safety Test Instructions on VA Form 10-6167, "Report of Test of Elevator Governor and Safety Devices".

Inspections are to be made in accordance with the Safety Code for Elevators, ANSI A17, 1-1971. Elevators are to be run at slow speed.

Reports: The Contractor shall complete VA Forms 10-6166 and 10-6167 which are not applicable, the notations "NA" (not applicable) shall be made. On the reverse side of such forms, the Contractor shall clearly indicate any adjustments, repairs, or replacements necessary to correct troubles encountered, shall definitively justify such recommendations, and shall furnish specifications sufficient to enable VA to purchase the materials required for such purposes. Also, on the reverse side of the forms, the Contractor shall advise whether the elevator parts have been kept clean and lubricated where necessary. Reports will be prepared and submitted in original and two (2) copies, no later than 15 working days following the inspection, to the Chief, Engineering Service at the VA Medical Center being inspected.

You are requested to visit the job site to determine the scope of work and view the area where the work is to be performed. Failure to do so will not relieve the successful offeror from performing in accordance with the strict intent and meaning of the specifications without additional cost to the Government. Prospective offerors should contact the VA Medical Center, Engineering Service to arrange an appointment to inspect the premises. Telephone number for this Medical Center is 423/232-6950, ext. 200.

Deliveries or Performance

1. VA Medical Center, Mountain Home, TN -- semi-annual inspections and tests will be made during the months of December and June. Annual safety test will be scheduled simultaneously with the June test.
2. Hours of Work:
 - a. Work required in the performance of this contract shall be performed during the Medical Centers' regular administrative working hours, which are from 7:45am to

4:30 pm, Monday through Friday. Upon visiting the Medical Center for inspection purposed, the Contractor shall report to the Chief, Engineering Service or his designee. The Maintenance Unit A Shop Foreman, or his designee at the medical Center, shall accompany the Contractor as an observer during the entire time of each inspection. Upon completion of the inspection, the Contractor shall again report to the Chief, Engineering Service or his designee.

- b. Contractor shall notify the Chief, Engineering Service at least 72 hours in advance as to the date of the contemplated inspection.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as

those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(ii) Each individual claiming economic disadvantage has a net worth not exceeding \$750,000 after taking into account the applicable exclusions set forth at 13 CFR 124.104(c)(2); and

(2) The management and daily business operations of which are controlled (as defined at 13 CFR 124.106) by individuals who meet the criteria in paragraphs (1)(i) and (ii) of this definition.

Veteran-owned small business concern means a small business concern—

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(2) The management and daily business operations of which are controlled by one or more veterans.

Women-owned small business concern means a small business concern—

(1) That is at least 51 percent owned by one or more women; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and

(2) Whose management and daily business operations are controlled by one or more women.

Women-owned small business (WOSB) concern eligible under the WOSB Program (in accordance with 13 CFR part 127), means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.

(b)(1) The North American Industry Classification System (NAICS) code for this acquisition is—238220.

The bidder or offeror agrees that if a contract is awarded to him/her, as a result of this solicitation, he/she will not advertise the award of the contract in his/her commercial advertising in such a manner as to state or imply that the Department of Veterans Affairs endorses a product, project or commercial line of endeavor.
