**Summary of Changes**

Amendment No. A00006, Solicitation VA260-16-R-0318, Demolish Seismically Deficient Bldg. 214 and Construct New Specialty Care Bldg. 201B

The purpose of this amendment is to issue the following changes:

1. Add the following attachments:

- a. Attachment 1 – Spec Section 07 46 46 – Fiber Cement Siding
- b. Attachment 2 – Drawing Depicting Scope of Work for Deleting the North Parking Lot

2. Answer the following questions:

Question 1: The Pre-Demolition Hazardous Building Materials Survey was provided in Amendment #3. Section 6.2-Recommendations, states to develop a scope of abatement work for competitive bidding. Was a scope of abatement ever produced? If so, please provide this. If not, please quantify the amount of each type of material identified in the report. Not having this information will cause the cost of abatement to be significantly higher than it should be.

Answer 1:

The crawl space – pipe insulation removal – approximately 1000 running feet - containment - **degree of difficulty – moderate**

From crawl space to up to floors – risers in walls – approximately 1200 running feet – multiple containments - **degree of difficulty – high** – have to break the walls and track the pipe runs

2<sup>nd</sup> floor – one main component – sheet vinyl flooring, multiple containments – approximately 8000 square feet - **degree of difficulty – low**

1st floor Golf Shop area – component – sheet vinyl flooring small bath and Shop – two containments - approximately 400 square feet - **degree of difficulty – low**

1st floor Golf Shop area – component – pipe insulation over ceiling and in walls – containment - approximately 120 running feet - **degree of difficulty – moderate**

Question 2: In regards to Bid Deduct #3 – Delete North Parking Lot, there is no clear delineation (Start/Stop) of the deleted scope was/has been provided. Parking lot runs North and South to add to lack of clarity. There is also no clear direction as to what replaces the deleted parking lot or how contractor is to leave that area.

Answer 2:

See attached drawing “G1.00\_9-2-16” which depicts the scope of work for the deletion of the North Parking Lot.

This deduction would mean that building 214 would be demolished and backfilled with material as specified in the Civil drawings, sheet C-500, Parking Pavement Section (Fully

compacted subgrade). There would be no site clearing, grading, rock base, curbs, utilities, landscaping, etc. (except as needed for the new chillers for building 201B).

Question 3: In regards to Bid Deduct #6 – Replace Exterior Brick with Cement Siding, please answer the following:

Answer 3:

Cement Siding? Is that Stucco or Cementitious Plank Siding? **Cementitious Plank Siding**

No spec or details provided for Cement Siding & associated flashing and trim **See attached spec section 07 46 46.**

No details regarding exterior wall construction to facilitate the Cement Siding (Amendment provided a manufacturer's detail, but a few questions remain); No spec for exterior paint (Amendment provided narrative paint requirements); No Exterior Wall Type Detail was/is part of the drawings

**Manufacturer's Exterior Wall Type detail was provided in Addendum #1**

Question 4: In regards to the Sound Wall Panels, please provide addition information on type/color and location.

Answer 4:

**See specification section 09 84 33. Use section 09 84 33, 2.1, D., 3. And Mineral fiber for substrate. The sound absorbing wall panels are to be provided by contractor and installed by contractor as directed by VA.**
