Firm fixed-price delivery order to Carefusion Solutions LLC to upgrade the Omaha & Grand Island VA's Pyxis automated dispensing cabinet system to a Windows 7 operating system.

(3) (a) A DESCRIPTION OF THE SUPPLIES OR SERVICES REQUIRED TO MEET THE AGENCY'S NEED:

This procurement includes hardware and software upgrades to the Omaha & Grand Island VA's Pyxis Medstation 4000 system to bring it in compliance with the mandate requiring Windows 7 operating system. The system tracks drug inventory, authenticates who is pulling drugs from the unit's stock and sends information to and from the pharmacy inventory management system and electronic patient record.

Carefusion is the manufacture of the existing Pyxis Medstation 4000 automated system at the Omaha & Grand Island VA Health Care Systems. Only Carefusion can provide the required upgrade as they are the sole manufacture and exclusive provider of sales and service for Pyxis products in the United States.

The current system is valued at approximately \$1,500,000. The items requested are to upgrade the current system from Windows XP to a Windows 7 operating system to meet the OI&T operating system requirements. The items requested are the only items that can be integrated with the current system due to proprietary software and configuration of the system.

As this upgrade is only available directly from the manufacture and is available through Carefusion's FFS contract V797P-4012B the price has already been determined fair and reasonable and is thus in the best interest of the government.

(6) DESCRIBE THE MARKET RESEARCH CONDUCTED AMONG SCHEDULE HOLDERS AND THE RESULTS OR A STATEMENT OF THE REASON MARKET RESEARCH WAS NOT CONDUCTED:

A VetBiz search under NAICS code 339112 was performed which produced 382 results. Another VetBiz search was performed with the keywords "automated medication" which produced zero results. In accordance with Acq Flash 12-20, Carefusion was contacted to determine if there were any authorized distributors for their Pyxis products. They stated that they are manufacture and exclusive provider of Pyxis products and services. Based on this information it was determined that they are the only company capable of providing the required upgrade.




When the automated medication dispensing cabinet system is replaced, the government will perform market research and issue a competitive solicitation if appropriate.
