**1. Contracting Activity:**

**2. Nature and/or Description of the Action Being Processed:**

The Minneapolis Veterans Affairs Medical Center currently has an urgent need for an orthopedic surgeon to provide the services as the Chief of Orthopedic Service. The Chief of Orthopedic Service is needed on a 1.0 full-time equivalent (FTE) basis from April 1, 2012 – October 1, 2012. To meet this need, the Government proposes to award an urgent indefinite quantity / indefinite delivery / firm-fixed price contract in accordance with FAR 6.302-2 (Unusual and Compelling Urgency).

The current contract (VA263-P-1395ICA) expires on March 31, 2012, and the period of performance in this contract cannot be extended as no extensions are available (e.g., 52.217-9).

It is anticipated that a long-term contract, which will follow the proposed urgent contract, will be awarded within the next 6 – 8 months.

**3. Description of Supplies/Services Required to Meet the Agency Needs:**

The Minneapolis Veterans Affairs Medical Center currently has an urgent need for an orthopedic surgeon to provide the services as the Chief of Orthopedic Service. The Chief of Orthopedic Service is needed on a 1.0 full-time equivalent (FTE) basis from April 1, 2012 – October 1, 2012. The estimated value of the urgent contract is \$373,000.00.

**4. Statutory Authority Permitting Other than Full and Open Competition:**

The statutory authority permitting other than full and open competition is 41 U.S.C.253(c)(2) as implemented by the Federal Acquisition Regulation (FAR) Subpart 6.302-2 entitled "Unusual and Compelling Urgency."

**5. Demonstrate that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above:**

The proposed source for this action is Dr. Terence Gioe. He is currently providing the services as the Chief of Orthopedic Service under the current contract.

The urgent contract is necessary to put in place to ensure continuity of direct patient care to the veteran patients. The Chief of Orthopedic Service at the Minneapolis Veterans Affairs Medical Center insures that appropriate treatment methodology is set forth for each patient admitted to the orthopedic department, and provides patient care by seeing patients and performing medical procedures. Disruption in the services of a Chief of Orthopedic Service would cause unnecessary delays in medical services to the veteran patients. In addition, it would result in a substantial increase in costs to the Government as patients would have to be referred to other providers on a fee basis.

Therefore, Dr. Terence Gioe is the only firm capable of providing the referenced services described in section 3 above without the Minneapolis Veterans Affairs Medical Center experiencing unacceptable delays in fulfilling its requirements.

**6. Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:**

Since the current contract expires on March 31, 2011, there is not sufficient time to adequately research, evaluate, and compare other orthopedic surgeons who can provide the services of a Chief of Orthopedic Service. Evaluating and comparing surgeons requires interviews and assessments of technical qualifications by a technical team. Therefore, the proposed urgent action will be awarded to Dr. Terence Gioe, the incumbent.

**7. Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:**

The urgent contract's price will be determined fair and reasonable in accordance with FAR 15.404-2. Information on market prices, historical contract pricing, and market conditions will be utilized. The Independent Government Cost Estimate, which would be based on salary information from the Association of American Medical Colleges, will also be utilized.






