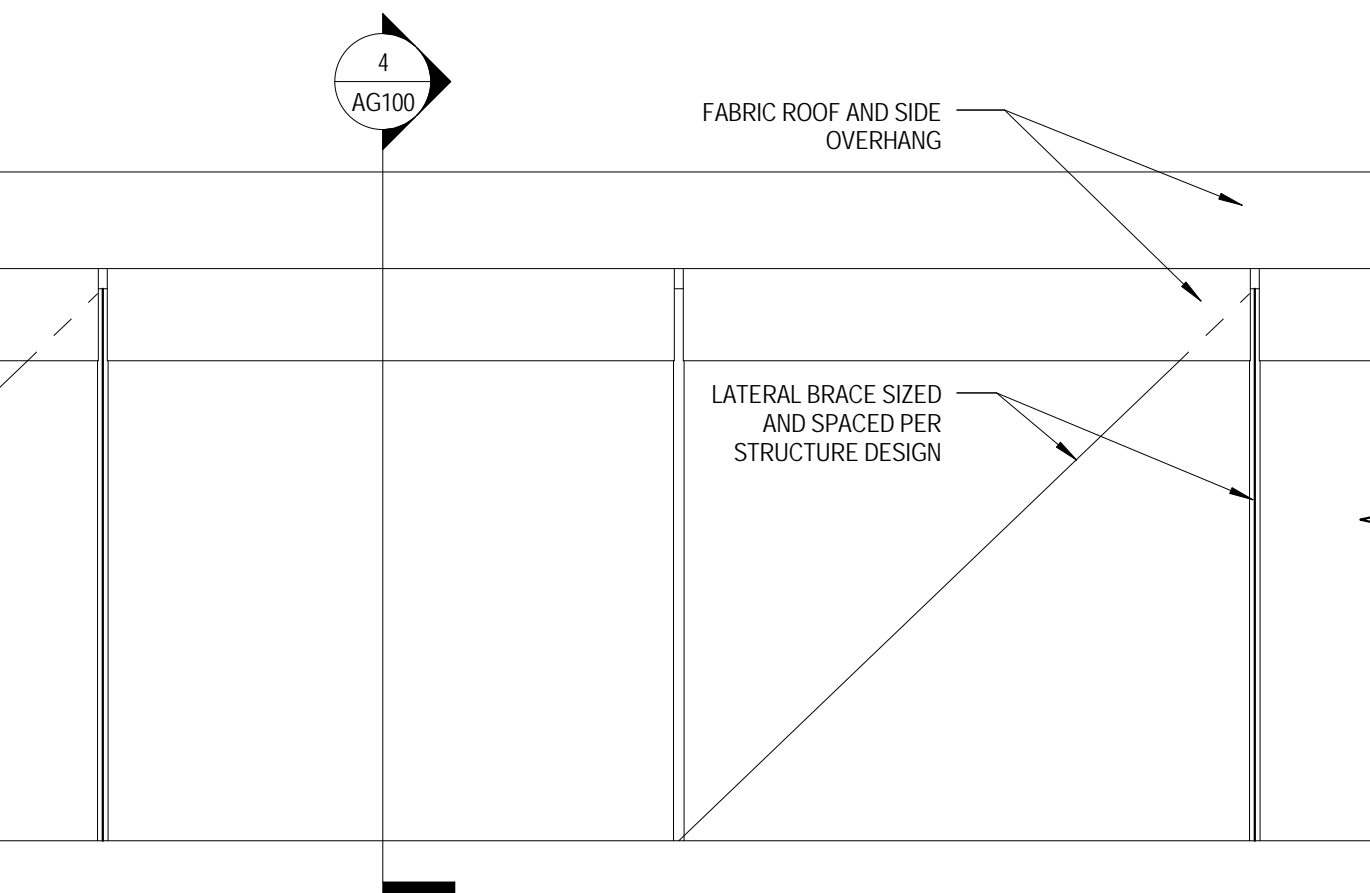
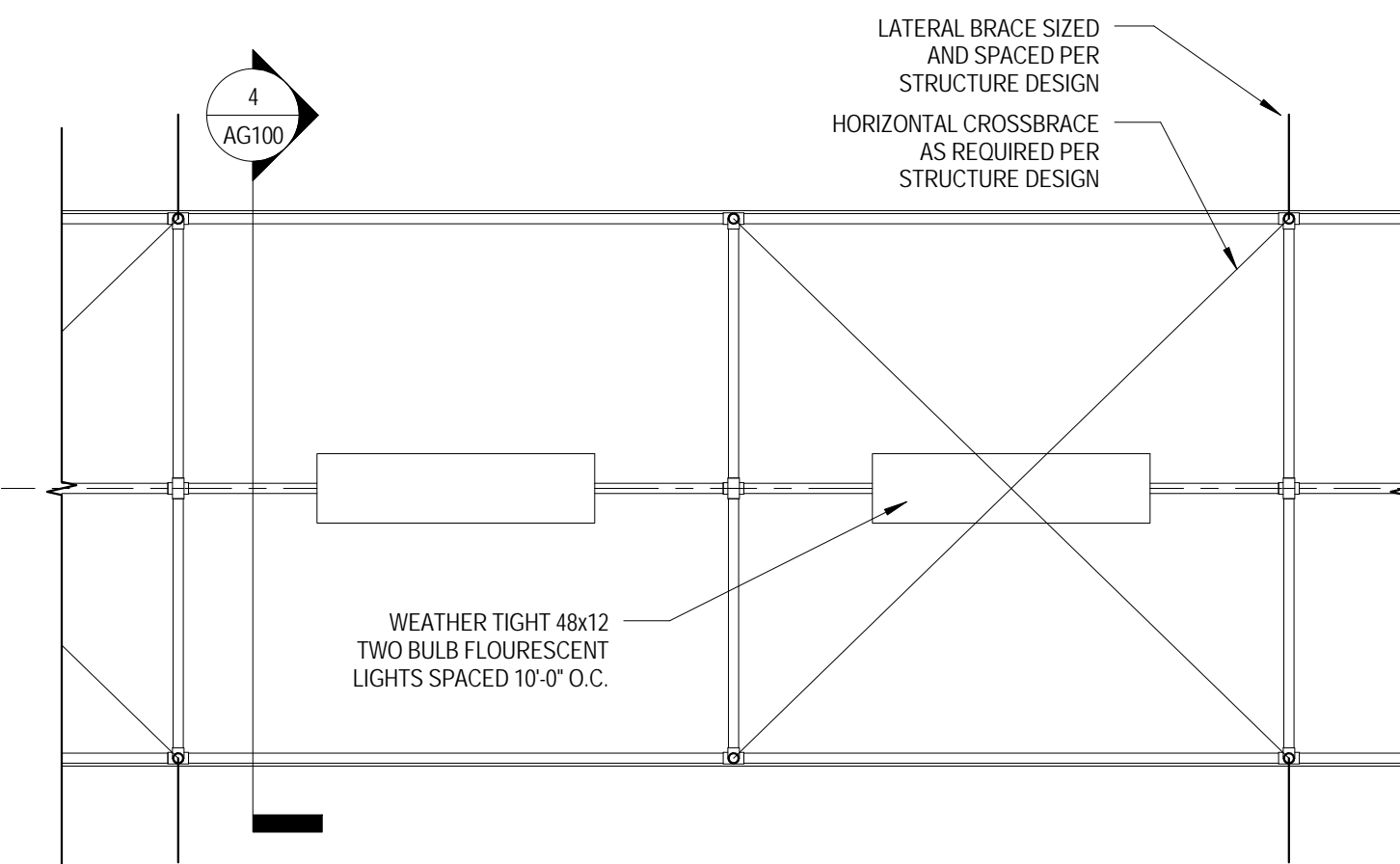


CONSTRUCTION PHASE NOTES:

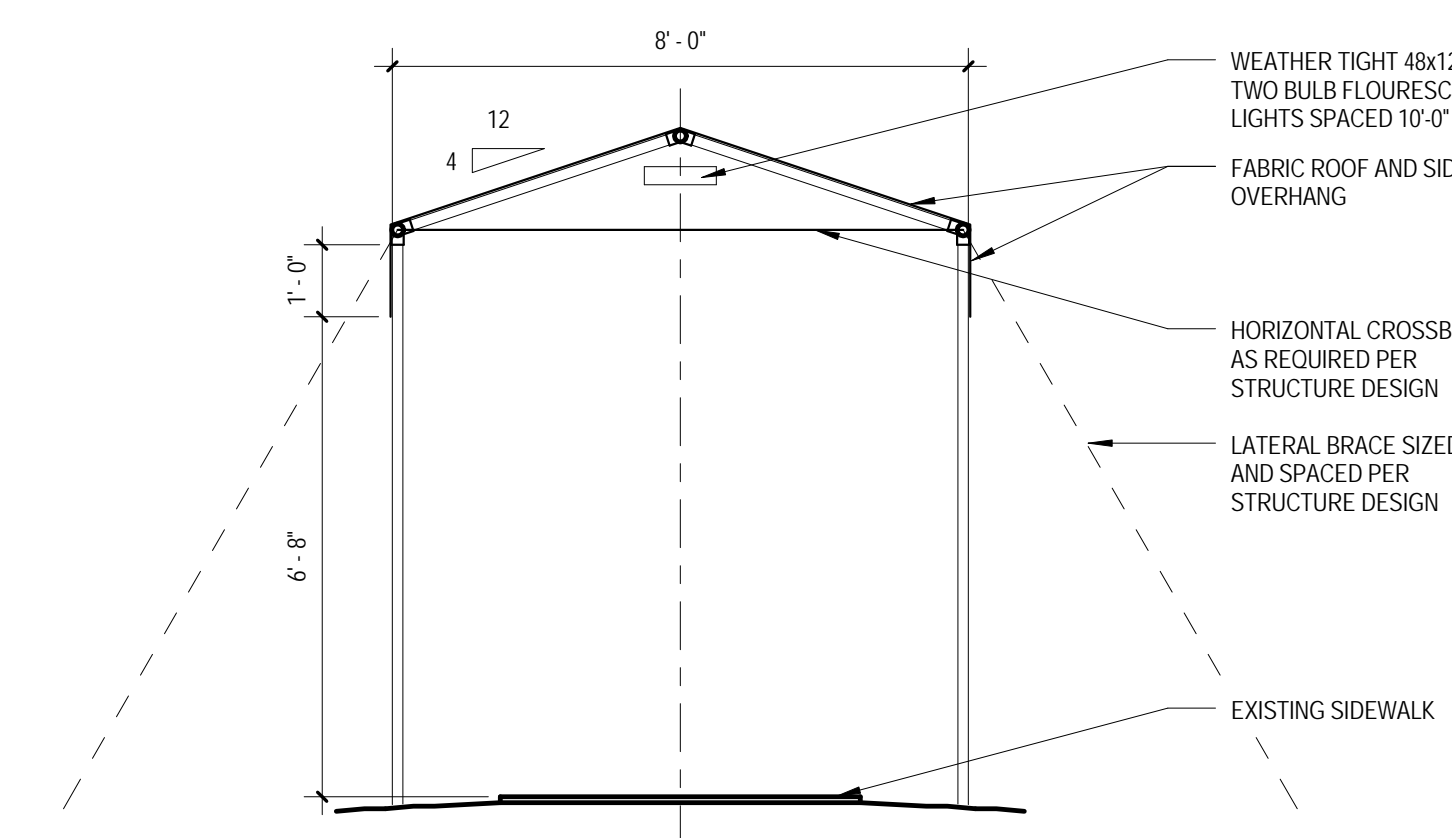
1. PRIOR TO START OF INTERIOR RENOVATIONS, GENERAL CONTRACTOR TO PROVIDE APPROXIMATELY 500LF OF TEMPORARY COVERED WALKWAY IN LOCATIONS SHOWN ON PLAN. WHEN OWNER OCCUPIES RENOVATED SPACE, CONTRACTOR SHALL REMOVE WALKWAY, COVER, AND SUPPORTING CONSTRUCTION AND RESTORE GROUNDS TO SAME CONDITIONS FOUND AT INSTALLATION. REFER TO DETAILS IN THIS PAGE FOR GENERAL CONFIGURATION AND DIMENSIONS OF WALKWAY AND COVER. STRUCTURE AND COVERING SHALL BE DESIGNED BY A PROFESSIONAL ENGINEER LICENSED TO PRACTICE IN THE STATE OF WEST VIRGINIA TO WITHSTAND WIND LOADS UP TO 100mph. PRIOR TO INSTALLATION, CONTRACTOR SHALL SUBMIT FOR APPROVAL DESIGN DETAILS, SAMPLE OF CANOPY MATERIAL FOR COLOR SELECTION BY OWNER, AND CALCULATIONS SIGNED AND SEALED BY THE ENGINEER.
2. GENERAL CONTRACTOR SHALL VERIFY LOCATION AND CONDITION OF EXISTING ENTRANCE DOORS. REMOVE ANY PANIC HARDWARE AND EXIT SIGNS AND PROVIDE AUTOMATIC DOOR OPERATOR. CONTRACTOR TO RESTORE DOORS AND SIGNAGE TO SAME CONDITIONS FOUND AT START OF CONSTRUCTION.
3. PROVIDE OPENING FOR TEMPORARY ACCESS DOOR WITH AUTOMATIC DOOR OPERATOR.
4. CONTRACTOR SHALL MODIFY EXISTING CURB TO ACCOMMODATE AN ABAAS COMPLIANT HANDICAP ACCESS RAMP. RESTORE CURB AND GROUNDS TO SAME CONDITIONS FOUND AT START OF CONSTRUCTION AFTER COVERED WALKWAY IS REMOVED.
