Questions and Answers Set #3


1. There are two different carpet types called out. One in the RFI clarifications (Interface, page 3, item 8) and one in the new statement of work (Bolyu, Scope, item o) of Amendment A00003. Please clarify.

Mill: Bolyu; Style: Flourish carpet tile; Color: Outdoor Hobby. The cove base and paint shall match existing.

2. Please clarify response 14c in Amendment A00003. Can you provide an estimated square footage? How are contractors supposed to propose on an unknown? Given (drywall around these supply air registers) areas are not to exceed 100sq ft without prior approval of the CO.
3. The new SOW does not mention acoustical tiles, please clarify. If needed existing tiles will be replaced by the using agency (OVAMC)
4. At one of the site visits the VA said that they would provide the mechanical prints so we can estimate the amount of ductwork there is. If you don't include mechanical drawings there is no way for any company to give you a true estimate on how long it will take to perform.
Please see attached Mechanical Drawings.
5. In reference to the Q&A responses provided in Amendment #4, question #4 where the question was asked "What is the scope for cleaning the AHU?" The response was given to clean "all ductwork leading up to AHU 14."
 - a. Will the VA provide a layout of the ductwork associated with AHU#14 so that we can properly price this requirement? Mechanical Drawings already provided
 - b. In a previous RFI response, the requirement was to include cleaning of the air handling unit (#14). Is this still the requirement? NO

6. In reference to the Q&A responses provided in Amendment #4, question #14c where the question was asked “If the drywall around these supply air registers is removed, the entire ceiling cavity will become exposed and the fire-resistant spray foam on the underside of the deck above would need to be abated and re-applied as it would be impossible to clean the spray foam. Is this the intent of the SOW; please clarify?” The response was given “YES”.
- a. The requirement is to remove drywall around 4’ x 6” supply air duct in all the rooms with visible mold. Mold was not visible at the supply air registers during the time of the site visits. Will the VA concur with this statement? **YES**
 - b. If mold becomes visible at the time of contract, please concur that this would be considered a “change in conditions”? **YES**
 - c. We respectfully request that this requirement (remove drywall around 4’ x 6” supply air duct in all the rooms with visible mold) be removed from the SOW as:
 - i. Mold was not visible at the supply registers during the site visit.
 - ii. The scope and cost to clean and abate the ceiling cavity would far exceed the cost of the remaining work defined in the SOW.

Will the VA remove this requirement from the SOW? **NO**




DRAWING NOTES

- 1 QUENCH VENT PIPE FROM MRI SYSTEM TO TERMINATE ON ROOF WITH GOOSE NECK. QUENCH VENT PIPE SHALL BE ALL WELDED 18 GAGE STAINLESS STEEL DUCT. SEE SPECIFICATION SECTION 23071 FOR INSULATION REQUIREMENTS AND REFER TO PHILPES 50 (M&C) 01 FOR QUENCH PIPE AND VENT HEIGHT REQUIREMENTS.
- 2 18"x4" EXHAUST DUCT TO TERMINATE ON ROOF WITH GOOSE NECK. PROVIDE BIRD SCREEN AT THE DUCT OPENING.
- 3 CONNECT ROUND 12" EXHAUST DUCT TO HOOD.
- 4 12" URDN.
- 5 24"X6" RELIEF DUCT WITH BACKDRAFT DAMPER. PROVIDE GOOSENECK WITH INSECT/BIRD SCREEN.
- 6 CONNECT 1" EXHAUST/1500 CFM DUCT TO GROSSING STATION.
- 7 PROVIDE SCREEN AT QUENCH VENT TERMINATION. SCREEN SHALL BE 18"X18" 1/4" THICK GALVANNEAL. SCREEN SHALL BE FLARE OPEN TO 18".
- 8 EXIT OUTLET SHALL BE FLARE OPEN TO 18".
- 9 EXIT OUTLET SHALL BE FLARE OPEN TO 12".
