#	Question	Answer
1.	The walk-in box dimensions are larger than the room dimensions.	Custom walk-in refrigerator that is to be placed in a room with dimensions of 12' wide x 25' long x 8'9" high. Walk-in Cooler Exterior Dimensions: 15'-5" Length x 10'-1 3/4" Width x 8'6" Height, cannot be greater than these dimensions.
2.	There is no information on the refrigeration system; Is it indoor or outdoor? How long is the pipe run?	Refrigeration system should be rated for outdoor locations. Pipe run is approximately forty feet.
3.	How close can we unload the materials for the cooling unit?	The outside condensing units can be unloaded within 10 feet of where they will be placed. There is a loading dock near the lab to unload the cabinet and inside parts.
4.	Are there any limitations for bringing the materials into the room? Sharp turns? Narrow Hallways? Elevators?	No sharp turns, no narrow hallways. There is a big overhead door at the loading dock, when you go through the door there is an elevator. Weight limit is 5000 lbs.
5.	. What are the limitations for opening the door of the cooling unit in the room?	No limitations. This is an open room and nothing will be in the way of the door.
6.	Will the VA provide power for the cooling	Power is available. Vendor will be responsible
