3. Question: “We would like to request you change the requirements for billing/usage to 100% of the inventory for garments (Scrub Tops & Bottoms). This is the way we process billing and will alleviate any A/R issues in the future with this solicitation. The best way to do this is take the inventory # that was giving to you and use that as opposed to just using the weekly amount. For example if you have 1 employee that works 5 days a week you will need to use 11 sets of uniforms. An employee that works 3 days a week you will need 7 sets of uniforms. Take all the employees that work for 5 days and week and multiply by 11, that is the number that should be used for “Quantity” in the Solicitation. Take the employees that will work just 3 days a week and multiply by 7 and that would be the “quantity” number.

All other items besides Scrub Tops, Scrub Bottoms, and Lab Coats are okay the way they are. The Patient Gowns, Blankets, and Sheets do not need to be changed.”

Answer: See Amendment No. 0004 for revised Price Schedule.

4. Question: “If we cannot provide these exact specifications, are we able to submit a proposal with noted adjustments. For one example – we have scrub pants but they don’t have cargo pockets.”

Answer: See Amendment No. 0004 for revised specifications for Radiology only. Your quote as submitted will be evaluated in accordance with FAR 52.212-2, Evaluation – Commercial Items, of the solicitation.

5. Question: “Is the previous award amount for the 5 year contract also available on FBO.gov, or is that something you are able to share?”

Answer: The previous contracts were awarded separately and each for a one-year period. The contract amounts were \$6,654.96 for Radiology and \$11,748.00 for Dental.

6. Revise the SOW, paragraph 4.3.6 in its entirety as follows:

“4.3.6 Scrub Pants, Unisex with or without Cargo Pocket (Radiology): 100% synthetic fabric, anti-microbial finish, moisture-wicking draw cord closure with easy glide webbing, with or without cargo pocket on right leg, non-reversible. Color: Ceil Blue”
