SUBJECT: JUSTIFICATION FOR OTHER THAN FULL AND OPEN COMPETITION,
ALLEGHENY PRIVATE CEMETERY SOLDIERS' LOT GROUNDS MAINTENANCE
SERVICES

1. The Department of Veterans Affairs (VA), National Cemetery Administration (NCA), Contract Service, has a Sole Source requirement for cemetery maintenance services at Allegheny Private Cemetery, Soldiers' Lot for the period of one base year, plus four, one-year option periods. The total cost of this acquisition is less than Simplified Acquisition Threshold and has an estimated cost not to exceed \$42,000.00. This requirement, which is being solicited, represents commercial services which are available to the general public and are not unique and/or exclusively for governmental purposes. There is no cost associated with modifying or tailoring the supplies to meet the government's needs.
2. Applicable statutory requirement: 41 U.S.C. 3304(a)(1) Use of noncompetitive procedures
3. In accordance with FAR Part 6.302-1(b)(1) Full and open competition need not be provided for when there is a reasonable basis to conclude that the agency's minimum needs can only be satisfied by unique supplies or services available from only one source or only one supplier with unique capabilities.
4. The requirement to be fulfilled by the vendor authorized by the private cemetery's owner, Allegheny Cemetery's staff (enclosure 1).
5. The proposed price of the services, once received by Allegheny Cemetery, will be evaluated for fairness and reasonability. Historically, Allegheny Cemetery provided the same services required under this procurement for a fair and reasonable price.
6. Market research was conducted in accordance with FAR Part 10 (enclosure 2). However, the services required are to be performed on a private cemetery, to wit, the vendor utilized is at the discretion of the cemetery operator.

This requirement will be not be solicited as required by FAR Subpart 5.2 due to the exception provided by FAR Subsection 5.202(a)(6).

7. The Contracting Officer has determined it is in the best interest of the Government for this acquisition to be awarded to Allegheny Cemetery, owner and operator of the cemetery in which Soldiers' Lot is located. With consideration to the VA's Soldiers' Lot being located within Allegheny Cemetery; and the land being donated to the Government with the understanding that the Soldiers' Lot would be maintained by the private cemetery – services are considered available only from Allegheny Cemetery, it is the Contract Officer's determination that there are no alternatives to fulfilling the agency's requirements and not awarding the solicitation to the authorized vendor would result in nonperformance or acting contrary to what is permissible to Allegheny Cemetery.
