STATEMENT OF WORK

Bariatric Beds for the
Charles George VA Medical Center
13 February 2017

1.0 Summary of Requirement

Charles George VA Medical Center is seeking to rent specialty beds to prevent interruption to patient care. The specialty beds are needed for Safe Patient Handling, Bariatric Sensitivity, and Wound and Skin Care for Bariatric Patients.

2.0 Scope

The Contractor shall be required to furnish all items, to include but not limited to, project management, labor, equipment, materials, travel and any incidentals required to satisfy the requirements of this Statement of Work. The Contractor shall also be responsible for timely delivery, training, and site deployment to ensure the successful completion of the tasks as outlined in this Statement of Work.

3.0 Description of Work

The Contractor shall be required to furnish all items, to include but not limited to, project management, labor, equipment, materials, travel and any incidentals required to provide adhoc bed rental supply/delivery services the Charles George VAMC. The contractor shall provide, on an as needed basis, bariatric beds with integrated low air loss support surfaces

The Contractor shall be required to provide delivery of bariatric beds within twelve (12) hours from the time of request by the authorized individuals identified in Section 6.0 below. The Contractor shall be required to remove rental equipment within twelve (12) hours of from the time of request by the authorized individuals identified in Section 6.0 below. The Contractor shall also be responsible for providing the identified POC's with a written confirmation via email acknowledging pickup and delivery requests within one (1) hour of coordination.

3.1 System Requirements:

At a minimum the offered equipment shall possess the following characteristics to meet the Minimum needs of the Government:

3.1.1 Bariatric Beds

Model: Compella Bed Features "Or equal"

Fully electric bed, integrated low air loss support surface with bed frame, support surface powered width expansion up to 50 inches without use of bolsters or removable parts, support surface remains inflated with transport, weight support up to 1000 pounds, bed length is adjustable without use of bolsters or removable parts, CPR function/quick release, integrated bed scale, turn-assist feature, side rails conform to FDA entrapment standards for all zones, bed controls integrated into the side rail(s) or contained within a separate hand pendant, lighted bed controls, bed exit alarms with audible alarm, bed frame has IV pole holders, bed may be transported in elevated position, bed braking system is set and released by foot control, bed has "move assist" feature not dependent on power, bed will allow lifts and other equipment beneath deck, chair position feature, head of bed angle indicator, bed will support attachment of traction equipment, battery back-up, trapeze compatible

4.0 Brand Name References

Any and all references to a brand name, model, marketing language or functionality pursuant to a particular manufacturer does not constitute a preference/desire of the Government for any one make or model over any other. The intent of the language contained herein is merely to communicate to industry as to the minimum needs of the Government in the most efficient means possible and does not represent the Governments preference.

5.0 Brand Name “or Equal” Submission Instructions

For consideration and evaluation of technical acceptability of any product proposed as an “or Equal”, the Offeror shall submit, with its offer, all technical data pertaining to the proposed as an equivalent, for consideration of technical acceptability. Offerors shall be responsible for demonstrating equivalency in a side by side comparison of technical data and shall address how each of the salient characteristics/minimum needs of the Government, as identified in this solicitation, have been met and/or exceeded. Any Offeror, failing to submit such supporting documentation, as required for an “or Equal” in accordance with this solicitation, shall not be considered. The Government will only review documentation as submitted by Offerors to determine technical acceptance and shall not be held responsible for researching any additional information beyond that information submitted by the Offeror.

6.0 Delivery/Order Authorization

The Contractor shall utilize its due diligence in ensuring that deliveries to the Charles George VAMC are coordinated by authorized individuals only. The Contractor shall only accept, process, and deliver orders under this vehicle in response to requests made by the authorized individuals identified below. Any deliveries made by the contractor from other than the individuals listed below are done so at risk of not being reimbursed by the government. The contractor shall specify in their response as to how deliveries shall be coordinated with by the individuals specified below.

7.0 Identification, Parking, Smoking, and VA Regulations:

The Contractor shall wear visible identification at all times while on the premises of Charles George VAMC. It is the responsibility of the Contractor to park in the appropriate designated parking areas. Information on parking is available from the VA Police Service. The VAMC will not invalidate or make reimbursement for parking violations of the Contractor under any conditions. Smoking is prohibited inside any buildings at the VAMC and only permitted in designated smoking shelters on the VA campus. Possession of weapons is prohibited. Enclosed containers, including tool kits, shall be subject to search. Violations of VA regulations may result in citation answerable in the United States (Federal) District Court, not a local district, state, or municipal court.

8.0 Protection Of Existing Structures, Equipment, And Utilities:

The Contractor shall preserve and protect all structures and equipment on or adjacent to the work site. The contractor shall replace at his own expense damage to such items to the satisfaction of the Contracting Officer.

Contractor shall take all measures and provide all materials necessary for protecting and preserving existing equipment and property in affected areas of installation against dust, debris and physical damage, so that equipment and affected areas to be used in Medical Center operations will not be hindered. Contractor shall permit access to VA personnel through installation areas as required for maintenance and normal Medical Center operations.

9.0 Performance And Maintenance:

- 9.1 Charles George VA Medical Center Personnel shall check the serviceability of each specialty bed and mattress upon delivery. All items delivered shall be clean, sanitized, and ready for immediate patient use in accordance with Joint Commission on Accreditation of Healthcare Standards (JCAHO). The Contractor shall be responsible for the serviceability and any associated maintenance of the specialty beds and mattresses supplied to the Charles George VA Medical Center for any and all deliverables under this contract. If a specialty bed or mattress is deemed unserviceable by the Government, the contractor shall repair and/or replace the unserviceable specialty bed(s) within twenty-four (24) hours of notification. Following any repairs and/or replacement, the contractor shall ensure that the item is restored to a clean, sanitized, and ready for immediate patient use in accordance with Joint Commission on Accreditation of Healthcare Standards (JCAHO).

10.0 Privacy/Security

These Beds/Mattresses contain no PHI. The contractor will not have electronic connectivity to the devices and will not have access to patient databases with PHI present. Contractor will not include any patient information on invoices submitted to the Department of Veterans Affairs or to the Invoice Payment Processing System (IPPS).

(d) The small business size standard for a Contractor providing a product which it does not manufacture itself, for a contract other than a construction or service contract, is 500 employees.

(e) Except as provided in paragraph (g) of this clause, the Contractor shall make the representation required by paragraph (b) of this clause by validating or updating all its representations in the Representations and Certifications section of the System for Award Management (SAM) and its other data in SAM, as necessary, to ensure that they reflect the Contractor's current status. The Contractor shall

notify the contracting office in writing within the timeframes specified in paragraph (b) of this clause that the data have been validated or updated, and provide the date of the validation or update.

(f) If the Contractor represented that it was other than a small business concern prior to award of this contract, the Contractor may, but is not required to, take the actions required by paragraphs (e) or (g) of this clause.

(g) If the Contractor does not have representations and certifications in SAM, or does not have a representation in SAM for the NAICS code applicable to this contract, the Contractor is required to complete the following rerepresentation and submit it to the contracting office, along with the contract number and the date on which the rerepresentation was completed:

Offers will be initially reviewed for compliance all terms and conditions required by the solicitation, to include but not limited, the requirements established within the SOW and/or terms and conditions that establish minimum offer submission requirements. Offers that comply with all terms of the solicitation will then move forward to the next step as detailed below. - (i) The Occupational Safety and Health Act of 1970; and
- (ii) OSHA-approved State Plans;

(3) Department of Labor Office of Federal Contract Compliance Programs (OFCCP) for—

- (i) Section 503 of the Rehabilitation Act of 1973;
- (ii) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974; and

- (iii) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity);
- (4) National Labor Relations Board (NLRB) for the National Labor Relations Act; and
- (5) Equal Employment Opportunity Commission (EEOC) for—
 - (i) Title VII of the Civil Rights Act of 1964;
 - (ii) The Americans with Disabilities Act of 1990;
 - (iii) The Age Discrimination in Employment Act of 1967; and

Forced or indentured child labor means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(9) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974.

(10) The Family and Medical Leave Act.

(11) Title VII of the Civil Rights Act of 1964.

(12) The Americans with Disabilities Act of 1990.

(13) The Age Discrimination in Employment Act of 1967.

(14) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors).

(15) Equivalent State laws as defined in the DOL Guidance. (The only equivalent State laws implemented in the FAR are OSHA-approved State Plans, which can be found at www.osha.gov/dcsp/osp/approved_state_plans.html).

Labor law decision means an administrative merits determination, arbitral award or decision, or civil judgment, which resulted from a violation of one or more of the laws listed in the definition of “labor laws”.

Manufactured end product means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;

- (5) PSC 9410, Crude Grades of Plant Materials;

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub.
