

Response to RFI's & Scope of Work Clarifications

VA69D-17-B-0432 IT Deficiencies

SCOPE OF WORK CLARIFICATIONS

1. The Sump pumps for the Water Intrusion Scope shall be installed on the Vault floor and no sump pit shall be constructed in the Telephone Comm Vault.
2. On the Water Intrusion Portion of the Work, The Contractor shall select one of the following two options in regards to the telephone splice wire waterproofing. (about 8,500 pairs).
 - 1.1 Install waterproof enclosing can for each splice bundle. Typical vendors are:
 - a. Armadillo Stainless steel Casing
 - b. REDDI Seal Splice Case
 - 1.2 Run new telephone cables from the Protection Block to MDF (about 10 feet). Amphenol connection to MDF and wire wrap connection on Projection Block. (After work or weekend activities to allow the system down-time)
3. On the Climate Control Unit (replacement for Liebert Units in Building 32) , the unit must meet the ASHRAE (90.1-2013) requirement IEER of 12.4.

B. Invoicing

Contractor is to assign a weighted percentage on milestones on the Critical Path Method Schedule developed by the CONTRACTOR and approved by COR.

1% of the Total Contract withholding per invoice period.

0.25% of the Total Contract for each outstanding CDR (Const. Discrepancy Report)

VA Payment = invoice- withholding – CDR penalties

All the withholding would be paid upon the turning over the Project to VA.
