Addendum to FAR 52.212-1 Instructions to Offerors – Commercial Items:

Questions, with the Government's responses, will be posted to the Government Point of Entry (GPE) FEDBIZOPPS ([www.fbo.gov](http://www.fbo.gov)). Please be advised that the Government reserves the right to transmit those questions and responses of a common interest to all prospective contractors.

Price and cost schedule: Contractor shall not complete the Contract Line Item Numbers (CLINs) annotated "separately priced". Government reserves the right to provide funding for the separately price CLINs. Funding for the CLINs will be funded at the time of the government's issuance of a task order. Government is seeking fully burden cost at the conclusion of repairs and not individual labor rates. Government reserves the right to request a cost breakdown not considered cost and pricing data to ensure prices are within stated industry and past history pricing. Contractor shall invoice based upon fully burden cost of each individual repair.

Provide the following information with your quote:

- Solicitation number
- Name and address of your company
- Point of contact; name, e-mail and phone number
- DUNS number and CAGE CODE
- Price and any discount terms
- Contractor's certifications to repair equipment and ability to obtain (non-grey market) parts.
- Representations and Certifications at FAR 52.212-3. Complete only paragraphs (b) of this provision if the vendor has completed the annual representations and certificates electronically via the System for Award Management (SAM) website. If a vendor has not completed the annual representations and certifications electronically at the SAM website, the vendor shall complete only paragraphs (c) through (o) of this provision.
