Environmentally Controlled Space to Store Reusable Medical Equipment (RME)

A. GENERAL INFORMATION

1. Title of Project: Sterile temp controlled storage unit
2. Type of Contract Contemplated: Firm Fixed Price

B. SCOPE

The purchase of this storage cabinet will allow Sterile Processing Service (SPS) to store RME at satellite locations, i.e. Podiatry, Derm Surg., while storing the RME in appropriate environmental conditions as stipulated by the National Program Office for Sterile Processing (NPOSP).

C. REQUIREMENT/SALIENT CHARACTERISTICS/SPECIFICATIONS:

The cabinet is a self-contained environment that maintains temperature, humidity, and the required number of air exchanges. The cabinet is portable with an uninterruptible power supply (UPS), the cabinet runs on a common 110v power from the wall. The cabinet can fit through typical 36 inch doors found in most clinical areas. Therefore the cabinet can be moved at will with no considerations to construction, lease agreements, major impacts on clinical space, and no interruption to patient care.
