STATEMENT OF WORK/TECHNICAL SPECIFICATION

Surgical Microscope

Scope: A Surgical microscope is intended for the illumination and magnification of the surgical area and for the support of visualization in surgical procedures for both the anterior segment of the eye.

Salient Characteristics: for Ophthalmic procedures

- apochromatic optics
- two independently programmable handgrips from which key system functions can be accessed by the surgeon intra-operatively.
- multi- function programmable footswitch which can be used tethered to the system or wirelessly, enabling hands-free access to key system functions.
- motorized zoom & focus adjustment that can be controlled from the programmable handgrips or the foot control panel.
- electronically adjustable depth-of-field that can be activated from the programmable handgrips or the foot control panel
- integrated beam-splitter for an assistant scope that can be rotated to enable left-side or right-side stereo co-observation without disassembling co-observer.
- integrated assistant's microscope with motorized zoom and focus that can be configured to be linked or adjusted independently of the main observer.
- non-contact fundus viewing system with sterilizable (and thus reusable vs. single use) aspheric lens options to enable customization based on surgeon preference of magnification, field-of-view and depth-of-field.
- binocular tube with motorized inverters and a non-contact fundus viewing system, the surgical microscope can be configured such that activation of the fundus viewing system automatically results in activation of the inverters and any affiliated user profile settings (light intensity, starting zoom and focus values, etc.) to speed transitioning between microscope setups optimal for anterior and posterior segment visualization.
- option of 100W or 180W Xenon illumination
- Brightness of the illumination can be controlled from the programmable handgrips or the foot control panel.
- backup light source of equal power to the primary light source in case of the first illuminator reaches end-of-life.
- retinal protection (blue barrier) filter
- Halogen Mode filter that mimics halogen-like characteristics.
- touchscreen central user interface from which all system functions, programming and operations are accessible.
- programming of at least 20 unique user profiles, each with its own set of preference parameters including initial light intensity, working distance and focus & zoom speeds.
- must have a manual mode which ensures that a surgical procedure can be completed in the event of failure or malfunction of the motorized functions such as zoom or focus.
- microscope enables the main surgeon to see the most important system parameters, such as working distance and light intensity without leaving his/her surgical position via an overhead display system.
- electromagnetic clutches for all system axes

- XY drive that enables motorized positioning of the microscope head in the XY plane.
- integrated 3CCD SD or, optionally, a 1080p HD video camera.
- an optional integrated video recording device for the capturing of still images and SD or 1080p video on a USB storage medium with ability to control all video functions from the central, touchscreen user interface.
- integrated high resolution monitor of 17" in diameter or larger.
- integrated keratoscope to enable visualization of corneal astigmatism.
- integrated slit illuminator with selectable slit widths of 0.2mm, 2mm, 3mm and 4mm which can be controlled from the programmable handgrips or foot control panel.
- dual-illumination setup that enables the connection of an external motorized slit lamp.

(d) Unless the offeror clearly indicates in its offer that the product being offered is an "equal" product, the offeror shall provide the brand name product referenced in the solicitation.

Manufactured end product means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

(2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;

(3) Consist of providing goods or services to marginalized populations of Sudan;

(4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;

(5) Consist of providing goods or services that are used only to promote health or education; or

(6) Have been voluntarily suspended.

“Sensitive technology”—

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

Service-disabled veteran-owned small business concern—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

Small business concern means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

Small disadvantaged business concern, consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that—

Successor means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

Veteran-owned small business concern means a small business concern—

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(1) That is at least 51 percent owned by one or more women; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and

(2) Whose management and daily business operations are controlled by one or more women.

Women-owned small business (WOSB) concern eligible under the WOSB Program (in accordance with 13 CFR part 127), means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.

Note to paragraph (a): By a court order issued on October 24, 2016, the following definitions in this paragraph (a) are enjoined indefinitely as of the date of the order: “Administrative merits determination”, “Arbitral award or decision”, paragraph (2) of “Civil judgment”, “DOL Guidance”, “Enforcement agency”, “Labor compliance agreement”, “Labor laws”, and “Labor law decision”. The enjoined definitions will become effective immediately if the court terminates the injunction. At that time, DoD, GSA, and NASA will publish a document in the **Federal Register** advising the public of the termination of the injunction.
