

ATTACHMENT A: Medical/Surgical Prime Vendor (MSPV-NG) Distribution Program

In a partnering effort between Veterans Health Administration (VHA) and the Office of Acquisition and Logistics (OAL), VA implemented a national medical/surgical prime vendor-next generation program. The program is mandatory for all VA medical centers and consists of four prime vendor contracts. The prime vendor contracts include one base period and two option periods for a total of five years of service from 2016 through 2021. Product prices are primarily established by the Federal Supply Schedule Program (FSS), VA National Standardization Program, Veterans Integrated Service Network (VISN) and/or local contracts.

The Contracting Officer (CO) will ensure that the items offered on your BPA are published (i.e. made available) to all VA ordering activities on or before the start of period of performance. The CO is also notifying all BPA holders of the NG-MSPV awarded contracts so that you may begin entering into agreements accordingly.
