B.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes Federal Acquisition Regulation (FAR) clause 52.219-14. Accordingly, any Blanket Purchase Agreement (BPA) resulting from this solicitation will include this clause. The **BPA holder** is advised in performing BPA administration functions, the CO may use the services of a support **BPA holder(s)** retained by VA to

assist in assessing the **BPA holder's** compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support **BPA holder(s)** may require access to **BPA holder's** offices where the **BPA holder's** business records or other proprietary data are retained and to review such business records regarding the **BPA holder's** compliance with this requirement. All support **BPA holders** conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the **BPA holder's** business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the **BPA holder** for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. Furthermore, if VA determines any services the support **BPA holder(s)** will perform in assessing compliance are advisory and assistance services as defined in FAR 2.101, Definitions, the support **BPA holder(s)** must also enter into an agreement with the **BPA holder** to protect proprietary information as required by FAR 9.505-4, obtaining access to proprietary information, paragraph (b). The **BPA holder** is required to cooperate fully and make available any records as may be required to enable the CO to assess the **BPA holder's** compliance with the limitations on subcontracting or percentage of work performance requirement.

B.3 PRODUCT DESCRIPTION

1.0 INTRODUCTION

1.1 The Department of Veterans Affairs (VA) requires contracted support for the acquisition of consumable commodities in support of the Medical/Surgical Prime Vendor (MSPV) Program and Formulary (hereafter referred to as the "MSPV formulary"). The MSPV Program and Formulary is a partnering effort between the (VA Veterans Health Administration (VHA) and the VA Office of Acquisition, Logistics and Construction (OALC).

1.2 The intent of this acquisition is to streamline procurements of Medical, Surgical, Dental, Prosthetics, Laboratory (Lab) and Environmental Medical Supplies (EMS) and consumable commodities purchased in support of the MSPV Program. The contracted support is needed to build and support the MSPV Formulary.

1.3 Items are currently added to the MSPV Formulary through the execution of Blanket Purchase Agreements (BPA) whose items are added to the MSPV Formulary that are ordered through the current regional MSPV Vendors. As the MSPV Program is a key element in VHA's integrated supply chain initiative that is designed to significantly improve efficiency in obtaining items. It is important that the manner in which items are added to the MSPV Formulary is also efficient and accurate. Current processes for the establishment of BPAs in support of the MSPV Program have been problematic in terms of effectiveness, timeliness, and overall benefit. The proposed approach is meant to streamline the establishment of BPAs by simplifying the process of product selection, solicitation, evaluation, and award.

1.4 The VHA Prosthetic and Sensory Aid Service (PSAS) has identified Fisher and Paykel Positive Airway Pressure (PAP) Devices and Accessories for in home use.

2.0 OVERVIEW MSPV

2.1 VA desires to establish single-award BPA's for various consumable commodities at prices lower than best commercial customer pricing.

2.2 The purpose of these BPA's requirement is to standardize the purchase of commodities across the VA healthcare system and secure the availability and consistency of volume based pricing and products through a nationally standardized source.

2.3 The MSPV Program is a national Program that provides a customized distribution system that meets or exceeds facility requirements by providing efficient and cost-effective just-in-time distribution, inventory, electronic, and Formulary ordering processes through four regional Prime Vendor contracts. The MSPV Program facilitates quick, reliable, just in time ordering, thus, increasing the efficiency and effectiveness of the day-to-day operations in the VHA system. In order for the [BPA holder](#) to participate in the MSPV Program, the [BPA holder](#) must have their products added to the MSPV Formulary for each regional Prime Vendor. Therefore, the [BPA holder](#) agrees to make the BPA item(s) available through the MSPV Formulary. The Specific terms and conditions (e.g. chargeback arrangements, payment terms) must be finalized between the [BPA holder](#) and each applicable regional Prime Vendor.

3.0 SCOPE OF WORK

3.1 The [BPA holder](#) agrees to provide uninterrupted supply of standardized items and delivery of PAP devices and accessories as specified in the agreement for distribution through the MSPV Program or directly through the [BPA holder](#) to include an alternate delivery method. [The BPA holder agrees to supply products that are Trade Agreement Act \(TAA\).](#)

3.2 Purchases by the Government of products established under the resulting BPA will be ordered by VA field offices through the MSPV Program or directly through the [BPA holder](#) and may be delivered using the alternate delivery method. The orders will indicate the specific items ordered, item quantities, and all necessary delivery and payment procedures.

4.0 PERFORMANCE

4.1 The BPA ordering period is 1-year with a 1-year option period that may be exercised by the Government upon annual review.

4.2 Orders issued under this agreement will be on a firm-fixed price. The [BPA holder](#) agrees to provide the equipment, supplies and resources necessary to accomplish the requirements described in this agreement.

5.0 REQUIREMENTS

5.1 See Attachment B– Excel Price/Cost Schedule for the list of Fisher & Paykel PAP supplies and salient characteristics required under this agreement.

6.0 INFORMATION SECURITY CONSIDERATIONS

6.1 The Certification and Accreditation (C&A) requirements do not apply and a Security Accreditation Package is not required (See VA6500).

7.0 PRODUCT REMOVAL OR RECALL

7.1 For any product awarded under this agreement removed or recalled by the [manufacturer](#) due to defects in the product or potential dangers to patients, or if any required removal or recall is suggested or mandated by a regulatory or official agency, the [BPA holder](#) or manufacturer agrees to take following steps immediately:

7.2 Notify the Contracting Officer (CO) at the Strategic Acquisition Center in writing, by the most expeditious manner possible.

7.3 Provide copies of the notification to CO, Contracting Specialist, Contracting Officer Representative, Manager at Product Recall Office, all Agencies and VA Facilities who purchased the product, which include, but not be limited to the following:

- (1) Complete item description and/or identification, order numbers from customers and the [BPA](#) number assigned as a result of an issuance on the solicitation;
- (2) Reasons for modifications, removal or recall; and
- (3) Necessary instructions for return for credit, replacement or corrective action.

8.0 EMERGING TECHNOLOGY, PRODUCT UPGRADES OR REFRESH

8.1 The **BPA holder** agrees to provide improved items within the awarded product line as appropriate new industry technologies emerge and/or products become obsolete. The revised product listing will be submitted in writing to the CO and COR.

8.2 Further, the **BPA holder** agrees to ensure that all PAPs devices and accessories offered are state-of-the-art. "State-of-the-art" is defined as the most recently designed components approved by the U.S. Food and Drug Agency (FDA) and are announced for marketing purposes. All improved or enhanced products will be provided with the **manufacturer's** commercial warranty.

8.3 The **BPA holder** agrees to ensure that all new products are approved in accordance with the pre-market notification under the U.S. Food and Drug Administration (FDA) 510K process and labeled appropriately for prosthetic appliances.

8.4 The **BPA holder** agrees to provide the CO the following information:

- (1) A list of specific awarded items to be updated or/and added in the Attachment B – Excel Price/Cost Schedule;
- (2) Product literature for the new items and a detailed description of the differences or benefits of the new items and/or awarded items
- (3) Specific analysis of the comparative advantages/disadvantages of the items involved to be updated; and
- (4) Proper identification of any new product requirements and/or procedures related to those new products.
- (5) FDA approval, if required.

8.5 The CO will provide the information to the Program Office for recommendation of approval to add to BPA. Upon approval, the **BPA** will be modified to acknowledge the updated items and/or new items. The Government reserves the right to not accept the new products. **The BPA holder agrees to continue to supply the item(s) as originally identified.**

8.6 The **BPA holder** agree to offer to Government at a discounted price any new products replacing awarded items, or product lines released to the market during the period of performance.

B.5 BPA TERMS AND CONDITIONS

1.0 The [BPA holder](#) agrees to provide the BPA established item(s) to satisfy the Governments requirement when an order is placed during the effective period of the established agreement. Ordering availability will be made available through the MSPV program or directly with the [BPA holder](#).

1.1 The [BPA holder](#) is encouraged to provide discounts and price reductions to its pricing. The [BPA holder](#) agrees to supply the BPA items whenever an order is placed under the BPA for the life of resulting BPA.

2.0 CANCELLATION

2.1 VA is required to review this BPA on an annual basis. At any time during the term of the agreement, the Government or [BPA holder](#) may cancel this agreement by providing written 90 day advance notice to the other party.

3.0 EXTENT OF OBLIGATION

3.1 The Government is obligated only to the extent of authorized purchases actually made under the resultant BPA. This BPA does not obligate any funds, nor is the Government obligated to make any purchases under this BPA.

3.2 It is anticipated that BPA will be established for a base period of -1-year with 1-year option period from the effective date of the BPA award including any extensions, whichever is earlier if applicable.

3.3 Within 90 calendar days of award, the [BPA holder shall establish an supplier agreement with each Prime Vendor in order to add their products to the supply chain.](#)

4.0 SOURCE OF SUPPLY AND ALTERNATE SUPPLY SUBSTITUTION

4.1 If the [BPA holder source of supply \(original equipment manufacturer\)](#) determines to terminate production of the selected item and contemplates replacement with alternative item, the Government reserves the right to evaluate the potential replacement item(s). There is no guarantee that the Government will evaluate any replacement item(s)

favorably. If the Government determines the replacement item(s) as unacceptable, the individual item(s) or the entire BPA may be cancelled.

4.1 By establishing this BPA, the [BPA holder](#) agrees to supply established item(s) to satisfy the Government's requirement when an order is placed [with the MSPV Prime Vendors pursuant to the supplier agreement](#) or [directly with BPA holder](#) during the effective period of the BPA.

5.0 ESTIMATED VOLUME

5.1 The aggregate purchases may be less than or more than the estimated annual volume of purchases identified in the solicitation and VA makes no guarantee regarding the actual quantities that may be purchased. The Government is not obligated to make any purchases under the resultant BPA. If the Government does not achieve the estimated annual volume of purchases, the [BPA holder](#) hereby waives any right to collect the difference in price between the actual level achieved and the anticipated level.

6.0 ORDER OF PRECEDENCE

[6.1. The terms and conditions of this BPA apply to all purchases made pursuant to it. In the event of an inconsistency between the provisions of this BPA and the BPA holder's invoice, the provisions of this BPA will take precedence.](#)

7.0 ORDERING

7.1 BPA ordering will be decentralized. Orders may be placed through the MSPV program or directly with the [BPA holder](#). Ordering procedures for orders under the MSPV Program will be in accordance with the supplier agreement established between the MSPV Prime Vendor and [BPA holder](#).

7.2 All orders are placed [with](#) the Prime Vendor or directly through the [BPA holder](#) and are based on the just-in-time needs of the VA field offices throughout the life of the BPA.

7.3 Orders placed directly [with](#) the [BPA holder](#) may be made via one of the following methods: (To be identified by [BPA holder](#)).

8.0 NOTICE OF INDIVIDUALS AUTHORIZED TO PURCHASE UNDER THE BPA

[8.1 The purpose of this BPA is to establish a supplier for the MSPV Program. Orders may be placed via the MSPV Prime Vendor in accordance with the supplier agreement and between the MSPV Prime Vendor and BPA holder or directly through the BPA holder until such time as payment can be made via Electronic Data Interchange \(EDI\) or alternate delivery method. Individuals with the expressed authority to obligate the Government are authorized to place orders under this BPA.](#)

8.2 The [BPA holder](#) agrees to make this BPA available through the MSPV Prime Vendors listed in Attachment C – Medical Surgical Prime Vendors.

9.0 REPORTS

9.1 In order to track compliance, VA requires the **BPA holder** to submit the quarterly sale report (QSR) in the approved format listed in Attachment D- BPA Quarterly Sales Reporting Tool based on Government fiscal calendar year. See below:

10.0 DELIVERY REQUIREMENTS

10.1 Standard Delivery: Delivery will be made Free On Board (FOB) destination to any Veterans Affairs Medical Centers (VAMC) facility (which may include outpatient facilities) and MSPV locations nationwide within the Continental United States (CONUS) and Outside the Continental United States (OCONUS).

10.2 Alternate Delivery: To meet the needs of Veteran patients across the VA healthcare system, there may be times the local Prosthetic and Sensory Aids Service (PSAS), will require delivery to an alternate location other than through MSPV Prime Vendor.

10.3 Alternate delivery will only be used when the need arises to ship prescribed item(s) to other than the local medical center, as MSPV is structured for direct delivery to the Facilities. These alternate delivery orders will be placed directly with the **BPA holder** by a warranted Contracting Officer and/or Government Purchase Card (GPC) holder. The local PSAS office will create a delivery order, to include the address to where the item(s) are to be shipped. This order can be placed by the local VAMC in the most economical manner they deem fit (**GPC or delivery order**).

10.4 Upon the receipt of an alternate delivery order (applicable to shipping directly to Veteran):

- a. Delivery from the **BPA Holder** agrees to be FOB destination to the address indicated on the delivery order.
- b. Deliveries will be shipped using a mail tracking system to identify location and proof of delivery.
- c. Regular deliveries will be made within 7 **business** days after receipt of a delivery order and expedited delivery within 3 **business** days.
- d. The Government agrees to pay for any expedited shipping charges when such orders are required.
- e. The Government acceptance of all delivery orders will take place at the delivery point.

10.5 Alternate delivery procedures will safeguard Personally Identifiable Health Information (PHI) and **Personally Identifiable Information (PII)**. The Department of Veteran defines personally identifiable information as: *"information which can be used to distinguish or trace an individual's identity, such as their name, social security number, biometric records, etc. alone, or when combined with other personal or identifying information which is linked or linkable to a specific individual, such as date and place of birth, mother's maiden name, etc."*

10.6 Personally Identifiable Health Information: Personally Identifiable Health Information (PHI) is a subset of Health Information, including demographic information collected from an individual, that: (1) is created or received by a health care provider, health plan, or health care clearinghouse (e.g., a HIPAA-covered entity, such as VHA); (2) relates to the past, present, or future physical or mental condition of an individual, or provision of or payment for health care to an individual; and, (3) identifies the individual or where a reasonable basis exists to believe the information can be used to identify the individual. NOTE: VHA uses the term PHI to define information covered by the Privacy Act and the Title 38 confidentiality statutes in addition to HIPAA.

10.7 Personally Identifiable Information: Personally Identifiable Information (PII) is any information pertaining to an individual that is retrieved by the individual's name or other unique identifier, as well as PHI regardless of how it is retrieved. PII is a subset of personally identifiable information and is protected by the Privacy Act.

10.8 Protected Health Information: The HIPAA Privacy Rule defines Protected Health Information (PHI) as PII transmitted or maintained in any form or medium by a covered entity, such as VHA. NOTE: VHA uses the term protected health information to define information that is covered by HIPAA but, unlike PII, may or may not be covered by the Privacy Act or Title 38 confidentiality statutes. In addition, PHI excludes employment records held by VHA in its role as an employer.

10.9 Schedule for Deliverables: the following provisions apply to all shipments:

Inspection: Destination
Acceptance: Destination

10.10 Ship To and Mark For: Deliveries will be marked and shipped to various VHA locations and MSPV locations, or alternate delivery address nationwide which will be identified under each order placed against the BPA.

10.11 Special Shipping Instructions: Prior to shipping, the [BPA holder](#) agrees to notify VHA site and MSPV location point of contact by telephone and email, of all incoming deliveries including line-by-line details for review of requirements. All shipments, either single or multiple container deliveries, will bear VA's Order number on external shipping labels and associated manifests or packing lists. In the case of multiple container deliveries, a readable statement near the order number will indicate total number of containers for the complete shipment (ex. "Package 1 of 2"), clearly readable on manifests and external shipping labels.

11.0 INSPECTION AND ACCEPTANCE

11.1 All orders placed through the MSPV Program; delivery, acceptance and inspection will be in accordance with the terms of this BPA (including FAR 52.212-4 and VAAR 852.246-71), and term of the supplier agreement established with the Prime Vendor if applicable.

12.0 PERIOD OF AGREEMENT

12.1 This agreement is between the Government and the [BPA holder](#) and agrees to become effective on the date stated in Box 3 of SF 1449. This BPA expires at the end of the agreement period. [Government will conducted annually \(i.e., one year from the date of award\) to determine if it is in the Government's best interest to continue the performance period of the agreement.](#) The [BPA holder](#) agrees to establish supplier agreement with MSPV Prime Vendors within 90 calendar days after the effective date of the BPA.

12.2 The supplier agreement established between the MSPV Prime Vendor and [BPA holder](#) agrees to establish the terms and conditions of the resultant [BPA holder's](#) participation in the MSPV program.

a. Service Level Agreement Fee.

The Service Level Agreement (SLA) fee is established by the Supply Fund Board and is provided as a means of reimbursement for customary acquisition-related services necessary to obtain Contractor services and/or supplies as required. The SLA is reimbursed to the SAC based on rates established by the supply fund board and are recouped based on a percentage of total quarterly sales. The Supply Fund Board may change the percentage at any time, but typically not more than once per year. Upon a change in the SLA, the Contracting Officer (CO) shall issue a unilateral modification to

apply the change to CLIN prices based upon the SLA rate change. The SAC will provide reasonable notice prior to the effective date of the change.

In order to facilitate SLA reimbursement, offerors must include (imbed) the SLA fee into their prices; therefore, the fee will be reflected in the total amount charged and transparent to ordering activities.

The current SLA fee which applies to this contract action is 0.5%. This SLA Fee shall be imbedded in the awarded contract/[agreement](#) price(s), and offers submitted in response to this solicitation shall include this SLA Fee in the price of every line item offered.

b. Quarterly Sales Reports.

The Contractor will report all contract sales under this contract and submit collected SLAs as follows:

(1)The Contractor will accurately report the dollar value, in U.S. dollars and rounded to the nearest whole dollar, of all sales made under this contract by calendar quarter (January 1–March 31, April 1–June 30, July 1–September 30, and October 1–December 31). Reported sales must include all sales made to all authorized contract or agreement users, whether shipped directly to the users or through Prime Vendor Contractor s. The report shall reflect sales by contract line item and shall segment sales by the Department of Veterans Affairs (VA) and Other Government Agencies (OGA). The reported contract sales shall include the SLA Fee and each quarterly report shall show the total SLA Fee amount collected on the reported sales. The Contractor shall maintain a consistent accounting method of sales reporting, based on the Contractors established commercial accounting practice. The Contractor shall consistently use only one of the following acceptable points at which sales may be reported—

- i. Receipt of order;
- ii. Shipment or delivery, as applicable;
- iii. Issuance of an invoice; or
- iv. Payment.

(2) Sales under this contract/[agreement](#) shall be reported to the SAC within 60 [calendar](#) days following the completion of each reporting quarter. The Contractor shall continue to furnish quarterly reports, including “zero” sales, through physical completion of the last outstanding order of the contract/[agreement](#).

(3) The sales report signed by an authorized representative of the Contractor shall be emailed to the appropriate individual(s) listed in the terms and conditions of the contract or agreement.

c. SLA Remittance

The Contractor will remit the SLA fee to the SAC in U.S. dollars within 60 **calendar** days after the end of the reporting quarter and final payment shall be remitted within 60 **calendar** days after physical completion of the last outstanding task order or delivery order of the contract.

The SLA Fee amount collected and due shall be paid electronically. To ensure that the payment is credited properly, the Contractor shall electronically transmit the SLA fee at www.pay.gov (VA Strategic Acquisition Center (SAC))

The Government reserves the right to inspect without further notice, such records of the Contractor as pertinent to sales under any contract or agreements resulting from this solicitation. Failure to remit the full amount of the SLA within 60 **calendar** days after the end of the applicable reporting period constitutes a contract debt to the United States Government under the terms of Federal Acquisition Regulation (FAR) Subpart 32.6. SECTION E - SOLICITATION PROVISIONS

In order for quotes to be considered acceptable and eligible for evaluation, they must be prepared IAW and in compliance with the instructions given in this RFQ and address, all of the requirements set forth within this RFQ.

The Government does not anticipate requesting revisions to quotes, so quoters should provide their best price in its response to this RFQ. However, the Government reserves the right to request quote revisions that seek additional price discounts, provide revisions to the technical aspect of the quote, or to clarify aspects of the quote. The quoter's initial quote shall contain the best terms from a price and technical standpoint. The Government reserves the right to make no award as a result of this solicitation.

E.7 52.203-98 PROHIBITION ON CONTRACTING WITH ENTITIES THAT REQUIRE CERTAIN INTERNAL CONFIDENTIALITY AGREEMENTS—REPRESENTATION (DEVIATION) (FEB 2015)

(a) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Resolution Appropriations Act, 2015 (Pub. L. 113-235), Government agencies are not permitted to use funds appropriated (or otherwise made available)

under that or any other Act for contracts with an entity that requires employees or subContractor s of such entity seeking to report fraud, waste, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or contractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(b) The prohibition in paragraph (a) of this provision does not contravene requirements applicable to Standard Form 312, Form 4414, or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(c) *Representation.* By submission of its offer, the Offeror represents that it does not require employees or subContractor s of such entity seeking to report fraud, waste, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subContractor s from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

E.8 52.209-7 INFORMATION REGARDING RESPONSIBILITY MATTERS (JUL 2013)

(a) *Definitions.* As used in this provision—

"Administrative proceeding" means a non-judicial process that is adjudicatory in nature in order to make a determination of fault or liability (e.g., Securities and Exchange Commission Administrative Proceedings, Civilian Board of Contract Appeals Proceedings, and Armed Services Board of Contract Appeals Proceedings). (c) If the offeror checked "has" in paragraph (b) of this provision, the offeror represents, by submission of this offer, that the information it has entered in the Federal Awardee Performance and Integrity Information System (FAPIIS) is current, accurate, and complete as of the date of submission of this offer with regard to the following information:

(1) Whether the offeror, and/or any of its principals, has or has not, within the last five years, in connection with the award to or performance by the offeror of a Federal contract or grant, been the subject of a proceeding, at the Federal or State level that resulted in any of the following dispositions:

(i) In a criminal proceeding, a conviction.

(iii) In an administrative proceeding, a finding of fault and liability that results in—

(A) The payment of a monetary fine or penalty of \$5,000 or more; or

(iv) In a criminal, civil, or administrative proceeding, a disposition of the matter by consent or compromise with an acknowledgment of fault by the Contractor if the proceeding could have led to any of the outcomes specified in paragraphs (c)(1)(i), (c)(1)(ii), or (c)(1)(iii) of this provision.

(2) If the offeror has been involved in the last five years in any of the occurrences listed in (c)(1) of this provision, whether the offeror has provided the requested information with regard to each occurrence.

(d) The offeror shall post the information in paragraphs (c)(1)(i) through (c)(1)(iv) of this provision in FAPIIS as required through maintaining an active registration in the System for Award Management database via <https://www.acquisition.gov> (see 52.204-7).

E.10 52.209-5 REPRESENTATION BY CORPORATIONS REGARDING AN UNPAID TAX LIABILITY OR A FELONY CONVICTION UNDER ANY FEDERAL LAW (DEVIATION)(MAR 2012)

(a) In accordance with Division H, sections 8124 and 8125 of P.L. 112-74 and sections 738 and 739 of P.L. 112-55 none of the funds made available by either Act may be used to enter into a contract with any corporation that—

(1) Has an unpaid federal tax liability, unless the agency has considered suspension or debarment of the corporation and the Suspension and Debarment Official has made a determination that this action is not necessary to protect the interests of the Government.

(2) Has a felony criminal violation under any Federal or State law within the preceding 24 months, unless the agency has considered suspension or debarment of the corporation and Suspension and Debarment Official has made a determination that this action is not necessary to protect the interests of the Government.

(b) The Offeror represents that—

(1) The offeror does [] does not [] have any unpaid Federal tax liability that has been assessed and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability.

(2) The offeror, its officers or agents acting on its behalf have [] have not [] been convicted of a felony criminal violation under a Federal or State law within the preceding 24 months.

(3) Include an original signed by the protester or the protester's representative and at least one copy;

(4) Set forth a detailed statement of the legal and factual grounds of the protest, including a description of resulting prejudice to the protester, and provide copies of relevant documents;

(5) Specifically request a ruling of the individual upon whom the protest is served;

(6) State the form of relief requested; and

(7) Provide all information establishing the timeliness of the protest.

(b) Failure to comply with the above may result in dismissal of the protest without further consideration.

(c) Bidders/offerors and contracting officers are encouraged to use alternative dispute resolution (ADR) procedures to resolve protests at any stage in the protest process. If ADR is used, the Department of Veterans Affairs will not furnish any documentation in an ADR proceeding beyond what is allowed by the Federal Acquisition Regulation.

E.13 52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS— COMMERCIAL ITEMS (DEC 2016)

The Offeror will complete only paragraph (b) of this provision if the Offeror has completed the annual representations and certification electronically via the System for Award Management (SAM) Web site located at <https://www.sam.gov/portal>. If the Offeror has not completed the annual representations and certifications electronically, the Offeror shall complete only paragraphs (c) through (t) of this provision.

(a) *Definitions.* As used in this provision—

Administrative merits determination means certain notices or findings of labor law violations issued by an enforcement agency following an investigation. An administrative merits determination may be final or be subject to appeal or further review. To determine whether a particular notice or finding is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

Arbitral award or decision means an arbitrator or arbitral panel determination that a labor law violation occurred, or that enjoined or restrained a violation of labor law. It

includes an award or decision that is not final or is subject to being confirmed, modified, or vacated by a court, and includes an award or decision resulting from private or confidential proceedings. To determine whether a particular award or decision is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

Civil judgment means—

(1) In paragraph (h) of this provision: A judgment or finding of a civil offense by any court of competent jurisdiction.

(2) In paragraph (s) of this provision: Any judgment or order entered by any Federal or State court in which the court determined that a labor law violation occurred, or enjoined or restrained a violation of labor law. It includes a judgment or order that is not final or is subject to appeal. To determine whether a particular judgment or order is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

DOL Guidance means the Department of Labor (DOL) Guidance entitled: “Guidance for Executive Order 13673, ‘Fair Pay and Safe Workplaces’ “. The DOL Guidance, dated August 25, 2016, can be obtained from www.dol.gov/fairpayandsafeworkplaces.

Economically disadvantaged women-owned small business (EDWOSB) concern means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

Enforcement agency means any agency granted authority to enforce the Federal labor laws. (iii) 40 U.S.C. chapter 31, subchapter IV, formerly known as the Davis-Bacon Act;

(iv) 41 U.S.C. chapter 67, formerly known as the Service Contract Act;

- (v) The Family and Medical Leave Act; and
- (vi) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors);
- (2) Department of Labor Occupational Safety and Health Administration (OSHA) for—
 - (i) The Occupational Safety and Health Act of 1970; and
 - (ii) OSHA-approved State Plans;
- (3) Department of Labor Office of Federal Contract Compliance Programs (OFCCP) for—
 - (i) Section 503 of the Rehabilitation Act of 1973;
 - (ii) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974; and
 - (iii) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity);
- (4) National Labor Relations Board (NLRB) for the National Labor Relations Act; and
- (5) Equal Employment Opportunity Commission (EEOC) for—
 - (i) Title VII of the Civil Rights Act of 1964;
 - (ii) The Americans with Disabilities Act of 1990;
 - (iii) The Age Discrimination in Employment Act of 1967; and
 - (iv) Section 6(d) of the Fair Labor Standards Act (Equal Pay Act).

Forced or indentured child labor means all work or service—

- (1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or
- (2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

Highest-level owner means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

Immediate owner means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

- (5) 40 U.S.C. chapter 31, subchapter IV, formerly known as the Davis-Bacon Act.
- (6) 41 U.S.C. chapter 67, formerly known as the Service Contract Act.
- (7) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity).
- (8) Section 503 of the Rehabilitation Act of 1973.
- (9) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974.
- (10) The Family and Medical Leave Act.
- (11) Title VII of the Civil Rights Act of 1964.
- (12) The Americans with Disabilities Act of 1990.
- (13) The Age Discrimination in Employment Act of 1967.
- (14) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractor s).
- (15) Equivalent State laws as defined in the DOL Guidance. (The only equivalent State laws implemented in the FAR are OSHA-approved State Plans, which can be found at www.osha.gov/dcsp/osp/approved_state_plans.html).

Labor law decision means an administrative merits determination, arbitral award or decision, or civil judgment, which resulted from a violation of one or more of the laws listed in the definition of "labor laws".

Manufactured end product means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

Small business concern means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

Note to paragraph (s): By a court order issued on October 24, 2016, this paragraph (s) is enjoined indefinitely as of the date of the order. The enjoined paragraph will become effective immediately if the court terminates the injunction. At that time, DoD, GSA, and NASA will publish a document in the **Federal Register** advising the public of the termination of the injunction.

(t) *Public Disclosure of Greenhouse Gas Emissions and Reduction Goals*. Applies in all solicitations that require offerors to register in SAM (52.212-1(k)).

(1) This representation shall be completed if the Offeror received \$7.5 million or more in contract awards in the prior Federal fiscal year. The representation is optional if the Offeror received less than \$7.5 million in Federal contract awards in the prior Federal fiscal year.

(2) Representation. [Offeror to check applicable block(s) in paragraph (t)(2)(i) and (ii)]. (i) The Offeror (itself or through its immediate owner or highest-level owner) [] does, [] does not publicly disclose greenhouse gas emissions, i.e., makes available on a publicly accessible Web site the results of a greenhouse gas inventory, performed in accordance with an accounting standard with publicly available and consistently applied criteria, such as the Greenhouse Gas Protocol Corporate Standard.
