B.4 STATEMENT OF WORK

Tri-Annual Substation Maintenance Statement of Work

1. OBJECTIVE

This Statement of Work (SOW) is for the performance of electrical substation maintenance and testing. Testing shall conform to NETA standards. The testing shall consist of cleaning, lubricating and calibrating circuit breakers, protective relays and any associated distribution equipment, including cleaning of all de-energized components, compartments, surfaces of the switchgear and related equipment. Records of the “as found” and the “as left” condition shall be provided in a binder. Three (3) copies of the test reports shall be provided to the foreman of the electric shop within 30 calendar days of the completion of the testing. A summary of deficiencies and recommendations shall be included with the test report.

2. SCOPE

Contractor shall perform electrical testing on 4160 transformers/circuit breakers by performing transformer turns ratio test (TTR) and hipot testing, all 480V circuit breakers, cleaning and lubrication, tightening all bussing and breaker connections, calibration and testing for correct voltage within GE relays. This is for the **VA Hospitals West Los Angeles** (11301 Wilshire Blvd, Los Angeles, CA 90073), **Sepulveda Ambulatory Care Center** (16111 Plummer Street, Los Angeles, CA 91343) and **Downtown Los Angeles Ambulatory Care Center** (351 East Temple Street, Los Angeles, CA 90012) locations: VA Hospital West Los Angeles has 4 buildings, 501, 299, 304 and 500; VA Hospital Sepulveda has 2 substations locations; Veterans outpatient clinic, Downtown Los Angeles, 1 substation.

- 8) Check insulators for evidence of physical damage or contaminated surfaces.
- 9) Clean the switchboard prior to testing unless as-found and as-left tests are required.

- 13) Thoroughly clean unit prior to testing unless as-found and as-left tests are required.
- 14) Check proper contact lubricant on moving current carrying parts.
- 15) Check proper lubrication on moving and sliding surfaces.

II. Electrical Tests

- 1) Perform insulation-resistance on each pole, phase-to-phase and phase-to-ground with switch closed and across each open pole for one minute, if applicable.
- 2) Perform resistance measurements through all accessible bolted connections with a low-resistance ohmmeter, if applicable.
- 3) Measure contact resistance across each switchblade and fuse holder.
- 4) Verify fuse resistance/continuity.

LV Switchboard & Circuit Breaker

I. Visual & Mechanical Inspection

- 1) The equipment nameplate data will be compared with the single line diagram if available.
- 2) Visually inspect the physical, electrical & mechanical condition including evidence of moisture or corona.
- 3) Check appropriate anchorage, required area clearances & physical damage.
- 4) Verify with the single line diagram that the fuses and circuit breakers correspond to the drawings, if available.
- 5) Verify if the settings of the relays/trip units correspond with the coordination study, if available.
- 6) Check if the current and voltage transformer ratios correspond to the drawings, if available.
- 7) Inspect all accessible bus connections for high resistance and verify connections by calibrated torque-wrench method in accordance with manufacturer's published data or by industry standard.
- 8) Check insulators for evidence of physical damage or contaminated surfaces.

- 5) Functionally test by secondary injection the circuit breakers, if applicable.

3Phase Dry Type Transformers

I. Visual and Mechanical Inspection

- 1) The physical, electrical, and mechanical condition including evidence of moisture, corona or brittleness will be inspected and evaluated.
- 2) Check that control and alarm settings on temperature indicators are as specified, if applicable.
- 3) Check that cooling fans operate, if applicable.
- 4) Check that the core, frame and enclosure are grounded properly.
- 5) Check the presence of transformer surge arresters, if applicable.
- 6) Thoroughly clean unit prior to testing unless as-found and as-left tests are required.
- 7) Check that the as-left tap connections are as specified.

II. Electrical Tests

- 1) Perform insulation-resistance tests winding-to-winding and each winding-to-ground.
- 2) Perform transformer turn's ratio tests at the designated tap position.

Lightning/Surge Arresters

I. Visual and Mechanical Inspection

- 1) The physical and mechanical condition will be inspected.
- 2) Check for proper mounting and adequate clearances.
- 3) Inspect bolted electrical connections for high resistance using low-ohmmeter resistance method.
- 4) Check if the ground lead on each device is individually attached to a ground bus or ground electrode.

II. Electrical Tests

- 1) Perform insulation-resistance test at voltage levels specified by the manufacturer or by NETA specifications.
- 2) Perform contact resistance test.
- 3) Test grounding connection.

INSURANCE LIABILITY

Workers Compensation and Employer's Liability: The contractor is required to comply with applicable Federal and State worker's compensation and occupational disease statutes. If occupational diseases are not compensable under those statutes, they shall be covered under the employer's liability section of the insurance policy, except when contract operations are so commingled with a contractor's commercial operations that it would not be practical to require this coverage. Employer's liability coverage of at least \$1,000,000 shall be required.

General Liability:

- (a) The contractor is required to maintain bodily injury liability insurance coverage written on the comprehensive form of policy of at least \$500,000 per occurrence.
- (b) The contractor will be responsible for all damage to property, which may be caused by him, or any employee engaged in the performance of this contract.
- (c) Automobile Liability: The contractor is required to maintain automobile liability insurance written on the comprehensive form of policy. The policy shall provide for bodily injury and property damage liability covering the operation of all automobiles used in connection with performing the contract. Policies covering automobiles operated in the U.S. shall provide coverage of at least \$200,000 per person and \$500,000 per occurrence for bodily injury and \$20,000 per occurrence for property damage. The amount of liability coverage on other policies shall be commensurate with any legal requirements of the locality and sufficient to meet normal and customary claims.

Before commencing work under this contract, the contractor shall furnish certification from his insurance company indicating that the coverage outlined in paragraphs 12 (a) through (c) has been obtained and that it may not be changed or canceled without a **guaranteed thirty (30) days notice** to the Contracting

Officer. The Contracting Officer may waive the requirement if it is determined that insurance certifications now on file are acceptable, however, new certifications shall be furnished prior to the expiration date.

10. AUTHORIZED SERVICE

Only those services specified within are authorized under this contract. Before permitting any service or repairs of a non-contract nature, the Contracting Officer must be advised of the reasons for this additional work. The Contractor is cautioned that only the Contracting Officer or his/her designee may authorize additional service or repairs that are outside of the scope of this contract and that reimbursement shall not be made unless prior authorization is obtained.

11. CHANGES

The Contractor is advised that only the Contracting Officer, acting within the scope of the contract has the authority to make changes which affect the contract in terms of quality, quantity, price or delivery.

In the event the Contractor effects any such change at the direction of any person other than the Contracting Officer, the change shall be considered to have been made without authority and no adjustment shall be made in the contract price to cover any increase in costs incurred as a result thereof.

12. SMOKING POLICY

Smoking is not permitted within or around the VA, except in designated areas.

13. VA POLICY

Possession of weapons is prohibited. Enclosed containers, including tool kits, are subject to search. Violations of VA regulations may result in citations answerable in the United States (Federal) District Court.

If this contract is completely or partially terminated, the records relating to the work terminated shall be made available for 3 years after any resulting final termination settlement. ALL OCCUPATIONS LISTED ABOVE RECEIVE THE FOLLOWING BENEFITS:

HEALTH & WELFARE: \$4.27 per hour or \$170.80 per week or \$740.13 per month

VACATION: 2 weeks paid vacation after 1 year of service with a contractor or successor, 3 weeks after 5 years, and 4 weeks after 15 years. Length of service includes the whole span of continuous service with the present contractor or successor, wherever employed, and with the predecessor contractors in the performance of similar work at the same Federal facility. (Reg. 29 CFR 4.173)

HOLIDAYS: A minimum of ten paid holidays per year: New Year's Day, Martin Luther King Jr.'s Birthday, Washington's Birthday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veterans' Day, Thanksgiving Day, and Christmas Day. (A contractor may substitute for any of the named holidays another day off with pay in accordance with a plan communicated to the employees involved.) (See 29 CFR 4.174)

THE OCCUPATIONS WHICH HAVE NUMBERED FOOTNOTES IN PARENTHESES RECEIVE THE FOLLOWING:

1) COMPUTER EMPLOYEES: Under the SCA at section 8(b), this wage determination does not apply to any employee who individually qualifies as a bona fide executive, administrative, or professional employee as defined in 29 C.F.R. Part 541. Because most Computer System Analysts and Computer Programmers who are compensated at a rate not less than \$27.63 (or on a salary or fee basis at a rate not less than \$455 per week) an hour would likely qualify as exempt computer professionals, (29 C.F.R. 541.400) wage rates may not be listed on this wage determination for all occupations within those job families. In addition, because this wage determination may not list a wage rate for some or all occupations within those job families if the survey data indicates that the prevailing wage rate for the occupation equals or exceeds \$27.63 per hour conformances may be necessary for certain nonexempt employees. For example, if an individual employee is nonexempt but nevertheless performs duties within the scope of one of the Computer Systems Analyst or Computer Programmer

occupations for which this wage determination does not specify an SCA wage rate, then the wage rate for that employee must be conformed in accordance with the conformance procedures described in the conformance note included on this wage determination.

2) AIR TRAFFIC CONTROLLERS AND WEATHER OBSERVERS - NIGHT PAY & SUNDAY PAY: If you work at night as part of a regular tour of duty, you will earn a night differential and receive an additional 10% of basic pay for any hours worked between 6pm and 6am.

If you are a full-time employed (40 hours a week) and Sunday is part of your regularly scheduled workweek, you are paid at your rate of basic pay plus a Sunday premium of 25% of your basic rate for each hour of Sunday work which is not overtime (i.e. occasional work on Sunday outside the normal tour of duty is considered overtime work).

**** HAZARDOUS PAY DIFFERENTIAL ****

An 8 percent differential is applicable to employees employed in a position that represents a high degree of hazard when working with or in close proximity to ordnance, explosives, and incendiary materials. This includes work such as screening, blending, dying, mixing, and pressing of sensitive ordnance, explosives, and pyrotechnic compositions such as lead azide, black powder and photoflash powder.

All dry-house activities involving propellants or explosives. Demilitarization, modification, renovation, demolition, and maintenance operations on sensitive ordnance, explosives and incendiary materials. All operations involving re-grading and cleaning of artillery ranges.

A 4 percent differential is applicable to employees employed in a position that represents a low degree of hazard when working with, or in close proximity to ordnance, (or employees possibly adjacent to) explosives and incendiary materials which involves potential injury such as laceration of hands, face, or arms of the employee engaged in the operation, irritation of the skin, minor burns and the like; minimal damage to immediate or adjacent work area or equipment being used. All operations involving, unloading, storage, and hauling of ordnance, explosive, and incendiary ordnance material other than small arms ammunition. These differentials are only applicable to work that has been specifically designated by the agency for ordnance, explosives, and incendiary material differential pay.

**** UNIFORM ALLOWANCE ****

If employees are required to wear uniforms in the performance of this contract (either by the terms of the Government contract, by the employer, by the state or local law, etc.), the cost of furnishing such uniforms and maintaining (by laundering or dry cleaning) such uniforms is an expense that may not be borne by an employee where such cost reduces the hourly rate below that required by the wage

determination. The Department of Labor will accept payment in accordance with the following standards as compliance:

The contractor or subcontractor is required to furnish all employees with an adequate number of uniforms without cost or to reimburse employees for the actual cost of the uniforms. In addition, where uniform cleaning and maintenance is made the responsibility of the employee, all contractors and subcontractors subject to this wage determination shall (in the absence of a bona fide collective bargaining agreement providing for a different amount, or the furnishing of contrary affirmative proof as to the actual cost), reimburse all employees for such cleaning and maintenance at a rate of \$3.35 per week (or \$.67 cents per day). However, in those instances where the uniforms furnished are made of "wash and wear" materials, may be routinely washed and dried with other personal garments, and do not require any special treatment such as dry cleaning, daily washing, or commercial laundering in order to meet the cleanliness or appearance standards set by the terms of the Government contract, by the contractor, by law, or by the nature of the work, there is no requirement that employees be reimbursed for uniform maintenance costs.

Conformance Process:

The contracting officer shall require that any class of service employee which is not listed herein and which is to be employed under the contract (i.e., the work to be performed is not performed by any classification listed in the wage determination), be classified by the contractor so as to provide a reasonable relationship (i.e., appropriate level of skill comparison) between such unlisted classifications and the classifications listed in the wage determination (See 29 CFR 4.6(b)(2)(i)). Such conforming procedures shall be initiated by the contractor prior to the performance of contract work by such unlisted class(es) of employees (See 29 CFR 4.6(b)(2)(ii)). The Wage and Hour Division shall make a final determination of conformed classification, wage rate, and/or fringe benefits which shall be paid to all employees performing in the classification from the first day of work on which contract work is performed by them in the classification. Failure to pay such unlisted employees the compensation agreed upon by the interested parties and/or fully determined by the Wage and Hour Division retroactive to the date such class of employees commenced contract work shall be a violation of the Act and this contract. (See 29 CFR 4.6(b)(2)(v)). When multiple wage determinations are included in a contract, a separate SF-1444 should be prepared for each wage determination to which a class(es) is to be conformed.

The process for preparing a conformance request is as follows:

- 1) When preparing the bid, the contractor identifies the need for a conformed occupation(s) and computes a proposed rate(s).
- 2) After contract award, the contractor prepares a written report listing in order the proposed classification title(s), a Federal grade equivalency (FGE) for each proposed classification(s), job description(s), and rationale for proposed wage rate(s), including information regarding the agreement or disagreement of the authorized representative of the employees involved, or where there is no authorized representative, the employees themselves. This report should be submitted to the contracting officer no later than 30 days after such unlisted class(es) of employees

performs any contract work.

3) The contracting officer reviews the proposed action and promptly submits a report of the action, together with the agency's recommendations and pertinent information including the position of the contractor and the employees, to the U.S. Department of Labor, Wage and Hour Division, for review (See 29 CFR 4.6(b)(2)(ii)).

4) Within 30 days of receipt, the Wage and Hour Division approves, modifies, or disapproves the action via transmittal to the agency contracting officer, or notifies the contracting officer that additional time will be required to process the request.

5) The contracting officer transmits the Wage and Hour Division's decision to the contractor.

6) Each affected employee shall be furnished by the contractor with a written copy of such determination or it shall be posted as a part of the wage determination (See 29 CFR 4.6(b)(2)(iii)).

Information required by the Regulations must be submitted on SF-1444 or bond paper.

When preparing a conformance request, the "Service Contract Act Directory of Occupations" should be used to compare job definitions to ensure that duties requested are not performed by a classification already listed in the wage determination. Remember, it is not the job title, but the required tasks that determine whether a class is included in an established wage determination. Conformances may not be used to artificially split, combine, or subdivide classifications listed in the wage determination (See 29 CFR 4.152(c)(1)).

The Offeror will be evaluated and rated acceptable on Technical Capability evaluation factor if at a minimum, the Offeror identified and addressed the requirements **clearly** for each subfactor listed below. The Offeror shall provide supporting documentation, as required, that they possess the resources, experience, technical knowledge, responsibility and integrity to meet the technical requirements of this solicitation. An unacceptable rating for any of the sub-factors listed below constitutes an overall unacceptable rating for the Technical Capability evaluation factor.

Sub-factor 1: Offeror must submit a capability statement in no more than four (4) pages demonstrating at least a minimum of five (5) years of experience and knowledge in performing requirements as described in the statement of work (SOW) and the items listed below:

- a. Licensing qualification: State to be "Fully Qualified" vendor to perform work on the equipment listed in the SOW as factory-trained (or equivalent) vendor/technician/engineer.
- b. Certification to perform testing in accordance with the InterNational Electrical Testing Association (NETA) standards.

Sub-factor 2: Offeror must provide qualifications of the proposed key personnel who will be providing the work to be performed. This information must include, but not limited to the following list below:

- a. Name of Proposed Contractor Personnel

- b. Brief description of qualifications and experience level or work history relevant to the requirements described in the SOW

The Offeror shall complete only paragraph (b) of this provision if the Offeror has completed the annual representations and certification electronically via the System for Award Management (SAM) Web site located at <https://www.sam.gov/portal>. If the Offeror has not completed the annual representations and certifications electronically, the Offeror shall complete only paragraphs (c) through (u) of this provision.

(a) *Definitions.* As used in this provision—

Administrative merits determination means certain notices or findings of labor law violations issued by an enforcement agency following an investigation. An administrative merits determination may be final or be subject to appeal or further review. To determine whether a particular notice or finding is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

Arbitral award or decision means an arbitrator or arbitral panel determination that a labor law violation occurred, or that enjoined or restrained a violation of labor law. It includes an award or decision that is not final or is subject to being confirmed, modified, or vacated by a court, and includes an award or decision resulting from private or confidential proceedings. To determine whether a particular award or decision is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

Civil judgment means—

(1) In paragraph (h) of this provision: A judgment or finding of a civil offense by any court of competent jurisdiction.

(2) In paragraph (s) of this provision: Any judgment or order entered by any Federal or State court in which the court determined that a labor law violation occurred, or enjoined or restrained a violation of labor law. It includes a judgment or order that is not final or is subject to appeal. Economically disadvantaged women-owned small business (EDWOSB) concern means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

Enforcement agency means any agency granted authority to enforce the Federal labor laws. - (12) The Americans with Disabilities Act of 1990.
- (13) The Age Discrimination in Employment Act of 1967.
- (14) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors).
- (15) Equivalent State laws as defined in the DOL Guidance. (The only equivalent State laws implemented in the FAR are OSHA-approved State Plans, which can be found at www.osha.gov/dcsp/osp/approved_state_plans.html).

Labor law decision means an administrative merits determination, arbitral award or decision, or civil judgment, which resulted from a violation of one or more of the laws listed in the definition of “labor laws”.

Manufactured end product means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

“Sensitive technology”—

- (i) To restrict the free flow of unbiased information in Iran; or
- (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

Service-disabled veteran-owned small business concern—

- (1) Means a small business concern—
