**Request For Information (RFI) Set #1**

1. Please clarify if either a State of Florida Certified Electrical License or a General Contractor License (from any of the 50 states) satisfies the licensing requirement of this solicitation. It is stated in the pre-solicitation, "General Requirements:

Provide all labor, materials, tools and equipment as necessary to construct the project described below and other specific tasks as further defined by this RFP. All proposals are to provide construction services for this project. The contractor shall be a State of Florida Certified/licensed General Contractor. The construction shall be in accordance with the 100% design drawings and specifications for this project."

General contractor from any of the 50 states is acceptable.

2. Item 3.LPTA Technical Factors: FACTOR 1: RELEVANT PAST PERFORMANCE  
EXPERIENCE: Items A and B require construction work, at a hospital or medical facility, as a prime contractor at a dollar magnitude between \$2,000,000 and \$5,000,000.00

Question: Will the VA recognize the experience of formal teammates under formal teaming agreements as provided for under FAR 9.6?

Relevant past performance require offeror to submit projects that were awarded to the offeror as the prime contractor regardless of formal teaming agreements.

Question: Will the VA recognize relevant generator installation experience for projects smaller than \$2M and not performed at a hospital environment?

Item A and B do not have to be combined. Contractor may have experience with \$2M to \$5M in one of the three allowable projects and experience in a different project that was at a hospital or medical facility.

Item C must apply to all submitted projects.
