Dishwasher, Flight Type Machine

The Amarillo VA Health Care System intends to award a firm-fixed price Purchase Order to a single SDVOSB/VOSB vendor.

GENERAL REQUIREMENTS:

Vendor shall provide 1 each Dishwashing machine and 1 each Installation of Dishwashing machine to include all aspects (plumbing, electrical, etc.) for the Nutrition and Food Service, Amarillo VA Medical Center, 6010 Amarillo Blvd., West, Amarillo, TX 79106.

The Vendor must provide 1 dishwashing machine and installation that **MEETS or EXCEEDS** the salient characteristics, specifications and requirements listed within this document.

- Vendor must provide complete Dish machine as outlined in Equipment section below.
- Vendor must provide a 1-year (12-month) standard coverage warranty.
- Vendor must provide 2 copies of the service manual and 2 copies of the user's manual.
- Vendor must provide expert installation of Dishwashing machine as outlined in section below.
- Vendor must provide shipping to Amarillo VA and provide shipping updates.

Equipment specifications:

The dishwasher will be a multiple tank, flight type machine. It will automatically pre-wash, wash and rinse / sanitize food service utensils when connected to an adequate source of 110 degree F. fresh water. The machine will be NSF and UL approved.

Minimum requirements:

The dishwasher must not exceed 33" in width, due to space constraints, and be no less than 21 ft. in length.

The unit must have a minimum of 4 separate tanks consisting of a non-heated pre-wash, heated power wash, heated power rinse, and heated dual rinse to include the final rinse.

The unit must process a minimum 11,127 dishes per hour, per NSF listing.

The unit must use a maximum 48 gallons per hour, per NSF listing.

The unit must have a maximum of 24" belt, with upper rods every fourth row.

The machine must have stainless steel, insulated, hinged, access doors per tank. Door safety switches will also be provided for each access door.

The equipment must have stainless steel hoods and integral tanks mounted on a stainless steel angle base with stainless steel legs and feet. The hoods and tanks must be polished to a #3 commercial finish. The machine must include a continuous frame extending under the pre-wash, wash, power rinse, dual rinse, to include the entire un-load end. Entire hood must be one piece to prevent leak points. Bolt together or tack welded, two piece hoods, are not acceptable. Removable perforated stainless steel refuse screens, each with handle, will completely cover each tank area. Free access will be possible with refuse screens removed.

Motors will be standard NEMA frame, TEFC construction with grease packed ball bearings. A one piece mechanical seal will mount on the motor shaft where it enters the pump. All pumps will automatically shut-off after a pre-determined period of idle operation by means of an electric eye energy sentinel (idle pump shut-off). The pumps contain stainless steel impellers. All service to the pumps and motors must be accessible from the front of the machine.

The prewash and wash/rinse sprays will each be distributed through stainless steel one piece manifold wash-arms, above and below the conveyor. Each manifold will be easily removable for cleaning and will have removable end closures. Final rinse sprays will be distributed through upper and lower stainless steel spray pipes and will cover the entire width of the conveyor. Automatic tank fill will be supplied. Only copper and stainless steel plumbing will be used. No plastic manifolds or braided hoses will be accepted.

The conveyor belt will provide a minimum 24" wide clearance with 19" vertical clearance through the machine. The peg type conveyor belt will be designed to accommodate trays, dishes, cups, glass racks, sheet pans, steam table pans, and oval serving trays. The belt will be molded polypropylene links. A standard peg style belt will be supplied. There will be a safety shut-off plate at the unload end to automatically stop the conveyor should the operator fail to remove pieces from it. There will be stainless steel belt sprockets at both ends of the unit, for maximum belt life.

The tank heat for this dish-machine will be a provided with steam tank heat. Furthermore, the unit will also provide the 180 degree final rinse water with the assistance of a built in 70F rise booster.

The machine will include a non-sacrificial, scale prevention device, to be mounted and inter-piped.

Machine will consist of the following:

- Flight Type Multiple Tank Machine
- 5' load section (load & prewash)
- 6' center section (powered wash/rinse)
- 10' (split) un-load section (dual rinse/final rinse)
- Left to Right operation

- Steam tank heat
- Steam booster, built in, 70 F. rise
- Steam blower dryer with 48" tunnel
- Standard peg belt with upper rods every fourth row
- Stainless steel rear enclosure panels
- Scale prevention system
- Maximum 72" shipping section

1 each Installation:

- Removal of old equipment to specified area in VA scrap yard.
- Move and place new machine in space allotted.
- Installation per manufacturer recommendations.
- Hook up to water source and steam. Contractor to verify existing plumbing, drainage, and steam supply will meet manufacturer's requirements and add/modify if necessary.
- Install venting. Contractor to verify existing vents will meet manufacturers requirements for venting and add/modify ventilation if necessary.
- Clean up of debris during and after project.
- Test run while vendor onsite.
- Connect electrical power to machine. Contractor is responsible for verifying existing power will meet requirements and will add/modify electrical supply to machine if necessary.

SECTION E - SOLICITATION PROVISIONS

If the lowest priced offer receives an “Acceptable” Technical rating, then the evaluation process concludes and the Government will make preparations for contract award. - (ii) OSHA-approved State Plans;

(3) Department of Labor Office of Federal Contract Compliance Programs (OFCCP) for—

- (i) Section 503 of the Rehabilitation Act of 1973;
- (ii) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974; and
- (iii) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity);

(4) National Labor Relations Board (NLRB) for the National Labor Relations Act; and

- (8) Section 503 of the Rehabilitation Act of 1973.

(9) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974.

(10) The Family and Medical Leave Act.

(11) Title VII of the Civil Rights Act of 1964.

(12) The Americans with Disabilities Act of 1990.

(13) The Age Discrimination in Employment Act of 1967.

(14) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors).

(15) Equivalent State laws as defined in the DOL Guidance. (The only equivalent State laws implemented in the FAR are OSHA-approved State Plans, which can be found at www.osha.gov/dcsp/osp/approved_state_plans.html).

Labor law decision means an administrative merits determination, arbitral award or decision, or civil judgment, which resulted from a violation of one or more of the laws listed in the definition of “labor laws”.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub.
