STATEMENT OF WORK

GENERAL

The specific uniform requirements for the two VA departments are noted separately below. This contract is based on estimated quantities, contractor shall only bill for services provided which must also be documented and on the appropriate invoices.

Engineering Service of the San Francisco Veterans Affairs has approximately 110 employees that require uniforms.. As a multifaceted service we have specific uniform requirements for HVAC, Plumbing, Building Maintenance, Electricians, Carpentry and Biomedical. This requires the specific vendor to be versatile in accommodating our needs in a quick and responsive matter. We also require a presentable uniform that will endure the complex environment and circumstances our employees face on a day to day basis. Such items are addressed specifically below. POC: Edward A. Nutrition and Food Services at the San Francisco VA Medical Center prepares and delivers meals to patient rooms and units throughout the hospital. Uniforms are required to provide a clean, professional and universally recognizable appearance for our customer, the Veteran patient, medical staff and visitors. DESCRIPTIONS/SPECIFICATIONS

– Engineering Facilities Requirement

1. Shirts for facilities section are to be of lightweight poplin, break resistant buttons. Collar Two-piece, lined; cuffs two button closure of a 65% cotton 35% polyester blend, long/ short sleeve. Trousers 65% polyester 35% cotton blend with YKK zipper with two (2) front pockets and two (2) back pockets. One (1) shirt and one (1) pant are considered 1 set. Eleven (11) sets for each employee in total with VA Engineering logo on the shirt.
 - a. Approximately sixteen (16) uniforms require a special fire retardant property in the fabric.
 - b. Approximately eleven (11) Coveralls are to be substituted for pant/shirt depending on specialization of the worker, that may require fire resistant properties in the fabric
2. New uniforms are required every two (2) years.
3. Uniforms will be returned clean, freshly pressed and without wrinkles.
 - a. Uniforms shall be returned from the cleaner in good repair (no tears, holes or stains) and of professional appearance. If uniforms cannot be returned in a serviceable and professional condition, they shall be replaced, even if off cycle (outside the 2 year rotation), at no additional cost.
4. New uniforms must be measured to fit each person upon initial delivery.
 - a. Female uniforms are required when applicable
 - b. Alterations will be completed with a maximum turnaround time of 3 weeks.

Biomedical Requirements

1. 11 Pairs – Shirts and Pants with VA Biomedical Engineering logo
 - a. 5 long sleeve oxford work shirts with button down collar
 - b. 5 short sleeve oxford work shirts with button down collar
 - c. 2 Polo shirts (short/long sleeves)
 - d. Pants must be at least 50% cotton
 - e. Oxford shirts must be 50/50 cotton blend
2. 2 black or dark blue fleece vests with VA Biomedical Engineering logo
3. New uniforms must be measured to fit each person upon initial delivery
 - a. Female uniforms are required when applicable
 - b. Alteration services to customize uniforms as necessary
 - i. Alterations will be completed with a maximum turnaround time of three (3) weeks.
4. Uniforms will be returned from cleaning freshly pressed and without wrinkles.
 - a. Uniforms shall be returned from the cleaners in good repair (no tears, holes, or stains) and of professional appearance. If uniforms cannot be returned in a serviceable and professional condition, they shall be replaced, even if off cycle (outside the 2 year rotation), at no additional cost.
5. New uniforms are required every two (2) years.

Additional Engineering uniform specifications

1. Dress shirts shall be button down. Shirts shall be made of 65% polyester and 35% cotton blend unless the worker has a specific requirement that will require a specific type of blend other than

mentioned. Men's shirts shall have a long shirt tail and unbreakable buttons. Women's shirts shall have a scalloped hem and four (4) buttons. There will be a choice of any combination of short and long sleeve shirts for all employees.

2. Polo shirts shall be made of 50% polyester and 50% cotton blend comfort fabric. Shirts shall have unbreakable buttons. The shirts colors are tan and the Supervisor shirts are medium blue.
3. Trousers shall be made of 65% polyester and 35% cotton twill blend or comfort fabric; double pleated men's/women's brass zippers; bar tack at stress points; top stitched belt loops; double inset rear pockets and two (2) front quarter top pockets. Unless the worker has a specific requirement that will require a specific type of blend other than mentioned
4. A special size is defined as trousers having a waist size of 46 or larger and a shirt size of 3XL or larger. The trousers colors are to be determined.
5. A complete set is defined as one shirt and one pair of trousers or one coverall.

Nutrition and Food Services - (Detailed Specifications noted in attached Salient Characteristics document)

1. Three types of uniform sets will be available and provided:
 - a. Food Service Supervisor (5 Supervisors) - Flat front pants and snap-front style shirts (colors to be determined once contract awarded)
 - b. Food Service Worker (estimated 60 Employees) – Flat front pants and snap-front style shirt(colors to be determined once contract awarded)
 - c. Cook (estimated 8 cooks) -Chef jacket, snap-front style shirt and checked pants
 - d. Additionally, white bib aprons will be supplied (90 per week)
2. Each type of uniform will be available in a mens and women's fit and style.
3. Each uniform component will be available in range of special sizes to comfortably meet all employee needs
4. A special size is defined as sizes smaller and larger than standard sizes. Larger sizes are trousers having a waist of 46 or larger and a shirt size of 3XL or larger. Smaller sizes are those in petite fit beginning at size 0 (zero) and XS.
5. A complete set is defined as:
 - a. Food service worker and supervisor -one top and one pair of pants
 - b. Cook - one pair of chef pants, one top and one chefs jacket

2. Emblems

Engineering

1. Emblems for VA ENGINEERING AND BIOMEDICAL will be provided and shall have dark blue lettering with a white background.
2. Emblems for ENGINEERING AND BIOMEDICAL will be provided and shall have navy blue lettering with a white background; (color will coordinate with trouser color). Emblems are a Department approved logo, and be firmly affixed to the front left side of the shirt. If the shirt is for a supervisor, the word "Supervisor" will be a approve Department service emblem.
3. Name emblem is sewn on the right hand side of the Supervisor shirt, approximately 1/2 inch above the pocket. VA emblem with Service Name is sewn on the left hand side of the shirt approximately% inch above the pocket. Both emblems are sewn at the same level on the opposite sides of the shirt. The employee's name will not be on the shirt.
4. Emblems will be provided by the vendor. SF VHA will provide the logo specifics.

Nutrition and Food Services

1. Emblems for Nutrition and Food Services will be provided and shall have lettering with a white background (color will coordinate with trouser color). Emblems shall read "Nutrition and Food Services", and be firmly affixed to the front left side of the shirt. An emblem with the employee's first name shall be firmly affixed to the front right side of the shirt at the same level as the other emblem. If the shirt is for a supervisor, the word "Supervisor" should be on the line below the employee's name.
2. Both emblems are sewn at the same level on the opposite side of the shirt.

3. Issuance of Garments

Engineering

1. The initial issue of garments will be for an estimated 90 VA ENGINEERING employees and 20 BIOMEDICAL employees.
90 - Employees' for Engineering
20 – Employees' for Biomedical
2. Each VA employee will be issued a predetermined amount of complete sets. A complete set is defined as 1 shirt and 1 pair of trousers/pants or one (1) coverall.
3. During the term of the contract, VA may make changes in the number of sets of garments required due to the decreasing or increasing of departmental personnel.
4. Upon award notification, VA will furnish the contractor a list of VA employees who are authorized to be issued garments. The list will provide the location, full name, type, color and quantity of garments to be issued.
5. Contractor agrees to buy back special size garments if employees leave VA within 90 days of the initial issue date.
6. Contractor shall provide qualified personnel to take individual sizing measurements and fittings on the initial order and any add on employees. Each garment shall be fitted to the satisfaction of the individual employee.

7. If the garment does not fit to the satisfaction of the individual employee, the contractor shall exchange it for a new garment. Turn-around time for this shall be within 14 calendar days after notification of the exchange requirement. Non-delivery within this specified period shall result in a NO CHARGE to the VA for the initial issue of the uniform.
8. Contractor shall have the ability to provide a wide variety of sizes to individuals to include any over-sized garments required, within two weeks of receiving a request, or three weeks if for a special size.

Nutrition and Food Services

1. The initial issue of Nutrition and Food Services garments will be for an estimated 65 employees

Each Nutrition and Food Services employee will be issued the following number of complete uniform sets within two weeks of measurement. Note: A complete uniform is a top and a bottom. Predetermined number of uniform sets to be provided:
 - i. Number of uniform sets issued is based on number of days scheduled to work.
(Number of days scheduled X 2) +1)
2. During the term of the contract, Nutrition and Food Services may make changes in the number of sets of garments required due to the decreasing or increasing of departmental personnel.
3. Upon award notification, VA will furnish the contractor a list of VA employees who are authorized to be issued garments. The list will provide the location, full name, type, color and quantity of garments to be issued.
4. Contractor agrees to buy back special size garments if employees leave VA within 90 days of the initial issue date
5. Contractor shall provide qualified personnel to take individual sizing measurements and fittings on the initial order and any add on employees. Each garment shall be fitted to the satisfaction of the individual employee and Nutrition and Food Service supervisors.
6. If the garment does not fit to the satisfaction of the individual employee and Nutrition and Food Services supervisors, the contractor shall exchange it for a new garment. Turn-around time for this shall be within 14 calendar days after notification of the exchange requirement. Non-delivery within this specified period shall result in a No Charge to the VA for the initial issue of the uniform.
7. Contractor shall have the ability to provide a wide variety of sizes to individuals include any over-sized or smaller than standard size garments required within two weeks of receiving a request, or three weeks if for a special size.

4. General Contract Requirements/information - (Applicable to both Engineering and Nutrition and Food Services)

1. Contractor will provide rental, maintenance and laundry service for work related garments (shirts, pants, chef jacket) with the appropriate number of changes per week based on the work schedule of the employee, for the San Francisco VA Medical Center.
2. All garments issued/provided under this contract shall be new, (Grade A). Used garments are not acceptable at any time, with the exception of the lost or damaged uniform caused by the VA employee.

5. Repair/Replacement – Engineering and Nutrition and Food Services -(Applicable to both Engineering and Nutrition and Food Services)

1. Any repairs or alterations to garments shall be accomplished at no additional direct cost to the VA.
2. Contractor shall be responsible for replacing the rented items that become damaged, worn out, or can no longer be worn with new garments, at no direct cost to the VA. This excludes damage or loss caused by VA employees (see paragraph D.5.6 below).
3. Any material found to be damaged or defective at time of delivery shall be repaired, replaced or corrected by the contractor. This applies to the initial issue of uniforms and subsequent weekly deliveries.
4. All repairs to include zipper replacement and broken, bent or missing buttons of equivalent quality. Repairs to be identified by means of a "NO CHARGE" repair tag placed on the garment and on the invoice. The invoice should also include annotations for replacements, any charges, NO CHARGE, credits, etc., as applicable.
5. Contractor shall inspect garments for upgrading or replacement on an as needed basis.
6. Replacement cost for garments damaged beyond repair or lost by VA employees will be the responsibility of the VA. Replacement garments, although not required to be new, shall be in good condition with no noticeable damage or worn areas. Prior to issuance of any new garment as a result of VA damage or loss will require approval of the Contracting Officer's Technical Representative (COR). Garments replaced without prior approval by the COR will be at no direct cost to the VA. The Replacement Garment Form (see paragraph D.8) will be used.
7. When replacement is made for normal wear and tear, no set up fee will be charged.

6. Delivery/Pickup - Engineering and Nutrition and Food Services (Applicable to both Engineering and Nutrition and Food Services)

1. Delivery and pickup will be required on a weekly basis, Monday through Friday. Delivery and pickup shall be accomplished on the same day each week.
2. Normal hours for pickup and delivery will be between 7:00a.m. and 3:00p.m. Engineering garments will be delivered to Building 6, Ground Floor and Nutrition and Food Services garments will be delivered to Building 203 room BB10.
3. Garments are to be received hung in orderly fashion, in numerical (based on contractors number tracking system) order at the designated location.
4. Should a federal holiday occur on the scheduled delivery day, the contractor shall provide delivery on the weekday preceding the holiday.

5. Contractor shall be able to provide and submit to the COR a computer generated weekly accountability of laundered garments delivered, plus a count of the previous week's pickup of soiled garments to equal a total inventory.
6. Counting of garments shall be accomplished at VA locations by hand, not at contractor facility or by scanner.
7. The weekly delivery document shall show employee name in alphabetical order by last name first, first name and middle initial, the employee identification number and for each employee a list of garments by type assigned to that employee.
8. Exact buildings and room numbers will be provided at time of award concerning delivery and pickup location(s).
9. If the contractor delivers an item(s) to the wrong location and the item(s) are not recovered at its original location, the contractor is responsible for its replacement by the next workday.
10. All garments delivered shall be unwrinkled and in wearable condition for placement in the designated VA locations. VA will not pay for articles, which are not delivered thoroughly cleaned and/or received in extremely wrinkled condition. This determination shall be at the discretion of the COR.
11. At the current time, VA San Francisco delivery address for Biomedical is located at 4150 Clement St. Bldg. #6, ground floor Room 11 and For VA Engineering the delivery drop off will be at Bldg 6, ground floor locker rooms. Delivery address for Nutrition and Food Services is building 203 room BB10.
12. All garments delivered to VA San Francisco shall be covered with plastic protector by employee .
13. Contractor shall provide required number of clothing racks at each pickup and delivery location for garments to hang on.
14. Contractor shall provide repair tags at each delivery and pickup location.
15. Contractor shall provide required number of clothing lockers at each location for soiled garments to be placed in. (see attached salient characteristics)
 - * Engineering – Two for the department (location to be determined)
 - * Nutrition and Food Services - Two for the department. One for the women's locker room and one for the men's locker room Building 203
16. Contractor shall provide repair tags at each delivery and pickup location.
17. Contractor shall provide weekly service and provide a delivery date and time of scheduled pick up.

7. General Guidelines - (Applicable to both Engineering and Nutrition and Food Services)

1. Laundering of all garments should be processed separately from standard industrial uniforms.

2. Adequate stain removal shall be accomplished at no additional direct cost to the VA. Excessively stained garments will be replaced by the contractor at no direct cost to the VA. This determination will be made at the discretion of the COR.
3. Contractor shall provide a tracking number to be attached to the collar or waistband of each garment. There will be only one tracking number to a garment and no duplicate numbers will be accepted. This tracking number will be attached at no direct charge.
4. VA reserves the right to inspect contractor's facilities prior to award or any time during the validity of the contract. Inspection will be to observe the process and operations and to evaluate contractor's performance, quality control and related procedures.
5. In case of an emergency that affects the San Francisco Bay Area, the contractor will give VA Medical Center San Francisco priority service. Contractor shall provide a 24-hour emergency telephone number where orders for immediate delivery will be processed.
6. Unless specified elsewhere in the contract, the garments supplied need not be flame retardant or acid resistant and contain no special flame retardant or acid resistant features.
7. The VA will notify the Contractor, in writing, of any hazardous materials that may be picked up by the company in the soiled garments or other textiles serviced under this contract. In NO case will hazardous materials be present to the extent that they may be harmful to Contractor's employees.
8. SPECIAL CIRCUMSTANCES: If the incumbent contractor is the successful offer, company shall not be made to provide initial required sets of uniforms.
9. San Francisco VA employees may, at their own discretion, elect to launder assigned uniforms on their own. In these instances, the Government will not be charged for any work that might otherwise be invoiced by the contractor.
10. A 10% deduction on monthly invoices may be taken at the discretion of the COR. This deduction will be based on five (5) or more valid, documented complaints/deficiencies per month.
11. A Replacement Garment Form will be used to identify any problems of the uniform by ENGINEERING AND BIOMEDICAL and NUTRITION AND FOOD SERVICES employees.
12. Replacement Garments will be replaced in no more than 2 weeks of reported incident.

8. General Information – (Applicable to both Engineering and Nutrition and Food Services)

1. Contractor shall provide rental, maintenance and laundry services for work related garments (shirts, trousers and coveralls) with the appropriate number of changes per week based on the work schedule of the employee, for VA Medical Center, San Francisco.
2. Contractor shall comply with CAL/OSHA California Code of Regulations, Section 5193 Title 8, and blood borne Pathogen, laundry standards for contaminated laundry.
3. Contractor shall possess a valid wastewater discharge permit from the local pretreatment authority. Contractor shall also possess any required hazardous material storage permits from local fire and/or health departments necessary for on-site use and storage of chemicals or other hazardous materials.

4. All garments issued/provided under this contract shall be new, (Grade A). Used garments are not acceptable at any time, with the exception of a lost or damaged uniform caused by the VA employee (see paragraph D.5.6 below).
5. All garments furnished under this contract shall remain the property of the contractor at all times. Purchased garments become the property of the Department of Veterans Affairs.
6. Definition. An environmental charge is defined as a stop at each VA pickup and delivery location. At the current time, there will only be one stop per week at the VA Engineering Locker room.

9. PRICE AND PAYMENT - (Applicable to both Engineering and Nutrition and Food Services)

1. Invoices. Contractor shall submit an invoice for the monthly usage not to exceed the agreed monthly pricing. Any charge in excess of this, must be approved in writing from the Contracting Officer (CO). COR's or any other person cannot approve any additional cost to the government without the CO's Approval in writing. Following its delivery of each Milestone Deliverable to the Contractor shall submit an invoice corresponding monthly. (Milestone is achieved on the final delivery date of the month.)
2. Invoices shall be submitted electronically through VA's Electronic Invoice Presentment and Payment System – The FSC uses a third-party contractor, OB10, to transition vendors from paper to electronic invoice submission. Please go to this website: <http://ob10.com/us/en/veterans-affairs-us/> to begin submitting electronic invoices, free of charge.
3. SFVAHCS payments under this Contract will be made following review and approval of the invoice. Subject to the review and approval of the Contracting Officer/ Contracting Officer Representative, the payment term on all invoices will be net.
4. Each invoice and delivery document shall include:
 - e. Employee ID number
 - f. Employee name – in alphabetical order by last name, first name and middle initial
 - g. Type of uniforms issued for each employee
 - h. Number of uniforms issued
 - i. Cost of uniforms
 - j. Weekly total cost
 - k. Any extra costs (set up fee, etc)
 - l. Weekly invoice total
 - m. Any extra costs (set up fee, etc)
 - n. Weekly invoice total

Nutrition and Food Service Uniforms - Salient Characteristics

The following Characteristics are required for Nutrition and Food Service Uniforms.

Tops (Food Service Workers, Food Service Supervisors and option for Chefs):

- Snap-front shirt/top – both a feminine and masculine/unisex fit
- Straight hem bottom or otherwise designed to be worn out over pants i.e untucked.
- Fabric should be Polyester/ cotton blend (fabric blend should be within the ratios of 50/50-80/20 – polyester/cotton respectively) or 100% polyester poplin
- lightweight
- wrinkle resistant
- fade resistant
- shrink resistant
- soil-release finish
- Color to be determined
- Short sleeve

Pants (Food Service Workers and Food Service Supervisors):

- polyester/cotton blend (fabric blend should be within the range of 50/50-80/20 – polyester/cotton respectively)
- flexible interlining in waistband for adaptable comfort
- Both mens and women's cut and fit
- Flat front style
- Colors to be determined (Will need two colors, one for supervisors and one for food service workers)

Chef Jacket:

- 100% polyester
- Double breasted, reversible front
- White
- Button front

- 100% polyester
- Two front pockets and two hip pockets

Soiled uniform/laundry collection receptacle:

- A durable container (bin, locker etc) which employees can insert their dirty uniforms without using a key.

- Two – one for the mens locker room and one for the women's locker room

Hanger collection receptacle:

- A container or rack to store used hanger for pick up
- Two – one for the mens locker room and one for the women's locker room

SECTION C - CONTRACT CLAUSES

C.1 VAAR 852.215-71 EVALUATION FACTOR COMMITMENTS (DEC 2009)

The offeror agrees, if awarded a contract, to use the service-disabled veteran-owned small businesses or veteran-owned small businesses proposed as subcontractors in accordance with 852.215-70, Service-Disabled Veteran-Owned and Veteran-Owned Small Business Evaluation Factors, or to substitute one or more service-disabled veteran-owned small businesses or veteran-owned small businesses for subcontract work of the same or similar value.

(End of Clause)

C.2 52.217-8 OPTION TO EXTEND SERVICES (NOV 1999)

The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. The option provision may be exercised more than once, but the total extension of performance hereunder shall not exceed 6 months. The Contracting Officer may exercise the option by written notice to the Contractor within 30 Days.

(End of Clause)

C.3 52.212-4 CONTRACT TERMS AND CONDITIONS—COMMERCIAL ITEMS (JAN 2017)

(a) *Inspection/Acceptance.* The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

- (1) Within a reasonable time after the defect was discovered or should have been discovered; and
- (2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) *Assignment.* The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) *Changes.* Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) *Disputes.* This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising

under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) *Definitions.* The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) Invoice.

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include—

- (i) Name and address of the Contractor;
- (ii) Invoice date and number;
- (iii) Contract number, line item number and, if applicable, the order number;
- (iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;
- (v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;
- (vi) Terms of any discount for prompt payment offered;
- (vii) Name and address of official to whom payment is to be sent;
- (viii) Name, title, and phone number of person to notify in event of defective invoice; and
- (ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.
- (x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer—Other Than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) *Patent indemnity.* The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) Payment.—

(1) *Items accepted.* Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) *Prompt payment.* The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

(3) *Electronic Funds Transfer (EFT).* If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) *Discount.* In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) *Overpayments.* If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall—

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the—

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

(C) Affected line item or subline item, if applicable; and

(D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) *Interest.*

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause,

and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) *Final decisions.* The Contracting Officer will issue a final decision as required by 33.211 if—

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on—

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) *Risk of loss.* Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) *Taxes.* The contract price includes all applicable Federal, State, and local taxes and duties.

(l) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) *Title.* Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) *Limitation of liability.* Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) *Other compliances.* The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) *Compliance with laws unique to Government contracts.* The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) *Order of precedence.* Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order:

- (1) The schedule of supplies/services.
- (2) The Assignments, Disputes, Payments, Invoice, Other Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause;
- (3) The clause at 52.212-5.

- (4) Addenda to this solicitation or contract, including any license agreements for computer software.
- (5) Solicitation provisions if this is a solicitation.
- (6) Other paragraphs of this clause.
- (7) The Standard Form 1449.
- (8) Other documents, exhibits, and attachments
- (9) The specification.

(t) *System for Award Management (SAM).*

(1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the SAM database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the SAM database to ensure it is current, accurate and complete. Updating information in the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the SAM database; (B) comply with the requirements of subpart 42.12; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (t)(2)(i) of this clause, or fails to perform the agreement at paragraph (t)(2)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the SAM information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the electronic funds transfer (EFT) clause of this contract.

(3) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the SAM record to reflect an assignee for the purpose of assignment of claims (see Subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the SAM database. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

(4) Offerors and Contractors may obtain information on registration and annual confirmation requirements via SAM accessed through <https://www.acquisition.gov>.

(u) *Unauthorized Obligations.*

(1) Except as stated in paragraph (u)(2) of this clause, when any supply or service acquired under this contract is subject to any End User License Agreement (EULA), Terms of Service (TOS), or similar legal instrument or agreement, that includes any clause requiring the Government to indemnify the Contractor or any person or entity for damages, costs, fees, or any other loss or liability that would create an Anti-Deficiency Act violation (31 U.S.C. 1341), the following shall govern:

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an “I agree” click box or other comparable mechanism (e.g., “click-wrap” or “browse-wrap” agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(2) Paragraph (u)(1) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

(v) *Incorporation by reference.* The Contractor’s representations and certifications, including those completed electronically via the System for Award Management (SAM), are incorporated by reference into the contract.

(End of Clause)

C.4 52.212-5 CONTRACT TERMS AND CONDITIONS REQUIRED TO IMPLEMENT STATUTES OR EXECUTIVE ORDERS—COMMERCIAL ITEMS (JAN 2017)

(a) The Contractor shall comply with the following Federal Acquisition Regulation (FAR) clauses, which are incorporated in this contract by reference, to implement provisions of law or Executive orders applicable to acquisitions of commercial items:

- (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
- (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.

(c) *Period for acceptance of offers.* The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

In accordance with FAR 13.106-1(a)(2), no relative importance or weight will be assigned to the criteria. The Government will consider all the factors and make a determination as to which quote represents the best value to the Government. Quotes will be compared to one another, and the Government will choose the quote that best suits its needs. The Government does not anticipate entering discussions for this acquisition, so vendors are encouraged to submit their best quotes. However, the Government reserves the right to enter into discussions if it is in its best interest.

(b) Procedures

(1) All vendors will be required to prepare and submit their complete quote submission in accordance with the quote preparation instructions in Provision 52.212-1 of this request for quote. Quotes and other information will be evaluated against the evaluation factors stated in this provision.

(c) Evaluation Factors

The Government will select a best value vendor that conforms to the solicitation, which is most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate quotes: Technical Capabilities and Approach, Quality Control, Past Performance and Price.

Comparative Analysis: In accordance with simplified acquisition procedures, in addition to quotes being evaluated against its response to the criteria below in relation to the PWS, the quotes will also be evaluated against one another.

(1) Factor: 1) Technical Capabilities and Approach, 2) Quality Control

- (i) **Factor Assessment:** The vendor's quote shall, as a minimum, address each of the evaluation factors as they apply to the PWS. The Government will evaluate the quote based on the evaluation factors described in FAR 52.212-1, which are tailored to specific principal tasks in the PWS. The Government will infer from the vendor's responses to the specified evaluation factor the vendor's capability to perform to the requirements of the entire PWS.

(2) Factor: 3) Past Performance

- (i) **Factor Assessment:** The purpose of Past Performance evaluation is to assess the degree of confidence the Government will have in a vendor's ability to provide services that meet customer needs. The Past Performance evaluation will assess how relevant the vendor's contracts on previous efforts of similar size and scope to this acquisition have been rated by their customers. The evaluation will focus on and target performance that is relevant to the principal tasks of the PWS. A lack of relevant past performance information will not preclude consideration for award.

(3) Factor: 4) Price

- (i) **Factor Assessment:** This criteria evaluates the overall price (i.e. aggregate for all periods of performance identified in the CLINs) to determine if the proposed price is fair and reasonable. The Government may determine an offer unacceptable if the proposed prices are materially unbalanced which is defined as significantly understated or overstated in relation to the actual cost of that work or when the price is determined not to be fair and reasonable. The individual unit prices listed in Price Schedule will be evaluated using the price analysis techniques prescribed by FAR 15.404-1(b).
- (ii) **Ratings:** Price proposals will be evaluated, but not rated.
- (iii) **Description of factor:** The Government will conduct a price review of each contract line item. Evaluations will be based on a comparison of the aggregate price of all vendors. The aggregate price is the sum of all the contract line items shown in the Price Schedule.

(a) *Definitions.* As used in this provision—

Administrative merits determination means certain notices or findings of labor law violations issued by an enforcement agency following an investigation. An administrative merits determination may be final or be subject to appeal or further review. To determine whether a particular notice or finding is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

Arbitral award or decision means an arbitrator or arbitral panel determination that a labor law violation occurred, or that enjoined or restrained a violation of labor law. It includes an award or decision that is not final or is subject to being confirmed, modified, or vacated by a court, and includes an award or decision resulting from private or confidential proceedings. To determine whether a particular award or decision is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

Civil judgment means—

(1) In paragraph (h) of this provision: A judgment or finding of a civil offense by any court of competent jurisdiction.

(2) In paragraph (s) of this provision: Any judgment or order entered by any Federal or State court in which the court determined that a labor law violation occurred, or enjoined or restrained a violation of labor law. It includes a judgment or order that is not final or is subject to appeal. To determine whether a particular judgment or order is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

It does not include other Federal agencies which, in their capacity as contracting agencies, conduct investigations of potential labor law violations. - (ii) OSHA-approved State Plans;

(3) Department of Labor Office of Federal Contract Compliance Programs (OFCCP) for—

- (i) Section 503 of the Rehabilitation Act of 1973;
- (ii) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974; and
- (iii) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity);

(4) National Labor Relations Board (NLRB) for the National Labor Relations Act; and

(5) Equal Employment Opportunity Commission (EEOC) for—

- (10) The Family and Medical Leave Act.

Labor law decision means an administrative merits determination, arbitral award or decision, or civil judgment, which resulted from a violation of one or more of the laws listed in the definition of “labor laws”.

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;

- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;

- (3) Consist of providing goods or services to marginalized populations of Sudan;
- (4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;
- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

“Sensitive technology”—

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

- (i) To restrict the free flow of unbiased information in Iran; or
- (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

Service-disabled veteran-owned small business concern—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

Small business concern means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

Small disadvantaged business concern, consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that—

- (1) Is at least 51 percent unconditionally and directly owned (as defined at 13 CFR 124.105) by—
 - (i) One or more socially disadvantaged (as defined at 13 CFR 124.103) and economically disadvantaged (as defined at 13 CFR 124.104) individuals who are citizens of the United States; and

- (1) Directly by a parent corporation; or
- (2) Through another subsidiary of a parent corporation.

Successor means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

Veteran-owned small business concern means a small business concern—

- (1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and
- (2) The management and daily business operations of which are controlled by one or more veterans.

Women-owned business concern means a concern which is at least 51 percent owned by one or more women; or in the case of any publicly owned business, at least 51 percent of its stock is owned by one or more women; and whose management and daily business operations are controlled by one or more women.

Women-owned small business concern means a small business concern—

- (1) That is at least 51 percent owned by one or more women; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and
- (2) Whose management and daily business operations are controlled by one or more women.

Women-owned small business (WOSB) concern eligible under the WOSB Program (in accordance with 13 CFR part 127), means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.

Note to paragraph (a): By a court order issued on October 24, 2016, the following definitions in this paragraph (a) are enjoined indefinitely as of the date of the order: “Administrative merits determination”, “Arbitral award or decision”, paragraph (2) of “Civil judgment”, “DOL Guidance”, “Enforcement agency”, “Labor compliance agreement”, “Labor laws”, and “Labor law decision”. The enjoined definitions will become effective immediately if the court terminates the injunction. At that time, DoD, GSA, and NASA will publish a document in the **Federal Register** advising the public of the termination of the injunction.
