## SECTION C - CONTRACT CLAUSES

### C.1 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes FAR 52.219-6 Notice of Total Small Business Set-Aside - Alternate I. Accordingly, any contract resulting from this solicitation will include this clause. Cost of installation of replacement material and parts shall be borne by the contractor.
