The Network Contracting Office 17 intends to award a Blanket Purchase Agreement(s) (BPA(s)) to the quoter(s) that are determined technically acceptable. Supplies include tissue from a human (Allograft), or other species (Xenografts) or artificially manufactured (Bio-implant) that is implanted into or onto the body to replace damaged tissue.

BPAs are not contracts and do not obligate government funds in any way. A Blanket Purchase Agreement is a “charge account” arrangement, between a buyer and a seller for recurring purchases of supplies.

BPAs will be issued to those vendors determined to be technically acceptable and offering the lowest cost to the Government.

The Contractor agrees to the following terms and conditions of this Blanket Purchase Agreement (BPA) with the Network Contracting Office (NCO)-17.

1. Description of agreement. The contractor shall furnish only the supplies listed on the attached price list if and when requested by the Contracting Officer or an authorized representative of the contracting officer during the life of this BPA at the rates agreed to at the time the call is placed.
 - a. Pricing shall be equal to or less than the prices offered on the Contractor's COST LIST.
 - b. If there is a volume discount, contractor shall identify that on their proposed pricing.
 - c. Price list may be updated periodically with 30 days written notice to the Contracting Officer. Items that are listed on Attachment A must be available on the Contractor's COST LIST.
 - d. The VA does not guarantee payment for any items ordered that are not shown on the price list. The Contractor shall furnish firm price lists periodically as required by the Contracting Officer.
 - e. Delivery: Deliver all items ordered under this BPA to the facilities shown in Attachment B. The contractor shall not deliver items to any facility not identified on Attachment B.
2. Extent of obligation. This BPA shall expire one year from date of award. If a new BPA is awarded to the Contractor before this BPA expires, the parties, by mutual agreement, may establish a follow-on BPA against the new BPA.
3. Purchase limitation. Each individual call placed against the BPA must be within the caller's specified call limit. Further, calls may not be split in order to avoid these thresholds.
 - a. This BPA does not obligate any funds.
 - b. The Government is obligated only to the extent of authorized purchases actually made under the BPA.
4. Individuals authorized to purchase under the BPA. Any warranted Contracting Officer assigned to NCO-17 may place calls against this BPA. The contracting officer may delegate ordering authority in writing to specific individuals that are not warranted Contracting Officers. Contractor shall not accept any orders from individuals not identified in writing by the Contracting Officer.
 - a. Orders against this BPA shall be transmitted using written communications only. Orders may be faxed, e-mailed, or mailed to the contractor.
 - b. All orders shall be F.O.B. Destination
5. Delivery tickets. Any deliveries made under this BPA shall be accompanied by delivery tickets or sales slips that shall contain the following minimum information:
 - (i) Name of Contractor.

- (ii) BPA number.
 - (iii) Date of purchase.
 - (iv) Purchase/Call/Order number (This should be provided to the contractor by the authorized ordering official).
 - (v) Itemized list of supplies or services furnished.
 - (vi) Quantity, unit price, and extension of each item, less applicable discounts (unit prices and extensions need not be shown when incompatible with the use of automated systems, provided that the invoice is itemized to show this information).
 - (vii) Date of delivery or shipment.
6. Invoices. A summary invoice shall be submitted at least monthly or upon expiration of this BPA, whichever occurs first, for all deliveries made during a billing period, identifying the delivery tickets covered therein, stating their total dollar value, and supported by receipt copies of the delivery tickets.
7. The terms and conditions included in this BPA apply to all purchases made pursuant to it. In the event of any inconsistency between the provisions of this BPA and the Contractor's invoice, the provisions of the BPA will take precedence.
8. When items in this agreement are standardized under any National Consolidated Contract, BPA, or BOA, they will be deleted from this agreement 60 days after written notice from the Contracting Officer.
