B.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes 52.219-6. Small Business registration will be verified in System Award Management (SAM), and Small Business Administration (SBA). Quotes will be considered nonresponsive and rejected if the Contracting Officer is not able to verify and view contractor registrations. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. B.3 STATEMENT OF WORK

STATEMENT OF WORK (SOW)

PART 1 - GENERAL INFORMATION

- 1.1 **Title of Project:** Installation of Patient Wandering System/alarm ID system at the North Little Rock VA, 2200 Ft Roots Drive, Bldg. 170, wards 1B and 2C, North Little Rock, AR 72114.
- 1.2 **Scope of Work:** All work specified in the following sections shall comply with all local and national codes and requirements. Contractor shall provide a complete and fully operational wandering resident system that works with our existing Secure Care transmitters A07300940 and A21350941. The contractor shall furnish all qualified personnel, materials, equipment and services including lodging, travel and meals necessary to furnish and install (2) complete Wanderguard SC-40 ID systems in Bldg. 170, NLR VA, 2200 Ft. Roots Drive, North Little Rock, AR 72114 on wards 1B and 2C. The system currently in place is obsolete and no longer supported. The contractor shall purchase and install all wiring, devices and parts needed to complete each system. There

are 2 double doors on 1B and also 2 double doors in use on 2C. These doors shall require 4 maglocks associated with the complete system. Each door shall be outfitted with the SC- 40 ID panels. There shall be a computer and monitor provided by the contractor associated with each system that shall be capable of handling the required software and maps associated. Each computer shall be capable of networking with existing Wanderguard software system already in use with the SC-40 ID system. Engineering shall provide autocad drawings of each ward to the contractor for their use in setting up the systems. The systems shall provide coverage for 4 double doors and shall include:

- 8 Magnetic Egress Locks, 750 lb.
- (4) remote keypads
- (10) SC 40 ID half sized, 2.5 year transmitters A21350941 at 40. 68 MHZ
- (4) Universal ID Exit Panel-double door (SC 40);
- (2) PC's with 19" Monitor with required software installed(x 2)
- (4) 4amp power supplies
- (2) SC 40 Testers
- (2) battery backup/ups devices
- (2) XIU interface devices
- (2) copies of client software from Wanderguard
- Wiring and specialized ribbon cables required shall be provided by the contractor
- All software configuration and hardware configuration shall be included
- All ancillaries
- (5) transmitters- pn # A21350940 SC 40 non id, ½ sized, 1 year transmitters.

All work shall comply with Level II ICRA requirements with Infection Control. Please see attached description of the Infection Control Requirements which describes the standards required. The C&A requirements do not apply and a Security Accreditation Package is not required.

- 1.3 **Background:** The contractor shall furnish all qualified personnel, materials, equipment and services including lodging, travel and meals necessary to furnish and install Patient Wandering systems.

PART 2 – PRODUCTS

2.1 ACCEPTABLE MANUFACTURERS

The wandering resident alarm system specified herein shall be Model Universal ID products, as manufactured by Secure Care Products, Inc. System shall be compatible with transmitter part numbers A07300940 and A21350941 which are currently stocked by the SPD suppliers here at the VA in North Little Rock, Arkansas and Little Rock, Arkansas. Additionally, the software and hardware shall be compatible with the SC 40 Secure Care Wanderguard ID system already in use in different wards at NLR and LR campuses. The system shall allow interfacing of our current "Identive" PACS/card access system such as in

use for emergency situations in bldg.. 170 on ward 1E and shall work with transmitters already in use.

All manufactured products shall meet with all required FCC, CE, C Tick, NFPA, and Listed Device and System approvals.

Products listed herein shall consist of, but not limited to, adult transmitters, Model Universal ID Wandering Resident/Access Control Exit Panel (located at each exit location requiring restricted access, local alarm, means of alarm reset, exit status, and electro-magnetic lock controller, authorized escort of monitored residents without alarm), remote PC with 19" monitor (provide Resident Identification and alarm notification of specified exit locations), External Receiver (located at each exit requiring additional wandering resident transmitter monitoring).

2.2 BASIC OPERATION

When a wandering resident wearing an adult transmitter (known as a "monitored resident") approaches a monitored exit location, the transmitter's pulsed signal shall trigger a microprocessor controlled software response to lock or arm the exit location, the transmitter's pulsed signal shall trigger a microprocessor controlled software response to lock or arm the exit location.

When an alarm condition exists, it shall not be possible to reset an exit location in alarm if a transmitter is present and door is open.

Model Universal ID Panels shall acknowledge each transmitter by illuminating the Person near door LED display and Door Armed LED display and the ID of the wandering resident. A local piezo sounder shall emit a unique audible tone in alarm condition.

Any "monitored resident" requiring access through a monitored exit, shall be accompanied by a facility staff member by use of the system escort code. This escort code shall allow access through a monitored exit without an alarm condition for an adjustable period of time (factory set for 30 seconds). If the monitored resident passes through the exit without authorized access, the exit location shall alarm locally and at the remote nurse station annunciator displaying the ID of the wandering resident. The alarm condition shall remain until a staff member reaches the exit, retrieves the resident, and resets the alarm condition by means of a keypad reset code. If a monitored resident approaches a monitored exit location but does not proceed through the exit, the exit shall display a red LED. No alarm shall sound locally or remotely unless the exit is breached.

If an authorized exit/entry code has been entered into the exit panel keypad, the monitored exit location shall automatically begin monitoring activity after a preset time limit of 30 seconds or once the door closes (whichever comes first). This is known as the "Anti-

Tailgate Feature”. Prevention of unauthorized exit of monitored residents through monitored exit is maintained in this manner. The Wandering Resident Alarm System shall employ safe guards against radio frequency interference and system false alarms. These safeguards shall include by not be limited to the following:

- An on-board “threshold” control (operated via firmware through the keypad on the face of the controls) shall be used to adjust the sensitivity of the microprocessor to compensate for a high ambient noise floor and detection range adjustment.
- Impedance control for producing maximum power transfer from antenna coils to microprocessor.
- Microprocessor based receiver allows more accurate discrimination of transmitter signal.

The Wandering Resident Alarm System shall trigger an alarm condition only when both the door is open and an adult transmitter is within adjustable detection range from the door front or if the panel is set to PM Mode. Once the alarm condition is triggered, the system shall remain in alarm until the door is closed and an authorized staff member manually resets exit panel. The remote alarm annunciator called Sentry shall be located in a central nursing location and can be added to five additional computers on the network. The remote annunciator shall identify the location of the alarm event and display the ID of the wandering resident. Alarm and delayed egress conditions are presented with visual LED displays, as well as a unique audible alarm tone.

Each door shall have its status monitored by a set of normally closed magnetic door contacts mounted to the door and the doorframe. Double door exits shall have two sets of contacts wired in series to monitor each door individually. The magnetic door contacts shall prevent the exit panel and remote annunciator from alarming if the door is closed. The system shall alarm if the door is open, panel is in PM Mode or if an adult transmitter is present.

Multiple dry contact outputs shall provide various means of interface for peripheral devices (i.e.; closed circuit television camera) or system integration.

All exit panels shall have battery backup for emergency power supply in case of AC power loss. Each exit shall remain operational and retain all programmed memory.

2.3 BASIC SYSTEM COMPONENTS

Adult Transmitters: Transmitters shall be “true active” type and shall utilize current state-of-the-art surface mount technology. The transmitter operating frequency shall be 4.7 Mhz. Transmitters shall be lightweight, water tight, and constructed of durable polycarbonate plastic. The transmitter shall have an expiration date engraved into the side and part number engraved into the bottom. Battery type shall be long life lithium. The

transmitter shall be attached to the wanderer with a hypoallergenic adjustable strap.

Model Universal ID Exit Panel: Exit panel shall be a microprocessor based control unit. Exit panel shall display door status via green and red LED display and on-board sounder. The exit panel shall display a red “armed” LED when a wandering resident transmitter is within adjusted range of monitored exit or panel is programmed to be locked and shall provide an audible alarm if door is breached. System shall be capable of being operationally setup to work with door constantly locked or setup so it locks when a particular patient is within the required distance. Battery back up (9-volt nickel-hydride) shall be provided to maintain operation during temporary AC power failure. A fire alarm interface shall be provided for compliance with NFPA-101 Life Safety Code when interfaced with electro-magnetic locks. Exit panel shall provide perimeter alarm and access control functions by arming/locking a door during the programmable hours and alarming during unauthorized exit/entry. Unit shall provide built in clock to keep time of day for control functions. External keypad connector shall be provided for increased ease of use by staff. Push button interface shall be provided for high traffic areas. User programmable escort times in one second intervals for up to 90 seconds. Exit panel shall provide user programmable primary, secondary and tertiary access/reset codes for authorized staff members. Exit panel shall be surface or flush mountable. Faceplate shall be constructed of ABS. Connections shall be of screw down type. Four dry contact outputs shall be for system integration. Relay specification shall be a maximum of 30 volts dc and 1 amp maximum of current. System shall have pm mode capability.

Remote PC Server with 19” Monitor: the server with monitor shall provide a remote display for all monitored exits. Unit shall identify monitored exit alarm by staff approved description along with ID of resident. Remote Nurse Station Annunciator, called Sentry shall provide audible and visual indicators for all alarm conditions.

PART 3 - EXECUTION

The contractor shall furnish and install all system equipment, devices and perform all system testing.

3.1 INSTALLATION

A. The contractor shall furnish and install all back boxes and conduit stub outs as required for system devices by all Authorities Having Jurisdiction.

B. When cabling is not run in conduit above drop ceilings and may penetrate rated smoke or firewalls, furnish and install approved empty conduit sleeve and bushings. Conduit and rated wall penetrations shall be sealed with approved fire caulking made by Grabber Construction Company with the specifications of - Intumescent fire caulk, IFC, GGIFC10 Fire Block to match and comply with VA local standards.

3.2 TRAINING OF PERSONNEL

A. The staff of the facility shall be full in-serviced in the use and intended operation of the resident wandering alarm system. Such in-service shall be provided in conjunction with the installation of wandering resident alarm system.

B. The vendor shall provide instruction to the staff by means of an actual system demonstration which shall allow hands-on experience by the staff. The instructor shall demonstrate each function on the system with all LEDs, displays and audible tones in operation. Maintenance instruction shall be performed in the same manner as described above.

PART 4 – ADDITIONAL INSTRUCTIONS AND REQUIREMENTS

4.1 CHANGES TO STATEMENT OF WORK

A. Any changes to this SOW shall be authorized and approved only through written correspondence from the CO. A copy of each change shall be kept in a project folder along with all other products of the project. Costs incurred by the contractor through the actions of parties other than the CO shall be borne by the contractor.

4.2 REPORTING REQUIREMENTS

4.3 GOVERNMENT RESPONSIBILITIES

A. Little Rock VA Equipment Repair personnel will provide access to the parking lot areas during the installation process.

B. Little Rock VA Equipment Repair personnel will remain on site during the repair process to ensure a seamless repair as possible.

4.4 CONFIDENTIALITY AND NONDISCLOSURE

It is agreed that:

A. The preliminary and final deliverables, and all associated working papers, application source code, and other material deemed relevant by VA which have been generated by the contractor in the performance of this task order, are the exclusive property of the U.S. Government and shall be submitted to the CO at the conclusion of the contract.

B. The CO shall be the sole authorized official to release, verbally or in writing, any data, draft deliverables, final deliverables, or any other written or printed materials pertaining to this task order. No information shall be released by the contractor. Any request for information relating to this task order, presented to the contractor, shall be submitted to the CO for response.

C. Press releases, marketing material, or any other printed or electronic documentation related to this project, shall not be publicized without the written approval of the CO.

4.5 CONTRACTOR PERSONNEL SECURITY REQUIREMENTS

A. All contractor employees who DO NOT require access to the Department of Veterans Affairs' computer systems or data tailor the following to best meet your needs.

The COR is responsible for maintaining the security under the terms of this contract and shall immediately report security & privacy violations to Information Security Officer and Privacy Officer.

The COR and the Contractor shall assure that-

A. No other information except what is in this contract shall be shared with the contractor in any follow up communication.

B. None of the information in this contract includes Protected Health Information (PHI) or Individually Identifiable Information (III).

1. Position Sensitivity – The position sensitivity has been designated as Low Risk.

2. Background Investigation –N/A.

3. Contractor Responsibilities

a. The contractor shall prescreen all personnel requiring access to the computer systems to ensure they maintain a U.S. citizenship, and are able to read, write, speak and understand the English language.

b. The contractor shall submit or have their employees submit the required forms (SF 86 or SF 85P, SF 85P-S, FD 258, Contractor Fingerprint Chart, VA Form 0710, Authority for Release of Information Form, and Optional Forms 306 and 612) to the VA Office of Security and Law Enforcement within 30 days of receipt of order.

c. The contractor, when notified of an unfavorable determination by the Government, shall withdraw the affected employee from working under the contract.

d. Failure to comply with contractor personnel security requirements may result in termination of the contract for default.

4. Government Responsibilities

SECTION C - CONTRACT CLAUSES

C.1 52.212-4 CONTRACT TERMS AND CONDITIONS—COMMERCIAL ITEMS (JAN 2017)

(a) *Inspection/Acceptance.* The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

- (1) Within a reasonable time after the defect was discovered or should have been discovered; and
- (2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) *Assignment.* The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) *Changes.* Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) *Disputes.* This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) *Definitions.* The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) Invoice.

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include—

- (i) Name and address of the Contractor;
- (ii) Invoice date and number;
- (iii) Contract number, line item number and, if applicable, the order number;
- (iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;
- (v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;
- (vi) Terms of any discount for prompt payment offered;
- (vii) Name and address of official to whom payment is to be sent;
- (viii) Name, title, and phone number of person to notify in event of defective invoice; and
- (ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.
- (x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer—Other Than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) *Patent indemnity.* The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) Payment.—

(1) *Items accepted.* Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) *Prompt payment.* The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

(3) *Electronic Funds Transfer (EFT).* If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) *Discount.* In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) *Overpayments.* If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall—

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the—

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

(C) Affected line item or subline item, if applicable; and

(D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) *Interest.*

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) *Final decisions.* The Contracting Officer will issue a final decision as required by 33.211 if—

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on—

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) *Risk of loss.* Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) *Taxes.* The contract price includes all applicable Federal, State, and local taxes and duties.

(l) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The

Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) *Title.* Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) *Limitation of liability.* Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) *Other compliances.* The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) *Compliance with laws unique to Government contracts.* The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) *Order of precedence.* Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order:

- (1) The schedule of supplies/services.
- (2) The Assignments, Disputes, Payments, Invoice, Other Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause;
- (3) The clause at 52.212-5.
- (4) Addenda to this solicitation or contract, including any license agreements for computer software.
- (5) Solicitation provisions if this is a solicitation.

(6) Other paragraphs of this clause.

(7) The Standard Form 1449.

(8) Other documents, exhibits, and attachments

(9) The specification.

(t) *System for Award Management (SAM)*.

(1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the SAM database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the SAM database to ensure it is current, accurate and complete. Updating information in the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the SAM database; (B) comply with the requirements of subpart 42.12; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (t)(2)(i) of this clause, or fails to perform the agreement at paragraph (t)(2)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the SAM information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the electronic funds transfer (EFT) clause of this contract.

(3) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the SAM record to reflect an assignee for the purpose of assignment of claims (see Subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the SAM database. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

(4) Offerors and Contractors may obtain information on registration and annual confirmation requirements via SAM accessed through <https://www.acquisition.gov>.

(u) *Unauthorized Obligations*.

(1) Except as stated in paragraph (u)(2) of this clause, when any supply or service acquired under this contract is subject to any End User License Agreement (EULA), Terms of Service (TOS), or similar legal instrument or agreement, that includes any clause requiring the Government to indemnify the Contractor or any person or entity for damages, costs, fees, or any other loss or liability that would create an Anti-Deficiency Act violation (31 U.S.C. 1341), the following shall govern:

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an “I agree” click box or other comparable mechanism (e.g., “click-wrap” or “browse-wrap” agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(2) Paragraph (u)(1) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

- (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.

(c) *Period for acceptance of offers.* The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.
