

JUSTIFICATION FOR BRAND NAME AWARDS IAW FAR 13.106-1(b)(ii)
(OVER MICRO-PURCHASE THRESHOLD(\$3K) BUT NOT EXCEEDING THE SAT (\$150K))

IAW [FAR13.104](#), COs must promote competition to the maximum extent practicable to obtain supplies and services from the source whose offer is the most advantageous to the Government, considering the administrative cost of the purchase. When competition is not practicable, IAW [FAR13.106-1\(b\)](#), COs solicit from a single source for purchases not exceeding the simplified acquisition threshold. COs may solicit from one source if the CO determines that the circumstances of the contract action deem only one source reasonably available (e.g., urgency, exclusive licensing agreements, brand-name or industrial mobilization). Within the VHA brand name items may be prescribed by physicians when in their clinical judgment the brand name item will provide a better therapeutic outcome for patients. The brand name of the product is in the CMOP print name. Pharmacists legally have to fill the prescription as it was written.

Products have been prescribed for patients by VA Physicians. Pharmacy employees do not have the training and/or authority to countermand physician orders. *"Brand Specific"* products are the same thing as *"dispense as written"* on a physician prescription. No NDC substitutions are permitted. In the VA, Pharmacy Benefits Management (PBM) has determined that CMOP IDs in the National Drug File (NDF) will most always identify *"brand specific"* products in the VA PRINT NAME. This is not always inclusive where a particular NDC has been determined to be *"formulation specific"* by clinical evaluation performed by the PBM or in the case where only one product was recommended.

Lines Item 1, the Insulet Reservoir, Omnipod (PC: 008508112010), is specific to the description which was prescribed by the physician - This product small, lightweight, self-adhesive insulin pod that you fill with insulin and wear directly on your body for up to three (3) days, then replace. The OmniPod delivers precise, personalized doses of insulin into your body through a small flexible tube (called a cannula), based on instructions that you program into its wireless companion, the Personal Diabetes Manager. The cannula is inserted only once with each OmniPod.
