- (2) Any award resulting from this solicitation shall be made to a service-disabled veteranowned small business concern.

Expenses incident to the examination and testing of materials or supplies that have been rejected will be charged to the contractor's account.

- (c) Representation. By submission of its offer, the Offeror represents that it does not require employees or subcontractors of such entity seeking to report fraud, waste, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.
