5. Rational/explanation to support cited authority:

Pyxis 4000 medistations serve to store medications where only approved users have access in order to treat patients. It gives perfect visibility for, and accountability on, all medications in safe and efficient manner. Pyxis is the pillar of inpatient ward stock and failure to operationalize it would lead to decreased patient care for Inpatient Veterans. Pyxis Medstation 4000 is the only product that has 1) integration and current contract to interface with VISTA inpatient orders at IMVA. 2) Interface capability with currently used Carefusion Alaris pumps, which can seamlessly integrate IV fluids from storage through administration safely. Failure of this may cause patient harm. 3) Currently installed and operational, so the Government incures no additional costs of implementing a new system. There are numerous prohibitive costs and patient care concerns regarding switching systems, including costs of setting up new system and training, down times, lack of medication, and potential errors due to running multiple systems.
