Statement of Work

SCOPE.

Title: Regulated Medical Waste Treatment

The Michael E. DeBakey VA Medical Center (MEDVAMC), 2002 Holcombe Blvd., Houston, TX 77030-4298 is seeking a Contractor to provide medical/special, pathological and residual chemotherapy waste treatment and disposal service on a fee-per-pound basis, plus a separate per-drum-cost disposal contingency for all services related to disposal of DOT Infectious Substances (i.e., Category A and Category B) to the MEDVAMC Houston, and a total of nine (9) each Community Based Outpatient Clinics (CBOCs) (i.e., Beaumont, Lufkin, Galveston Island, Richmond-Rosenberg, Texas City, Conroe, Katy, Tom Ball, and Lake Jackson, Texas) with the specific services requirements identified in this SOW. The specific services as a minimum shall include all materials, manpower, process equipment, licenses, permits, fees, fuel surcharge, transportation and computerized documentation for the complete treatment and disposal of an estimated total of 80,770 lbs./monthly of medical/special, pathological and residual chemotherapy waste in an Approved or Alternate Treatment Methods Technology for Special Waste from Health Care-Related Facilities in strict compliance with all applicable Federal (CDC, OSHA, DOT, EPA), State (TCEQ, TDH), and Local laws, regulations, ordinances, and codes, etc.

All interested firms shall provide the following information: company name, address, point of contact, phone number, email address, capability statement, business size, DUNS #, and GSA contract number (if applicable) pursuant to the NAICS code 562211.

Responses Requested: The MEDVAMC requires the following questions answered in the RFI. Contractor shall answer questions to be considered as part of the Market Research. Contractor shall be considered non responsive if answers are not provided and will not be considered as part of the Market Research.

a. Does the Contractor possess all license and certifications required for the state of Texas to meet all government requirements for regulated waste treatment service? Contractor shall provide documentation of license and certification to support Market Research to be considered.

b. Contractors shall also provide their point(s) of contact name, address, telephone number, and email address; and the company's business size, and Data Universal Numbering System (DUNS) Number.

d. Is your company a small business, SDBs, HUBZone, or 8A concern? Please provide proof of qualifications.

c. Provide in your capability statement a list of active contracts for commercial, federal, state, and local governments. List Contracts shall provide communication on the government requirement illustrating the capability for comparison.

d. Is your company available under any Government Wide Agency Contract (GWAC), General Services Administration Schedules (GSA), Indefinite Delivery Indefinite Quantity (IDIQ), and/or Blanket Purchase Agreement (BPA)? If so, please list the contract number and a brief summary of the products and services provided.

e. Provide a short summary of your potential approach to this type of contract and meeting the specific requirements per the draft Statement of Work and your experience managing similar contracts with similar requirements for the MEDVAMC.

Contractor shall possess the capability to provide all requirements and objectives.
