1. **Contracting Activity:** Department of Veterans Affairs, VISN 4, Pittsburgh Medical Center
2. **Nature and/or Description of the Action Being Processed:**
The VA Medical Center is in need of blood products for patient care. We are currently working on soliciting for this service but will need to remain consistent with receiving blood products until this can be accomplished.
3. **Description of Supplies/Services Required to Meet the Agency's Needs:**
The Pittsburgh VAMC is intending to issue a standalone contract to cover a 3 month period to ensure blood products are delivered to the facility without hesitation. We do not want to risk a break in service because that will cause delays in providing patient care.
4. **Statutory Authority Permitting Other than Full and Open Competition:**

5. **Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):** The contract is needed to purchase blood products for use at the Pittsburgh VAMC. Because blood products are urgently needed, the supplier has to be able to deliver products within 3 hours and the American Red Cross has the capability to provide these products and the knowledge of our procedures to ensure proper and timely delivery.

6. **Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:**

Because of the urgency of this requirement it would not be in the best interest to the government to risk patient care by soliciting this requirement. There is however, a long term contract being issued to ensure fair opportunity to offer this service.

7. **Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:**

The price for this service has not changed from the last procurement and is deemed to be fair and reasonable.

8. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:**

Market Research was not conducted because there is an urgent need to supply blood products to patients and it would cause harm to patients if we put this out for solicitation. This will be the only time that market research will not be done because there is a long term contract following that provides the market research necessary to fulfill FAR requirements.

9. **Any Other Facts Supporting the Use of Other than Full and Open Competition:**

This is an urgent requirement and competition could not be conducted. This requirement is in accordance with FAR 6.302-2 and completion would cause further delays in patient care.




