Description

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in FAR Subpart 12.6 in conjunction with Part 13, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation for this action. Quotes are being requested, and a written solicitation will not be issued.

This solicitation is issued as a Request for Quote (RFQ). Submit written quotes on VA248-17-Q-0838. The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2005-94, 2005-95 effective January 19, 2017. This request for quote is issued May 10, 2017 and will end on May 25, 2017 at 3:00 PM EST and is Set-Aside for 100% SDVOSB.

The Network Contracting Office 8-SAO East intends to award a firm fixed priced contract to the **contractor providing a one-time service with labor, tools, and testing of Spill Buckets for Water Intrusion on Four (4) Underground Diesel Fuel Storage Tanks (UST), located on the Main Campus, (CWBYVAMC); also providing a one-time service to filter and polish 300 gallons of diesel fuel located in an AST outside on the west-side of Bldg. 22 and then relocate this fuel to a (UST) storage tank (TBD) located at Bldg. 100; contractor will also need to provide a one-time service to pump out and properly dispose of Approximately 150**

gallons of diesel fuel from a Day Tank inside Generator #40 Room located on the west-side of bldg. 22; and will need to provide a Base year and Four (4) Option Year Annual Service on Six (6) Underground Diesel Fuel Storage Tanks (UST and Seven (7) above Ground Diesel Fuel Storage Tanks, located on the Main Campus, (CWBYVAMC).

All the work will be in accordance with the Performance Work Statement below.

This procurement is being conducted under Subpart 13.5 Simplified Procedures for Certain Commercial items. The intent is to award a firm fixed price contract.

This procurement is a 100% SDVOSB set-aside and all eligible offerors are encouraged to submit quotes. To be considered for award prospective offerors must be a verified SDVOSB concern in the VA Center for Verification and Evaluation (CVE) Veteran Information Pages (VIP) pages <https://www.vip.vetbiz.gov/> at the date and time set for receipt of offers. An Offeror who is not a verified SDVOB concern at the date and time set for receipt of offers will have their offer rejected as non-responsive, and will not be considered for award. All offerors must be registered in System for Award Management (SAM) at <http://www.sam.gov> to be considered for an award of a federal contract registered in the record must be complete and not missing elements such as representations and certifications.

PERFORMANCE WORK STATEMENT FOR WATER MITIGATION AND FUEL FILTRATION AND POLISHING FOR THIRTEEN (13) DIESEL Fuel STORAGE TANKS

Scope: The C.W. Bill Young Veterans Administration Medical Center requires a contractor to:

- 1. Contractor shall provide a One-time Service required for the Spill Buckets for Water Intrusion on Four (4) Underground Diesel Fuel Storage Tanks (UST)s located at Bldg. 100, tanks #1, 2, 3 & 4, the following services are required. The Contractor shall complete this service within Seven (7) Days after Notice to Proceed.**

Contractor shall:

- Clean spill buckets and remove surface rust.
- Replace all gaskets, seals, O-rings, gaskets on gauges and drain ports.
- Replace drop tube O-ring and seals.
- Wire brush, paint and replace spill bucket lid seal.
- Pressure test spill bucket per manufacturer's specifications for compliance.
- Furnish written report of test procedures and results.

The Contractor shall complete this service within Seven (7) Days after Notice to Proceed.**

Item 4-1: Vacuum Water: Contractor will vacuum the free standing Petroleum Contact Water (PCW) from the thirteen (13) tanks if standing water is present. Contractor will use Water Finding Paste applied to a stick to ensure no additional water resides in the tanks. Contractor will dispose of PCW per EPA Regulations.

Item 4-2: Fuel Filtration and Polishing: Samples shall be taken from each tank prior to filtration. All fuel samples retrieved shall be bottom samples per ASTM D 4057 methods in accordance with NFPA 110 Emergency Power Systems.

Contractor shall filter and polish approximately 114,500 gallons of diesel fuel to remove emulsified water, sediment and microbial growth.

These specifications must comply with ASTM D 975-15, ASTM D 6304 and ISO 4406-99, Caterpillar and Detroit Diesel Engine Manufacturers Fuel Specifications.

Item 4-3: Fuel Testing by Third Party: After the fuel has been filtered and polished, samples will be taken per ASTM D 4057 Specifications and witnessed by Bay Pines VA Electrical personnel. The contractor shall have an Independent & Accredited ISO 17025 Fuel Testing Laboratory perform the following tests:

- ASTM D975-15 Specification for Diesel Fuel Oils
- ASTM D6304 Water by Karl Fisher
- Sulfur
- ASTM D2709 Bottom Sediment & Water (BSW)
- ISO 4406 Fuel Cleanliness
- ASTM D93 Flash Point

Water content shall be 500ppm (mg/kg) or less dissolved content.

Particulate contamination shall not exceed ISO 4406 Code 18/16/13 for Original Engine Manufacturer Specification CAT Service Bulletin (SEBU) 6250.

Water and particulate shall not exceed 500mg/l combined.

Report Requirements: A printed test report with tank ID, date and test results including a pass/fail column of each fuel sample shall be submitted to the Engineering Technician in Engineering Service. In the event the lab report indicates the tank failed to comply with the specified fuel quality specification, the fuel is to be filtered and polished to comply with the specification at contractor's expense and retest with a report indicating compliance.

Requirements: The contractor shall have in their possession all necessary PPE required by OSHA. This will include spill kits and absorbents. The contractor will haul away all contaminated water, sediments and fuel and dispose of properly per local codes at a licensed facility.

The contractor will provide a contingency plan for spillage of fuel.

The period of performance for Item 1 is 7 days after Notice to Proceed (NTP).

The period of performance for Item 2 is 7 days after Notice to Proceed (NTP).

The period of performance for Item 3 is 7 Days after Notice to Proceed (NTP).

The period of performance for Item 4 is a Base and Four (4) Option Years.

The Contractor shall use reasonable care to avoid damaging existing buildings, equipment, and vegetation on the Government installation. If the Contractor's failure to use reasonable care causes damage to any of this property, the Contractor shall replace or repair the damage at no expense to the Government as the Contracting Officer directs. If the Contractor fails or refuses to make such repair or replacement, the Contractor shall be liable for the cost, which may be deducted from the contract price.

52.246-4 -- Inspection of Services -- Fixed-Price (Aug. 1996)

(a) *Definition:* "Services," as used in this clause, includes services performed, workmanship, and material furnished or utilized in the performance of services.

(b) The Contractor shall provide and maintain an inspection system acceptable to the Government covering the services under this contract. Complete records of all inspection work performed by the Contractor shall be maintained and made available to the Government during contract performance and for as long afterwards as the contract requires.

(c) The Government has the right to inspect and test all services called for by the contract, to the extent practicable at all times and places during the term of the contract. The Government shall perform inspections and tests in a manner that will not unduly delay the work.

(d) If the Government performs inspections or tests on the premises of the Contractor or a subcontractor, the Contractor shall furnish, and shall require subcontractors to furnish, at no increase in contract price, all reasonable facilities and assistance for the safe and convenient performance of these duties.

(e) If any of the services do not conform with contract requirements, the Government may require the Contractor to perform the services again in conformity with contract requirements, at no increase in contract amount. When the defects in services cannot be corrected by reperformance, the Government may --

(1) Require the Contractor to take necessary action to ensure that future performance conforms to contract requirements; and

(2) Reduce the contract price to reflect the reduced value of the services performed.

(f) If the Contractor fails to promptly perform the services again or to take the necessary action to ensure future performance in conformity with contract requirements, the Government may --

(1) By contract or otherwise, perform the services and charge to the Contractor any cost incurred by the Government that is directly related to the performance of such service; or

(2) Terminate the contract for default.

(a) Definition. For the Department of Veterans Affairs, “Service-disabled veteran-owned small business concern”:

(1) Means a small business concern:

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans (or eligible surviving spouses);

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans (or eligible surviving spouses) or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran;

(iii) The business meets Federal small business size standards for the applicable North American Industry Classification System (NAICS) code identified in the solicitation document; and

(iv) The business has been verified for ownership and control and is so listed in the Vendor Information Pages database, (<http://www.VetBiz.gov>).

(2) “Service-disabled veteran” means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

(b) *General.* (1) Offers are solicited only from service-disabled veteran-owned small business concerns. Offers received from concerns that are not service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a service-disabled veteran-owned small business concern.

(c) Agreement. A service-disabled veteranowned small business concern agrees that in the performance of the contract, in the case of a contract for:

(1) Services (except construction), at least 50 percent of the cost of personnel for contract performance will be spent for employees of the concern or employees of other eligible service-disabled veteran-owned small business concerns;

(2) Supplies (other than acquisition from a nonmanufacturer of the supplies), at least 50 percent of the cost of manufacturing, excluding the cost of materials, will be performed by the concern or other eligible service-disabled veteran-owned small business concerns;

(2) Each other concern is small under the size standard corresponding to the NAICS code assigned to the procurement; and

(3) The joint venture meets the requirements of paragraph 7 of the explanation of Affiliates in 19.101 of the Federal Acquisition Regulation.

(4) The joint venture meets the requirements of 13 CFR 125.15(b).

(e) Any service-disabled veteran-owned small business concern (non-manufacturer) must meet the requirements in 19.102(f) of the Federal Acquisition Regulation to receive a benefit under this program.

(a) *Definitions.* As used in this clause-

(5) *Payment request* means any request for contract financing payment or invoice payment submitted by the contractor under this contract.

(b) *Electronic payment requests.* Except as provided in paragraph (e) of this clause, the contractor shall submit payment requests in electronic form. Purchases paid with a Government-wide commercial purchase card are considered to be an electronic transaction for purposes of this rule, and therefore no additional electronic invoice submission is required.

Further, it is agreed that any negligence of the Government, its officers, agents, servants and employees, shall not be the responsibility of the contractor hereunder with the regard to any claims, loss, damage, injury, and liability resulting there from.

(a) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Resolution Appropriations Act, 2015 (Pub. L. 113-235), Government agencies are not permitted to use funds appropriated (or otherwise made available) under that or any other Act for contracts with an entity that requires employees or subcontractors of such entity seeking to report fraud, waste, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or contractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(b) The prohibition in paragraph (a) of this provision does not contravene requirements applicable to Standard Form 312, Form 4414, or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(c) *Representation.* By submission of its offer, the Offeror represents that it does not require employees or subcontractors of such entity seeking to report fraud, waste, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from

lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

52.204-16 --Commercial and Government Entity Code Reporting (Jul 2015)

(a) Definition. As used in this provision—

“Commercial and Government (CAGE) code” means--

(1) An identifier assigned to entities located in the United States or its outlying areas by the Defense Logistics Agency (DLA) Contractor and Government Entity (CAGE) Branch to identify a commercial or Government entity; or

(2) An identifier assigned by a member of the North Atlantic Treaty Organization (NATO) or by the NATO Support Agency (NSPA) to entities located outside the United States and its outlying areas that the DLA Contractor and Government Entity (CAGE) Branch records and maintains in the CAGE master file. This type of code is known as an NCAGE code.

NCAGE codes may be obtained from the NSPA if the foreign entity’s country is not a member of NATO or a sponsored nation. (e) When a CAGE Code is required for the immediate owner and/or the highest-level owner by 52.204-17 or 52.212-3(p), the Offeror shall obtain the respective CAGE Code from that entity to supply the CAGE Code to the Government.

(f) Do not delay submission of the offer pending receipt of a CAGE code.

52.209-5 -- Certification Regarding Responsibility Matters.

(a)

(1) The Offeror certifies, to the best of its knowledge and belief, that --

(i) The Offeror and/or any of its Principals --

(A) Are ☐ are not ☐ presently debarred, suspended, proposed for debarment, or declared ineligible for the award of contracts by any Federal agency;

(c) Based on this information and any other information solicited or obtained by the contracting officer, the contracting officer may determine that an organizational conflict of interest exists which would warrant disqualifying the contractor for award of the contract unless the organizational conflict of interest can be mitigated to the contracting officer's satisfaction by negotiating terms and conditions of the contract to that effect. If the conflict of interest cannot be mitigated and if the contracting officer finds that it is in the best interest of the United States to award the contract, the contracting officer shall request a waiver in accordance with FAR 9.503 and 48 CFR 809.503.

(d) Nondisclosure or misrepresentation of actual or potential organizational conflicts of interest at the time of the offer, or arising as a result of a modification to the contract, may result in the termination of the contract at no expense to the Government.

If ADR is used, the Department of Veterans Affairs will not furnish any documentation in an ADR proceeding beyond what is allowed by the Federal Acquisition Regulation.
