There will be a minimum order for the base and option periods)** for the Sioux Falls VA Health Care System. The information in this notice is based on the most current information available to date. This information is subject to change and is not binding to the Government. Updated information will be provided in future announcements and posted electronically on the Federal Business Opportunities homepage (www.fbo.gov). The Government shall not reimburse the costs of preparing responses to this sources sought notice.

The Department of Veterans Affairs, Network Contracting Office 23, intends to issue a formal Request for Proposal (RFP) approximately late-June, 2017 timeframe for the acquisition of these services. The estimated contract period including all option years is July 1, 2017 through June 30, 2018. The NAICS code for this requirement is 621399 (Offices of All Other Miscellaneous Health Practitioners). The Small Business Size Standard is \$7,500,000.

The Government requests interested parties to submit a letter of interest and a brief statement of current capability to perform these services.
