Federal Acquisition Circular Statement

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in FAR Subpart 12.6 in conjunction with Part 13, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation for this action. Quotes are being requested, and a written solicitation will not be issued.

This solicitation is issued as a Request for Quote (RFQ). Submit written quotes on VA248-17-Q-0764. The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2005-94 & 95 effective January 20, 2017. This request for quote is issued May 12, 2017 and will end on June 12, 2017 at 1 PM EST.

The Network Contracting Office 8 intends to award a fixed priced contract, providing for the purchase and installation of a new fuel polishing system located at Lee County Healthcare Center in accordance with the scope of work (SOW).

This procurement is being conducted under Subpart 13.5 Simplified Procedures for Certain Commercial items. The intent is to award a firm fixed price contract.

This procurement is a 100% SDVOSB set-aside and all eligible offerors are encouraged to submit quotes. To be considered for award prospective offerors must be a verified SDVOB concern in the VA Center for Verification and Evaluation (CVE) Veteran Information Pages (VIP) pages <https://www.vip.vetbiz.gov/> at the date and time set for receipt of offers. An Offeror who is not a verified SDVOB concern at the date and time set for receipt of offers will have their offer rejected as non-responsive, and will not be considered for award. Additionally, all offerors must be registered in System for Award Management (SAM) at <http://www.sam.gov> to be considered for an award of a federal contract, and registration must be complete and not missing elements such as representations and certifications

CLIN 0001 Provide all parts, labor and materials necessary to remove existing fuel filtration system and install a new continuous fuel polishing system at LCHCC.

Description of requirement.

Work required under this section consists of providing all labor, equipment, materials and supervision necessary to demolish an existing fuel filtration system including the mounting pad at Lee County Healthcare Center. Existing electrical service and piping distribution system shall remain for use with new system. Install a new continuous fuel polishing system that maintains fuel quality suitable to meet fuel quality standards specified by the equipment manufacturer. This work will include all electrical, mechanical and electronic controls required to complete the installation. The contractor shall make every effort necessary to prevent the release or spillage of any fuel from the installed system. Additionally the Contractor shall ensure an uninterrupted supply of fuel to our emergency generators during the performance of the work. All piping and electrical systems shall be installed in accordance with all applicable codes and regulations by properly licensed Trades Specialists. The installed system shall include connection and programming for all controls and alarm points, with the facilities Building Automation System (BAS), currently a Johnson Controls "Metasys" operating system. All systems components shall be tested and documentation submitted prior to final acceptance by the VA. The Contractor shall provide at least two copies of Operations and Maintenance (O&M) manuals and provide up to 4 hours of on-site hands-on training for up to 10 VA Personnel.

The Contractor shall respond to any calls for emergency repairs during the warranty period within 1 hour of any call for service.

STANDARD GENERAL CONDITIONS

The Contractor shall assure that its employees have received safety equipment training, medical surveillance programs, individual health protection measures, and manufacturer's product and safety data sheets (SDS) required for the work described by this Contract Document. The Contractor shall maintain a copy of all current SDS documentation and safety certifications at the site at all times, as well as comply with all other site documentation requirements of the Occupational Safety and Health Administration (OSHA) programs and this specification. The Contractor shall assure that its employees have received the necessary training, medical surveillance programs, safety equipment, individual health protection measures, and manufacturer's product and material safety data sheets required for the work described by this Contract Document.

CORRECTION OF WORK

The Contractor shall re-execute any work that fails to conform to or meet requirements of the Contract, and which appears during the progress of the project, and shall remedy any defects due to faulty materials or workmanship which appear within a period of one year from the date of final acceptance of the work by the Government. The provisions of this article apply to work completed by subcontractors as well as to work completed by employees of the Contractor.

MATERIALS, EQUIPMENT AND PERSONNEL

Except as otherwise noted, the Contractor shall provide and pay for all materials, labor, tools, and equipment necessary to complete the work. All material shall be new, and both workmanship and materials shall be of a high standard of quality, approved by the COR. All workmen and subcontractors shall be skilled in their trades. The Contractor shall use only Factory replacement parts approved by the equipment manufacturer and meeting the requirements of the Buy American Act.

ROYALTIES AND PATENTS

The Contractor shall pay all royalties and patent fees for any material or processes, which require the use of proprietary patented systems and/or methods. The Contractor also agrees to hold the Government harmless of all such claims if such issues of intellectual property arise.

PROTECTION OF WORK, PROPERTY AND PERSONS

The Contractor shall adequately protect the Government's property and building occupants. The Contractor shall be responsible for the cost arising out of any damage or injury due to his act or neglect.

CONTRACTOR RESPONSIBILITIES

The Contractor shall be responsible for security at the work site. The Contractor is responsible for ensuring the work area is maintained clean of debris, chemicals or other products which may pose a risk to building occupants or give the appearance of poor housekeeping. All site conditions must be properly restored to the same or better condition than before work commencement. All floors, and equipment surfaces shall be swept or wiped down at the end of each work day to remove or control settled dust and debris.

MATERIALS, CHEMICALS AND EQUIPMENT

The Contractor shall use materials, chemicals and equipment, which are specified herein and pre-approved by the CO or his representative. All used or waste oils and chemicals shall be handled and disposed in accordance with the Resource Conservation and Recovery Act (RCRA) and or applicable laws and regulations. The proper storage, handling, recycling, clean-up or disposal of any and all regulated and non-regulated waste as identified by RCRA shall be the responsibility of the contractor. Records documenting use and disposal shall be maintained by Contractor with duplicate copies being provided to the Contracting Officers Representative (COR) within 5 business days of disposition. Disposal of oils and or chemical products on the ground or in drains or sewer systems is strictly prohibited.

WORKMANSHIP

The Contractor shall use materials, chemicals and equipment, which are in their original containers. No open or used containers will be allowed. Personnel skilled and trained in the specific discipline shall accomplish the work. The access, preparation and dismantling of equipment for such work shall be performed by qualified technicians. The Contractor shall exercise caution to prevent any damage to the equipment, electrical motors of systems, floors, walls and to the building in general, resulting from their work. Any damaged fixtures, equipment or systems shall be repaired, if possible, or replaced with equal equipment at no cost to the Government.

Place of delivery and acceptance. FOB Destination.

Work is to be performed at the DEPARTMENT OF VETERAN AFFAIRS, LEE COUNTY OUTPATIENT CLINIC, located in Cape Coral, Florida. Work address is 2489 Diplomat Pkwy. East, Cape Coral, Florida 33909. Work hours are between 7:30 AM and 4 PM, Monday thru Friday with the exception of federal holidays. Work area includes the 1st floor Central Energy Plant room, 1B200, located on the north western end of the building. Adjacent spaces shall be occupied and can reasonably be expected to have ongoing work activities being performed during contract hours of work. Consideration for continued medical operations and occupant safety and health is paramount during the conduct of work. A thorough and detailed incremental work schedule shall be submitted to the CO for approval prior to the start of work

(c) Based on this information and any other information solicited or obtained by the contracting officer, the contracting officer may determine that an organizational conflict of interest exists which would warrant disqualifying the contractor for award of the contract unless the organizational conflict of interest can be mitigated to the contracting officer's satisfaction by negotiating terms and conditions of the contract to that effect. If the conflict of interest cannot be mitigated and if the contracting officer finds that it is in the best interest of the United States to award the contract, the contracting officer shall request a waiver in accordance with FAR 9.503 and 48 CFR 809.503.

(d) Nondisclosure or misrepresentation of actual or potential organizational conflicts of interest at the time of the offer, or arising as a result of a modification to the contract, may result in the termination of the contract at no expense to the Government.

Quotes shall be evaluated for acceptability or unacceptability. Award will be made to the lowest priced quote meeting the acceptability standards for the non-cost factors. Quotes shall be initially screened for the content listed below. Quotes shall be initially evaluated either acceptable or unacceptable based on whether the specified sections are actually included in the quotes. Quotes must have the following items; those that do not shall receive an unacceptable and will be considered non-responsive.

To be considered for this award the **Contractor must** provide the following:

Technical Information

1. Offerors shall include their technical solution for providing the necessary equipment and services to demo and install a new continuous fuel polishing system at the Lee County Healthcare Clinic. The proposed technical solution shall include an estimated schedule to completion of the installation from the notice to proceed. Offers will also provide descriptive literature outlining the products being proposed to include make, model, description, product identification number and serial if applicable.
 - i. An acceptable response will be one that provides a solution which demonstrates that the contractor understands and has the ability to successfully execute the requirements of the statement of work.
 - ii. Unacceptable responses will be ones that do not provide a solution which demonstrates that the contractor understands and has the ability to successfully execute the requirements for the installation and services found within the statement of work or provides a solution that simply restates the performance work statement.

Past Performance

1. Contractors shall be regularly established in the business of providing the services identified in the Performance Work Statement; who have experience with commercial contracts of similar size or larger; with conditions and scope as required for this contract.

Offerors without a record of relevant past performance or for whom information on past performance is not available, will not be evaluated as neither favorable nor unfavorable, and, as a result, will receive a "Neutral/Unknown Confidence" rating for past performance.

Quotes shall include a complete listing of CLIN items.

Award and documentation will be in accordance with FAR Part 13.106-3.

"Arbitral award or decision" means an arbitrator or arbitral panel determination that a labor law violation occurred, or that enjoined or restrained a violation of labor law. It includes an award or decision that is not final or is subject to being confirmed, modified, or vacated by a court, and includes an award or decision resulting from private or confidential proceedings. To determine whether a particular award or decision is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

"Civil judgment" means--

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;

- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;
- (4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;
- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

Sensitive technology—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

“Small business concern” means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

“Successor” means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

“Veteran-owned small business concern” means a small business concern—

(1) That is at least 51 percent owned by one or more women or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and

(2) Whose management and daily business operations are controlled by one or more women.

“Women-owned small business (WOSB) concern eligible under the WOSB Program (in accordance with 13 CFR part 127),” means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.

The enjoined definitions will become effective immediately if the court terminates the injunction. 52.246-4 -- Inspection of Services -- Fixed-Price (Aug. 1996)

(c) Section I, General Description. This section shall provide a generalized description of the equipment or devices and shall describe its purpose or intended use. Included in this section will be a table listing all pertinent equipment specifications, power requirements, environmental limitations and physical dimensions.

(d) Section II, Installation. Section II shall provide pertinent installation information. It shall list all input and output connectors using applicable reference designators and functional names as they appear on the equipment. Included in this listing will be a brief description of the function of each connector along with the connector type. Instructions shall be provided as to the recommended method of repacking the equipment for shipment (packing material, labeling, etc.).

(e) Section III, Operation. Section III will fully describe the operation of the equipment and shall include a listing of each control with a brief description of its function and step-by-step procedures for each operating mode. Procedures will use the control(s) nomenclature as it appears on the equipment and will be keyed to one or more illustrations of the equipment. Operating procedures will include any preoperational checks, calibration adjustments and operation tests. Notes, cautions and warnings shall be set off from the text body so they may easily be recognizable and will draw the attention of the reader. Illustrations should be used wherever possible depicting equipment connections for test, calibration, patient monitoring and measurements. For large, complex and/or highly versatile equipment capable of many operating modes and in other instances where the Operation Section is quite large, operational information may be bound separately in the form of an Operators Manual. The providing of a separate Operators manual does not relieve the supplier of his responsibility for providing the minimum acceptable maintenance data specified herein. When applicable, flow charts and narrative descriptions of software shall be provided. If programming is either built-in and/or user modifiable, a complete software listing shall be supplied. Equipment items with software packages shall also include diagnostic routines and sample outputs. Submission information shall be given in the Maintenance Section to identify equipment malfunctions that are software related.

(f) Section IV, Principles of Operation. This section shall describe in narrative form the principles of operation of the equipment. Circuitry shall be discussed in sufficient detail to be understood by technicians and engineers who possess a working knowledge of electronics and a general familiarity with the overall application of the devices. The circuit descriptions should start at the overall equipment level and proceed to more detailed circuit descriptions. The overall description shall be keyed to a functional block diagram of the equipment. Circuit descriptions shall be keyed to schematic diagrams discussed in paragraph (i) below. It is recommended that for complex or special circuits, simplified schematics should be included in this section.

(g) Section V, Maintenance. The maintenance section shall contain a list of recommended test equipment, special tools, preventive maintenance instructions and corrective information. The list of test equipment shall be that recommended by the manufacturer and shall be designated by manufacturer and model number. Special tools are those items not commercially available or those that are designed specifically for the equipment being supplied. Sufficient data will be provided to enable their purchase by the Department of Veterans Affairs. Preventive maintenance instructions shall consist of those recommended by the manufacturer to preclude unnecessary failures. Procedures and the recommended frequency of performance shall be included for visual inspection, cleaning, lubricating, mechanical adjustments and circuit calibration. Corrective maintenance shall consist of the data necessary to troubleshoot and rectify a problem and shall include procedures for realigning and testing the equipment. Troubleshooting shall include either a list of test points with the applicable voltage levels or waveforms that would be present under a certain prescribed set of conditions, a troubleshooting chart listing the symptom, probable cause and remedy, or a narrative containing sufficient data to enable a test technician or electronics engineer to determine and locate the probable cause of malfunction. Data shall also be provided describing the preferred method of repairing or replacing discrete components mounted on printed circuit boards or located in areas where special steps must be followed to disassemble the equipment. Procedures shall be included to realign and test the equipment at the completion of repairs and to restore it to its original operating condition. These procedures shall be supported by the necessary waveforms and voltage levels, and data for selecting matched components. Diagrams, either photographic or line, shall show the location of printed circuit board mounted components.

852.219-10 VA Notice of Total Service-Disabled Veteran-Owned Small Business Set-Aside.

(a) Definition. For the Department of Veterans Affairs, "Service-disabled veteran-owned small business concern":

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans (or eligible surviving spouses);
