This requirement was competed five years ago in accordance with DVA guidance at the time, that National Acquisition Center Federal Supply Schedules be used to procure supplemental staffing services. The Kingdomware Decision in June 2016 changed the methodology for procuring these services. In order to comply with this Decision, more robust and extensive market research is required and a long term contract has not yet been awarded. This short term requirement will ensure that critical services are procured until the long term contract is awarded. If a task order is not awarded, the Consolidated Mail Outpatient Pharmacy will cease production and directly affect the medical prescription services to the nations' Veterans.

**(5) DESCRIBE WHY YOU BELIEVE THE ORDER REPRESENTS THE BEST VALUE CONSISTENT WITH FAR 8.4 TO AID THE CONTRACTING OFFICER IN MAKING THIS BEST VALUE DETERMINATION:**

The current contractor, DLH Solutions, has performed under Blanket Purchase Agreement VA797M-12-A-0001 since November 2011.

**(6) DESCRIBE THE MARKET RESEARCH CONDUCTED AMONG SCHEDULE HOLDERS AND THE RESULTS OR A STATEMENT OF THE REASON MARKET RESEARCH WAS NOT CONDUCTED:**

A Request for Information VA770-16-N-0406 (RFI) was issued on GSA E-Buy, ( RFQ1096254) on 31 May 2016 and closed on 14 June 2016 seeking qualified, experienced and interested potential sources. The RFI was limited to veteran owned small businesses, or service disabled veteran owned small businesses. Interested and capable businesses were encouraged to submit documentation of technical expertise to this office so that this office could determine that they possessed the necessary functional area expertise and experience to compete for this acquisition.
